NOTE A - DESCRIPTION OF PLAN

The following description of Weld County Garage 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, established February 1, 1964, by Weld County Garage (the Plan Sponsor). Weld County Garage is part of the Yoder Family of Companies, which includes Weld County Garage and eight affiliated companies. The Plan allows other related employers (the Adopting Employers) to adopt the Plan and its provisions. The Plan is available for qualifying employees of Weld County Garage and Adopting Employers (collectively, the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

All employees, excluding drivers, interns and independent contractors, are eligible to participate in the Plan following the completion of six months of service and attainment of age 21.

The Plan includes an auto-enrollment provision whereby an eligible employee will be automatically enrolled in the Plan at an initial three percent pre-tax deferral rate after meeting eligibility requirements. In accordance with the Plan, a participant will be given a reasonable period to affirmatively elect a different percentage or elect not to make elective deferral contributions.

The Plan includes an auto-escalation provision whereby employee deferral elections are automatically increased by one percent each year until a maximum ten percent is reached, unless a participant affirmatively elects to opt-out of the auto-escalation provision.

Contributions

Each year, participants may contribute up to one hundred percent of their annual compensation as defined by the Plan (not to exceed the limits set by the Internal Revenue Code) on a pre-tax basis or as Roth contributions. The Plan allows catch-up contributions for participants who have attained or will attain age 50 by the last day of the plan year, subject to Internal Revenue Code limitations. Participants may change their contribution percentage and may cease making contributions at any time.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

December 31, 2024 and 2023

The Company may make discretionary matching contributions to the Plan equal to a discretionary percentage of a participant's compensation or a discretionary dollar amount as determined by the Company on a uniform basis for all participants. All participants share in the allocations of discretionary matching contributions regardless of service completed during the plan year or employment status on the last day of the plan year. There were no matching contributions made to the Plan for the years ended December 31, 2024 or 2023. In 2024, the Company contributed \$3,115 to the Plan for corrective contributions, including lost earnings, to the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's discretionary matching and profit-sharing contributions, and (b) Plan earnings. Allocations are based on participant compensation or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company's discretionary matching and profit-sharing contributions plus actual earnings thereon is twenty percent for each year of service after two years of services and participants are one hundred percent vested after six years of service.

If an employee dies, suffers total and permanent disability, or attains normal retirement age of 65 while still employed by the Company, his or her entire interest in all accounts will become fully vested, without regard to the length of service with the Company.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to the lesser of \$50,000 or fifty percent of their vested account balance reduced by the highest outstanding loan balance in the participant's account during the prior twelve-month period. The loans are secured by the vested balance in the participant's account and bear interest at a commercially reasonable interest rate established by the Plan Administrator. Principal and interest are paid ratably through payroll deductions over a period not to exceed five years, though loans for the purpose of purchasing the participant's primary residence may have longer repayment terms if permitted by the Plan Administrator.

Payment of Benefits

Payment of benefits is made upon retirement, disability, death, or termination of employment. A participant may elect to receive their benefit payments in the form of a lump-sum amount, in substantially equal installments, or as an annuity. Participants may elect to receive a cash payment, rollover the funds to another qualified plan or individual retirement account, or remain in the Plan if their vested account balance has a minimum of \$1,000. If a participant's vested account balance does not exceed \$1,000, the Plan will distribute the vested balance in a lump sum cash payment or rollover payment as soon as administratively practicable. The Plan also provides for hardship withdrawals in certain instances as specified in the Plan.

Forfeited Accounts

Forfeited non-vested accounts are used to reduce future employer contributions and pay certain Plan expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$185 and \$171, respectively.

NOTE B - SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting and Use of Estimates

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

Investments, Guaranteed Investment Contracts and Income Recognition

Pooled separate accounts, collective investment trusts and mutual funds are recorded at fair value. See Note C for discussion of these measurements. Guaranteed investment contracts are recorded at contract value. See Note D for discussion of this measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's unrealized gains and losses on investments held, as well as realized gains and losses on investments sold.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Expenses of maintaining the Plan are generally paid by the Company, though certain expenses may be paid directly by the Plan from forfeitures.

Subsequent Events

The Plan evaluates events occurring subsequent to the balance sheet date, through the date the financial statements are eligible to be issued, to determine whether the events require recognition or disclosure in the financial statements. If a subsequent event evidences conditions existing at the balance sheet date, the effects are recognized in the financial statements (recognized subsequent event). If a subsequent event evidences conditions arising after the balance sheet date, the effects are not recognized in the financial statements but rather disclosed in the notes to the financial statements (non-recognized subsequent event). The effects of subsequent events are only recognized if material or disclosed if the financial statements would otherwise be misleading.

With respect to the December 31, 2024 financial statements, the Plan has evaluated subsequent events through October 2, 2025.

NOTE C – INVESTMENTS AND FAIR VALUE MEASUREMENTS

The following is a summary of the Plan's investments at fair value as of December 31, 2024 and 2023, which was derived from information prepared by Principal Trust Company (the custodian) and furnished to the Plan administrator. The Plan administrator has obtained certifications from Principal Trust Company that such information is complete and accurate.

During 2024 and 2023, the Plan's investments appreciated by \$635,268 and \$857,831, respectively. These amounts include unrealized gains and losses on investments held, as well as realized gains and losses on investments sold.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets
 - Quoted prices for identical or similar assets or liabilities in inactive markets
 - Inputs other than quoted prices that are observable for the asset or liability
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used in 2024 and 2023.

Mutual funds – Valued using the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts – Valued using the NAV per unit of the funds. The NAV is based on the fair values of the underlying investments held by the fund less its liabilities. Principal generally determines the fair values of the underlying investments based on market quoted pricing. These investments are direct filing entities with the Department of Labor.

Collective investment trusts – Valued using the NAV per unit of the funds. The NAV is based on the fair values of the underlying investments held by the fund less its liabilities. Principal generally determines the fair values of the underlying investments based on market quoted pricing. These investments are direct filing entities with the Department of Labor.

NOTE D – GUARANTEED INVESTMENT CONTRACT

One of the current investment options in the Plan is the Principal Fixed Income Guaranteed Option. This investment guarantees principal and provides a stable crediting rate and is backed by the assets in the general account of the Principal Life Insurance Company and does not have specific underlying assets assigned.

This investment is fully benefit-responsive, and contract value is the relevant measurement attribute as Plan transactions are ordinarily executed using contract value without adjustment. As the Plan intends to maintain this investment, and the investment generally cannot be sold, transferred, or assigned externally, contract value is a good proxy for fair value. Contract value, as reported to the Plan by the custodian, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The total contract value of the guaranteed investment contract as of December 31, 2024 and 2023, was \$113,736 and \$37,648, respectively.

Certain events, such as the termination of the investment contract by the Plan, may limit the ability of the Plan to transact at contract value. As of December 31, 2024, the Plan administrator does not believe that any events which would limit the Plan’s ability to transact at contract value are probable of occurring.

NOTE E – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become one hundred percent vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

NOTE F – TAX STATUS

Effective July 1, 2019, the Company adopted a Prototype Plan Document sponsored by Principal Financial Group. The Internal Revenue Service has determined and informed the Company by letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator does not believe there are any such uncertain tax positions. The Plan may be subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

NOTE G – RISKS AND UNCERTAINTIES

The Plan invests in various investment options. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE H – RELATED-PARTY TRANSACTIONS

Certain Plan investments are managed by Principal Financial Group, such as the pooled separate accounts, collective investment trusts, and the guaranteed investment contract. Principal Trust Company, a member of the Principal Financial Group, is the Plan's custodian. As such, these investments qualify as party-in-interest transactions. Fees paid by the Plan to Principal Financial Group for administrative services amounted to \$36,972 and \$38,073 for the years ended December 31, 2024 and 2023, respectively.

Certain administrative functions for the Plan are performed by officers and employees of the Company. No such officer or employee receives compensation from the Plan. The Company generally pays expenses applicable to maintaining the Plan, other than administrative fees charged directly to the Plan.

We have conducted an ERISA Section 103(a)(3)(C) audit of the financial statements of the Weld Country Garage 401(k) Plan (the Plan) as of and for the year ended December 31, 2024 and have issued our report thereon dated October 2, 2025. Professional standards require that we advise you of the following information related to our audit.

Our Responsibility under U.S. Generally Accepted Auditing Standards

As communicated in our engagement letter dated May 20, 2025, our responsibility, as described by professional standards, is to conduct our audit in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Therefore, as permitted by ERISA Section 103(a)(3)(C), the audit need not extend to any statements of information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by a bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution). For an ERISA Section 103(a)(3)(C) audit, the audit will not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirement of accounting principles generally accepted in the United States of America (GAAP). Accordingly, the objective of the ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

Our responsibility, as prescribed by professional standards, is to plan and perform our audit to obtain reasonable, rather than absolute, assurance about whether the financial statements are free of material misstatement. An audit of financial statements includes consideration of internal control over financial reporting as a basis for designing audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control over financial reporting. However, we are not required to design procedures for the purpose of identifying other matters to communicate to you.

Planned Scope and Timing of the Audit

We performed our audit according to the planned scope and timing previously communicated to you.

Compliance with All Ethics Requirements Regarding Independence

The engagement team, others in our firm, as appropriate, and our firm have complied with all relevant ethical requirements regarding independence.

Significant Risks Identified

We have identified the following significant risks:

The accuracy of participant level data. We have performed sample testing at the participant level to verify the accuracy of participant information with respect to plan eligibility, contributions, distributions and vesting.

Qualitative Aspects of the Plan's Significant Accounting Practices

Significant Accounting Policies

Management is responsible for the selection and use of appropriate accounting policies. In accordance with the terms of our engagement letter, we may advise management about the appropriateness of accounting policies and their application, but the responsibility remains with management. The significant accounting policies used by the Plan are described in Note B to the financial statements. No new accounting policies were adopted, and the application of existing policies was not changed during 2024.

No matters have come to our attention that would require us, under professional standards, to inform you about (1) the methods used to account for significant unusual transactions, and (2) the effect of significant accounting policies in controversial or emerging areas for which there is a lack of authoritative guidance or consensus. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. There are no significant transactions that have been recognized in the financial statements in a different period than when the transaction occurred.

Significant Accounting Estimates

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. The most sensitive estimate affecting the financial statements was:

Management's estimate of the fair values of the investments owned by the Plan.
