Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of MKD Electric, LLC Employee's Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the MKD Electric, LLC, Employee's Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has then obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

(1) DESCRIPTION OF PLAN:

The following description of the MKD Electric, LLC Employee's Profit Sharing Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General -

The Plan is a defined contribution plan covering all eligible employees of MKD Electric, LLC and Powercor Services, LLC ("Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). During 2024, the Company acquired JSET Ultimate Holdings LLC ("JSET"). JSET became a participating employer in the plan. An employee becomes eligible to participate in the elective deferral portion of the plan with one month of service requirement and must be of nineteen years of age. Employees who have one year of service and are age nineteen are eligible for the employer non-elective contribution portion of the plan. The Plan's Administrative Committee is responsible for the oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Administrative Committee.

Contributions -

Each year, participants are allowed to contribute to the Plan up to 100% of their pretax annual compensation, with such contributions not to exceed the maximum allowable by law annually. Participants may also contribute amounts representing distributions from other qualified benefit plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The plan has elected the Safe Harbor provisions. Under these provisions the employer will make a matching contribution of 100% of the participant's elective deferral that does not exceed 3% of compensation, as defined in the Plan, plus 50% of the elective deferral that exceeds 3% of compensation but does not exceed 5% of compensation. For the Plan years ended December 31, 2024 and 2023, the employer safe harbor contribution was \$1,055,108 and \$910,518, respectively.

The plan allows discretionary employer profit sharing contributions. For the plan years ended December 31, 2024 and 2023, the employer did not make a discretionary contribution to the plan.

Participants direct the investment of all contributions into various investment options offered by the Plan.

(1) DESCRIPTION OF PLAN (continued):

Participant Accounts -

Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's contribution and (b) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants -

The Plan allows participants to borrow up to a maximum equal to the lesser of \$50,000 or one-half of their vested interests in the Plan. The loans are secured by the balance in the participant's account and must bear a reasonable rate of interest. Principal and interest are paid through payroll deductions over a reasonable period of time.

Vesting -

Participants are immediately vested in their voluntary contributions and safe harbor matching contributions, plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after six years of credited service.

Forfeitures -

There were \$8,227 and \$702 forfeited non-vested accounts at December 31, 2024 and 2023, respectively. These accounts will be used to reduce administrative expenses of the plan then the remaining forfeitures shall be used to reduce future employer contributions. For the years ended December 31, 2024 and 2023, no forfeitures were used to reduce employer contributions or used to pay plan fees.

Payment of Benefits -

On termination of service due to death, disability, or retirement, a participant may elect to have his or her vested aggregate account distributed as a lump sum payment. The Plan also allows for in-service hardship withdrawals and employee loans under certain conditions.

(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of Accounting -

The financial statements of the plan are prepared on the accrual basis of accounting.

(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued):

Use of Estimates -

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants -

Notes receivable from participants are measured and reported at their unpaid balances plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Investment Valuation and Income Recognition -

Investments are reported at fair value (except for the fully benefit responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Contributions -

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits -

Benefits are recorded when paid.

Expenses -

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation or depreciation of fair value of investments.

(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued):

Subsequent Events -

Subsequent events were evaluated through September 30, 2025, which is the date the financial statements were available to be issued.

(3) FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Investments held in group variable annuity investment contracts pooled separate accounts: Valued based on the quoted net asset values of the units held by the Plan, which is then adjusted to apply the expense factor that is disclosed in the group annuity contract, as calculated by the group annuity provider.

(4) INVESTMENT CONTRACT WITH INSURANCE COMPANY:

In 2012, the Plan entered into a benefit-responsive investment contract with Voya Retirement Insurance and Annuity Company ("Voya") totaling \$1,249,757 and \$1,208,698 as December 31, 2024 and 2023 respectively. Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula agreed upon with the issuer. The guaranteed investment contract does not permit the investment issuer to terminate the agreement prior to the scheduled maturity date.

The contract meets the fully benefit responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value as reported to the Plan by Voya, represents contributions made under contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. As of December 31, 2024 and 2023, contract value is deemed to equal fair value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

(4) INVESTMENT CONTRACT WITH INSURANCE COMPANY (continued):

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibition transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

(5) TRANSACTIONS WITH PARTIES IN INTEREST:

For the Plan years ended December 31, 2024 and 2023, certain accounting fees were paid by the Plan Sponsor. Certain employees of the company perform administrative services for the Plan. These employees receive no compensation from the Plan for these services. Certain plan investments are funds managed by Voya Retirement Insurance and Annuity Company ("Voya"). Voya is the issuer of the group funding agreement and, therefore, these transactions qualify as party-in-interest transactions.

(6) PLAN TERMINATION:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

(7) TAX STATUS:

The Plan has received a favorable determination letter from The Internal Revenue Service dated June 30, 2020 relating to amendments adopted by the Plan effective prior to the date thereof. The Plan has since been amended. However, the Plan Administrator believes the Plan, as amended, is currently being operated in compliance with applicable requirements of the Internal Revenue Code and is exempt from Federal income taxes.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

(8) RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

(9) CERTIFIED INVESTMENTS:

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya Retirement Insurance and Annuity Company (the custodian of the plan).
