Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Frederick Primary Care Associates, P.A. Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

(1) Description of plan

The following description of the Frederick Primary Care Associates, P.A. (the Sponsor) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General: The Plan became effective April 1, 1986. It is a defined contribution retirement plan covering all employees of the Sponsor. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

Effective January 1, 2019, the Plan adopted an amendment to freeze the plan. This means that no employee deferrals and no employer contributions will be made to the Plan and no employee, former employer, or inactive participant will become an active participant after January 1, 2019.

Participant accounts: Each participant's account is credited with the participant's contribution and allocations of (a) the Sponsor's contribution, (b) Plan earnings, and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances or specific transactions, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their savings contributions, matching contributions, discretionary contributions and past contributions plus actual earnings thereon.

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of the participant's vested account balance. The number of outstanding loans is limited to 2. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 4.50% to 9.50%. Principal and interest is paid ratably through semi-monthly payroll deductions.

Payment of benefits: On termination of service, a participant will receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account. The participant may have all or any portion of the distribution paid in a direct rollover to an IRA or another employer plan. If the amount exceeds \$5,000, a participant may elect to leave their funds in the Plan, or to receive installment payments based on their life expectancy.

(2) Summary of significant accounting policies

Basis of accounting: The accompanying financial statements are presented on the accrual basis of accounting.

(2) Summary of significant accounting policies (continued)

Use of estimates: The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the custodian/trustee. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. No accrued interest or dividends existed as of December 31, 2024 and 2023. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest is charged on the loans at rates ranging from 4.50% to 9.50%. The Plan has not identified any uncollectible loans at December 31, 2024. Loans that become uncollectible are reported to the participant as a deemed distribution.

Administrative expenses: Investment expenses, loan fees associated with notes receivable from participants and other administrative and recordkeeping fees are paid for by the Plan. These expenses may be allocated among participants, or for participant specific expenses, directly to the participant's account. Certain accounting and administrative functions of the Plan are performed by employees of the Sponsor at no cost to the Plan.

Administrative expenses paid by the Plan totaled \$60,320 for the year ended December 31, 2024.

Investment related expenses are included in the net appreciation in fair value of investments.

Payment of benefits: Benefit payments to participants are recorded when paid.

(3) Information prepared and certified by the Plan's trustee

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus, LLC, as agent for Ascensus Trust Company and Newport Trust Company, LLC, the trustee, has certified as to the completeness and accuracy of all investments reflected in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reflected in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

(4) Risks and uncertainties

The Plan provides for various investment options which may include any combination of stocks, bonds, fixed income securities, mutual funds, common trust funds, and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit.

(4) Risks and uncertainties (continued)

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participant's account balances and amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

(5) Fair value measurements

Accounting Standards Codification Topic 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Registered investment companies (mutual funds): Valued at the net asset value of shares held by the plan at year end. The mutual funds held by the Plan are mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

Self-directed brokerage accounts: The fair values of the mutual funds, stocks and bonds within the self-directed brokerage accounts are based on quoted market prices when available.

Collective investment trust: The fair value of the stable value fund is based on the net asset value (NAV) of participation units. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investments for an amount different than the NAV. Participant transactions (purchases and sales) may occur daily. The fund provides for daily redemptions by the Plan with no advance notice requirements and has redemption prices that are determined by the fund's net asset value per unit. If the Plan initiates a full redemption, the issuer reserves the right to require twelve months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments at December 31, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In accordance with Subtopic 820-10, certain investments that were measured at net asset value per share (or its equivalent) as a practical expedient are not classified in the fair value hierarchy. The fair value amounts presented in this table for such investments are intended to permit reconciliation of the fair value hierarchy to the investments at fair value presented in the Statements of Net Assets Available for Benefits.

(6) Related party transactions

Plan investments were administered and managed by Vanguard Group, Inc. and Global Retirement Partners for the year ended December 31, 2024. Due to these relationships, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for recordkeeping and investment management services amount to \$60,320 for the year ended December 31, 2024.

(7) Tax status

The plan has adopted a non-standardized form of a prototype plan sponsored by a third party administrator. The prototype plan received its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designated, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is currently designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax-exempt.

(7) Tax status (continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has an uncertain tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan Administrator has evaluated the Plan's tax positions and has concluded that there are no uncertain positions taken or expected to be taken that would require adjustments to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. The Plan is generally no longer subject to income tax examinations by federal, state, or local tax authorities for years prior to 2021.

(8) Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

(9) Subsequent events

In preparing these financial statements, the Sponsor has evaluated events and transactions for potential recognition or disclosure through September 25, 2025, the date the financial statements were available to be issued. There are no subsequent events requiring disclosure in these financial statements.
