V. Actuarial Assumptions

A. Funding – The following actuarial assumptions were used in the calculation of the required contribution:

- 1) Interest Rate – Mandated Segment Rates of 4.21/4.75, 4.86/4.87% and 4.87/5.59% were used for the maximum and minimum respectively. The Effective interest rate was 4.83%.
- 2) Mortality Table – The 2024 Applicable Mortality Table was used for the post-retirement period.
- 3) Salary Scale – It was assumed that salaries would remain constant.
- 4) Severance Discount – No discount for early severance was assumed.
- 5) Retirement Age – It was assumed that employees would retire on their Normal Retirement Date or immediately if later.
- 6) Asset Valuation – Assets were valued at market value for purposes of calculating the required contribution.
- 7) Actuarial Cost Method – Required PPA valuation method.

VI. Principal Plan Provisions - A summary of the main operational features of the Plan is as follows:

- A. Effective Date – January 1, 2008.
- B. Eligibility - On the January 1 or July 1 after One Year of Service and attainment of age 21.
- C. Benefit Service - All Plan Years (Jan. 1-Dec. 31) of 1000 hours are counted.
- D. Retirement Dates - Normal - The first of the month following age 65 or the later completion of 5 Years of Plan Participation.
- E. Benefit Formula - A monthly life annuity at Normal Retirement Date equal to 6.75% of Average Compensation multiplied by Years of Service to a maximum of 10 years.
- F. Pre Retirement Death Benefit - The benefit which can be provided by the Actuarial Equivalent of the accrued retirement pension.
- G. Vesting – Participants become 20% vested after completion of two Years of Service increasing by 20% per Year to 100% after 6 Years of Service.


