Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements

We have performed audits of the accompanying financial statements of 403(b) Thrift Plan of Spectrum for Living (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

A. DESCRIPTION OF PLAN

The following description of 403(b) Thrift Plan of Spectrum for Living (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established on September 1, 2002, and is a defined contribution plan qualifying under Section 403(b) of the Internal Revenue Code ("IRC"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan was established for the purpose of providing eligible employees of Spectrum for Living (the "Employer"), and their beneficiaries, funds for retirement. Employees are eligible to participate in the Plan at the commencement of their employment with the Employer and the entry date is the first day of the pay period on or after the commencement of employment.

Mutual of America Life Insurance Company (the "Trustee") is the trustee of the Plan.

Contributions

A participant of the Plan may make contributions to the Plan through payroll deductions of any whole percentage up to 100% of compensation, as defined, up to the limit prescribed by the IRC. Any participant, age 50 or over, may make an additional "catch up" contribution as determined by the Internal Revenue Service ("IRS"). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Beginning January 1, 2024, the Plan permits participants to make Roth contributions to the Plan.

During the year ended December 31, 2024, employer matching contributions were not permitted under the Plan. Beginning January 1, 2025, the Plan was amended to allow for employer matching contributions.

Participant Accounts

Individual accounts are established for each participant. The Plan offers a variety of pooled separate accounts with varying investment objectives and an insurance general account as investment options. Each participant's account is credited with the participant's pre-tax contributions, the Employer contributions, and the proportionate share of dividends, interest and investment gains since the preceding valuation date. The participant's account is reduced by withdrawals, losses on investments, and administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTES TO FINANCIAL STATEMENTS

A. DESCRIPTION OF PLAN (CONTINUED)

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Employer contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service or upon attaining normal retirement age, disability, or death, based upon the following schedule:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than two years	0%
Two years but less than three years	20%
Three years but less than four years	40%
Four years but less than five years	60%
Five years but less than six years	80%
Six years or more	100%

Vesting years of service is the total of a participant's countable periods of service without regard to hours of service. A participant is always 100% vested in his/her own deferred salary contribution to the Plan and income earned thereon, but with respect to the Employer contributions, any unvested portion of his/her account shall be forfeited at termination.

Payment of Benefits

A participant may make withdrawals of vested amounts upon retirement, death, disability, separation from service, attainment of age 59½ or hardship. A distribution will be made on account of hardship, for the IRC's safe harbor reasons, only if it is necessary in light of immediate and heavy financial needs of the participant.

Upon termination of employment, a participant's vested interest in his or her account is distributed in the form of (i) joint and survivor annuity, (ii) lump-sum payment, or (iii) payments made over a period of time not to exceed the life expectancy of the participant and/or beneficiary. Lump-sum payment is distributed if the vested interest is \$5,000 or less.

The Plan permits participants to receive benefits due no later than 60 days after the Plan year in which the latest of the following occurs: (i) the participant reaches normal retirement date, (ii) the participant has become eligible for early retirement and has completed ten years of service, or (iii) the participant terminates employment.

Forfeited Accounts

Forfeitures of non-vested Employer contributions will be used first to pay certain Plan expenses. Any amount of forfeitures remaining will be used to reduce future Employer contributions. At December 31, 2024 and 2023, forfeited non-vested amounts were \$23 and \$618, respectively. During the year ended December 31, 2024, \$603 of forfeitures were used to pay Plan expenses.

Expenses of the Plan

The Plan's administrative expenses are paid by the Plan Sponsor, as provided by the Plan document.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the Trustee. See Note D for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income are recorded on the accrual basis.

The Plan has an investment in the Mutual of America Interest Accumulation Account (the "General Account"). The General Account is comparable to a cash equivalent for the following reasons:

- There are no front or back-end charges, so investments are completely liquid.
- The interest rate credited to investments in the General Account is a current rate and is not dependent upon the length of time the assets are invested with the investment custodian.
- Requests for withdrawal can be made at any time and are processed on the day that they are received; they are not dependent on the company having to liquidate securities in order to generate payment.
- The value shown on the pension fund report is the redeemable value of the fund; there are no deferred sales charges, load assessments or interest rate adjustments that would affect the value as a result of a withdrawal request.

Because the investment in the General Account is comparable to a cash equivalent, the investment is excluded from the fair value hierarchy classification disclosure in Note D.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Plan Loans

Participants may borrow from the Trustee, and use their Plan account balance as collateral for the loan. The loan amount plus an additional 20% must be held in the General Account as collateral. These loans are not taken from Plan assets and therefore, are not included in the statements of net assets available for benefits. The minimum loan amount is \$1,000. Generally, the maximum amount that can be borrowed is the lesser of \$50,000 or 50% of the participant's vested account balance. This is further reduced by the participant's highest outstanding loan balance within the previous 12 months. As of December 31, 2024 and 2023, the outstanding loan balance was approximately \$209,337 and \$168,004, respectively. Interest rates may be fixed or variable and the initial rate is determined by the terms of the contract. Loan interest is calculated using a variable rate set by the Trustee and is subject to change at the beginning of each calendar quarter. The loan interest rate is equal to the credited General Account interest rate plus 3%. The interest rate on the loans ranged from 3.25% to 5.85% at December 31, 2024 and 2023. The loans mature at various dates through May 2030. Repayment of principal and interest can be made through employee payroll deductions or paid directly to the Trustee.

Subsequent Events

Management has evaluated subsequent events for potential recognition and disclosure through September 15, 2025, the date the financial statements were available to be issued. Except for the matters disclosed in Notes A and J, no items were determined by management to require disclosure.

C. INFORMATION CERTIFIED BY TRUSTEE

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Mutual of America Life Insurance Company, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information included in the schedule of assets (held at end of year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required schedule.

D. FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in less active markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts: Valued at the net asset value ("NAV") of shares held by the Plan at year end, which is based on the unit prices quoted by the fund representing the fair value of the underlying investments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the end of the reporting period.

The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the years ended December 31, 2024 and 2023, there were no transfers between levels.

E. PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer reserves the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

F. CONCENTRATION OF CREDIT RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

G. TRANSACTIONS WITH PARTIES-IN-INTEREST

Certain Plan investments are shares of pooled separate accounts and an investment contract managed by the Trustee, and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for participant transaction fees amounted to \$2,768 for the year ended December 31, 2024.

NOTES TO FINANCIAL STATEMENTS

H. TAX STATUS

The Plan has not yet received a determination letter from the IRS under its 403(b) plan application process. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and ERISA.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
