Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Baesler's, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Baesler's, Inc. 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Baesler's, Inc. 401(k) Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. NOTE 1 - DESCRIPTION OF PLAN

The following description of the Baesler's, Inc. 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of Baesler's, Inc. (Company), who have one year of service and are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligible employees may enter into a written salary deferral agreement with the Company to contribute to the Plan a specified whole percentage of their salaries, up to 100% of their plan compensation each pay period. Under no circumstances may an employee contribute an amount exceeding that allowed by the Internal Revenue Service of \$23,000 for 2024. Eligible participants, who have reached the age of 50 by the close of the plan year, may make an additional "catch up" contribution in an amount up to \$7,500 for 2024.

Safe - harbor matching contributions will be made on behalf of Participants in an amount equal to 100% of the amount of the Eligible Participant's Elective Deferrals that do not exceed 3% of the Participant's Compensation and 50% of the amount of the Participant's Elective Deferrals that exceed 3% of the Participant's Compensation but that do not exceed 5% of the Participant's Compensation.

If a discretionary contribution is made, the Employer's contribution for the Plan Year shall be allocated to the accounts of eligible Participants. The Employer's contribution for the Plan Year shall be allocated to each eligible Participant on a pro-rata basis based on the Compensation of the Participant to the total Compensation of all participants.

An employee who is entitled to receive an Eligible Rollover Distribution from another qualified plan may contribute the Eligible Rollover Distribution into a Rollover account under the Plan.

Participant Accounts

Each participant may direct that his individual account be invested in one or any combination of the investment choices made available. Each participant's account is credited with the participant's contribution and allocation of (a) the Company's contribution and (b) unrealized and realized plan earnings (losses). Plan earnings are charged with an allocation of administrative expenses. Allocations are based upon employee earnings or account balances as defined by the plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are immediately vested in their voluntary contributions and safe harbor matching contributions, plus actual earnings thereon. Employer discretionary contributions and the related earnings thereon, are vested in participant's accounts based on years of continuous service. A participant is 100 percent vested after 6 years of credited service.

Forfeitures

Forfeitures are the non-vested amounts in the accounts of participants who terminated service. Forfeitures shall be used to restore forfeitures, reduce future employer contributions to the plan, or to pay reasonable expenses. As of December 31, 2024 and 2023, the balance in forfeiture accounts was \$458 and \$458, respectively.

Notes Receivable from Participants

Participants may borrow from their accounts a maximum of the lesser of \$50,000 or ½ of the sum of their non-forfeitable account balances. The minimum that can be borrowed is \$500. Loan transactions are treated as a transfer to (from) the applicable investment fund from (to) the Participant Loan fund. Loan terms range up to 5 years. The loans are secured by the balance in the participant's account and bear interest at rates determined by the Administrator in accordance with ERISA. Principal and interest are paid ratably through monthly payroll deductions. A participant may have no more than three outstanding loans at any given time during any calendar year.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive a distribution. The participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or use the value of the account to purchase an annuity contract. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan can make involuntary cash outs of participants with account balances less than \$1,000.

Administration

The trustees of the Plan have the overall responsibility and authority to manage and control the operation and administration of the plan. Certain other administrative functions are performed by officers or employees of the Company. The trustees and such officers and employees do not receive compensation from the Plan. The Plan is charged an administrative fee for setup and maintenance of the participants' accounts. These fees are allocated to the participants' accounts. All other plan expenses are paid by the plan sponsor.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of the financial statements in conformity with generally accepted accounting principles requires the Plan's management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from these estimates.

Investments

Investments in pooled separate accounts are recorded at net asset value reported to the plan by John Hancock - see Note 3. Pooled separate account transactions are recorded on a trade-date basis. Interest income is recorded on the accrual basis. The pooled separate accounts do not pay dividends.

Investments in traditional investment contracts are recorded at contract value - See Note 3.

Notes Receivable from Participants

Notes receivable are recorded at fair market value. The allowance for credit losses was zero at December 31, 2024 and 2023.

Subsequent Events

Management has evaluated subsequent events through October 3, 2025, the date which the financial statements were available for issue and concluded nothing occurred requiring adjustment to the financial statements or disclosure in the notes to the financial statements.

NOTE 3 - FAIR VALUE MEASUREMENT

Financial Accounting Standards Board ASC 820 establishes a framework for fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs (Quoted Prices) - are quoted prices in active markets for identical assets that the Plan has the ability to access at the measurement date (for example, prices derived from NYSE, NASDAQ and the Chicago Board of Trade). If a level 1 input is available for a particular investment, it must be used to value that investment.

NOTE 3 - FAIR VALUE MEASUREMENT - continued

Level 2 Inputs (Observable Inputs) - are inputs (other than quoted prices included within level 1) that are observable for the asset, either directly or indirectly. Observable inputs are those that reflect the assumptions market participants would use in pricing the asset developed on market data obtained from sources independent of the Plan (e.g., matrix pricing, yield curves and indices).

Level 3 Inputs (Unobservable Inputs) - are observable inputs for the asset. Unobservable inputs are those that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing the asset developed, based on the best information available in the circumstances (e.g., investment manager pricing for private placements, private equities and hedge funds).

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The Plan held no investments that are required to be presented classified as level 1, 2, or 3.

The following section describes the valuation methodologies the Plan uses to measure financial assets and liabilities at fair value.

Pooled Separate Accounts - These are funds invested in mutual funds and accounts with a portfolio of investments. As a practical expedient, management values the accounts at the net asset values reported to the Plan by John Hancock. The net asset value is determined by John Hancock and reported to the Plan based on the value of the underlying mutual fund and class of units held.

The following table summarizes investments for which fair value is measured using the net asset value per share practical expedient as of December 31, 2024 and 2023, respectively. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

The Plan holds a contract with John Hancock that is a traditional investment contract with a value of \$369 and \$490 as of December 31, 2024 and 2023, respectively. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, Baesler's, Inc. 401K Profit Sharing Plan has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 6 - TAX STATUS

The Plan is a prototype pension plan developed and maintained by Ekon Benefits. Ekon Benefits has provided Baesler's, Inc. with a determination letter for the prototype pension plan dated June 30, 2020, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the plan's financial statements.

NOTE 6 - TAX STATUS - continued

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan's information returns are subject to examination by the appropriate taxing jurisdictions. As of December 31, 2024, the plan's tax returns for the last three years are open for examination as each year's returns remain open for examination for three years.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 8 - PARTY-IN-INTEREST TRANSACTIONS

The Plan investments are with John Hancock Insurance Company which is considered a party in interest since it provides services to the Plan. The Plan has various service providers which may be compensated by indirect fees paid out of the investments which are netted against investment income. Management believes the arrangements with the service providers are exempt transactions.
