Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Sandmeyer Steel Company Capital Accumulation Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). (1) Description of Plan

The following brief description of the Sandmeyer Steel Company Capital Accumulation Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a salary deferral and defined contribution plan covering all eligible employees of Sandmeyer Steel Company (the Company). Eligible employees may participate in the Plan upon the attainment of age 18 years and completion of 12 months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA), as amended. The Board of Directors is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

Each year, participants may make contributions to the Plan up to 90% of their pretax annual compensation, as defined in the plan document, subject to Internal Revenue Code (IRC) limits. Effective November 3, 2023, participants may make after tax Roth contributions to the Plan. Participants who have attained age 50 years before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Participants receive a matching employer contribution equal to 25% of their pretax contribution up to a maximum of \$1,000. The 2024 employer matching contribution was \$74,478. The Company may also make a discretionary matching contribution and a non-elective discretionary profit-sharing contribution to eligible active participants. In order to be eligible for both discretionary contributions, participants must have at least 501 hours of service during the plan year and be employed on the last day of the plan year. For 2024, the Company made a discretionary matching contribution of \$.25 of each \$1.00 of eligible participant contributions up to a maximum of \$4,000. The discretionary employer match for 2024 was \$71,927.

All contributions to the Plan by the participants and the employer, plus any plan earnings and participant rollover or transfer contributions, are held in a trust and administered under a written trust agreement.

Contributions from plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's contributions and plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and the Company's contributions plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms are for a period not to exceed five years unless the loan qualifies for the purchase of a principal residence. The loans are secured by the balance in the participants' accounts and bear interest at rates that range from 3.75% to 4.00%, which are commensurate with prevailing rates. Principal and interest are paid ratably through payroll deductions. A participant may only have one loan outstanding at a time. Upon termination of employment, the outstanding principal and interest balance is immediately payable.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant or his or her designated beneficiary will receive a lump-sum amount equal to the value of the participant's account. Participants are entitled to receive the amount credited to their account upon the latter of reaching age 55 or the fifth anniversary of the participant's commencement date.

Hardship Withdrawals

A participant may be permitted to take a hardship withdrawal from his or her account if the distribution is necessary to satisfy an immediate and heavy financial need of the participant, as defined by the Plan.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

(2) Summary of Significant Accounting Policies, Continued

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value as determined and certified by Fidelity Management Trust Company (the trustee). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expense. Investment related expenses are included in net appreciation in fair value of investments. Loan origination and maintenance fees of \$2,181 were charged to specific participant accounts for the year ended December 31, 2024.

Subsequent Events

The Plan has evaluated subsequent events through September 29, 2025, the date the financial statements were available to be issued.

(3) Financial Information Certified by a Qualified Institution

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Line 4i – Schedule of Assets (Held at End of Year), including investments at fair value and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution.

(4) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market fund and registered investment companies: Valued at the daily closing price as reported by the fund. These investments held by the Plan are open-end investments that are registered with the Securities and Exchange Commission. These investments are required to publish their daily net asset value and to transact at that price. The investments held by the Plan are deemed to be actively traded.

(5) Related Party Transactions and Party-In-Interest Transactions

The Plan invests in shares of registered investment companies and a money market fund managed by an affiliate of the trustee. Fidelity Management Trust Company acts as trustee for those investments as defined by the Plan. Transactions in such investments qualify as party-in-interest transactions, which are exempt under the prohibited transaction rules of ERISA.

(6) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, the net assets will be distributed to the participants and beneficiaries based on their account balances.

(7) Tax Status

The Plan uses a pre-approved plan document sponsored by FMR LLC. The Internal Revenue Service (IRS) has determined and informed FMR LLC by a letter dated June 30, 2020, that the plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(8) Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
