### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements**

We have performed an audit of the 2024 financial statements of ATPCO 401(K) SAVINGS PLAN, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

## NOTES TO FINANCIAL STATEMENTS

**NOTE 1—PLAN DESCRIPTION**

The following description of the ATPCO 401(k) Savings Plan (the “Plan”) provides only general information. Readers of the financial statements should refer to the Plan agreement for a more comprehensive description of the Plan’s provisions.

1. General – The Plan is a defined contribution plan covering all employees of ATPCO (the “Company”) who are United States citizens or foreign nationals residing in the United States. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The trustees are responsible for oversight of the Plan. The Plan’s management determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to the Plan’s trustees.
2. Contributions – Eligible participants may choose to contribute by payroll deduction up to a maximum of \$23,000 for 2024 and \$22,500 for 2023. Participants who are at least age 50 may make additional “catch-up” contributions of \$7,500 in 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified plans, as defined in the Plan’s provisions. The Plan has the auto-enrollment provision. Under this provision, employees who become eligible to participate are automatically enrolled in the Plan with a pre-tax contribution rate of 6%, unless otherwise elected. In addition, automatically enrolled participants will have their pre-tax contribution rate increased by 1% automatically every January 1<sup>st</sup>, until 10% is reached or another election is made by the participant.

The Company matches 100% of participant contributions that do not exceed 1% of compensation, plus 50% of the amount of participant contributions exceeding 1% but not to exceed 6% of participant compensation. For the years ended December 31, 2024 and 2023, the Company contributed \$1,641,253 and \$1,886,268, respectively, in employer matching contributions. Each pay period, the Company also makes a discretionary contribution to the Plan to be allocated to employees based on their age and years of service with the Company. For the years ended December 31, 2024 and 2023, the Company contributed \$2,202,359 and \$1,654,483, respectively, in discretionary contributions.

3. Participant Accounts – Each participant’s account is credited with the participant’s contribution and allocation of the Company’s contributions and plan earnings. Allocations are based on participant earnings or account balances, as defined. Participants direct the investment of their contributions and the Company’s contributions into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
4. Vesting – Participants are 100% vested in their voluntary contributions plus actual earnings thereon. Participants’ vesting in the Company’s contributions is based on years of service. A participant becomes 100% vested in employer matching contributions after two years of service and 100% vested in employer discretionary contributions after three years of service.
5. Forfeited Accounts – Forfeitures can be used to make contributions to the Plan or pay administrative expenses of the Plan. Forfeitures utilized to make contributions were \$462,621 and \$-0- for 2024 and 2023, respectively. Forfeitures utilized to pay expenses were \$-0- for 2024 and \$2,462 for 2023, respectively. Unused forfeitures were \$209,720 and \$457,292 at December 31, 2024 and 2023, respectively.

## NOTES TO FINANCIAL STATEMENTS

**NOTE 1—PLAN DESCRIPTION (Continued)**

6. Payment of Benefits – On termination of service due to death, disability, or retirement, or for other reasons, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. If no election is made, distributions are made no later than when a participant reaches age 65, the tenth anniversary of the year participant commenced, or upon disability or death. Distributions may be deferred until the normal retirement date. In certain hardship situations, participants may withdraw their account balances while still being actively employed by the Company.
7. Participant Loans – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance, reduced by the amount of the participant's highest outstanding loan balance during the previous one-year period. Loan terms range from one to five years, or up to ten years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing commercial rates for similar loans. Principal and interest are paid ratably through regular payroll deductions, or individually through John Hancock's online portal.
8. Administrative Expenses – Certain administrative expenses of the Plan are paid by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Expenses related to investments are included in the net appreciation of fair value of investments.

**NOTE 2—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES****BASIS OF ACCOUNTING**

The accompanying financial statements have been prepared using the accrual basis of accounting.

Investment held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

**USE OF ESTIMATES**

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions to and deductions from plan assets during the reporting period. Actual results could differ from those estimates.

**RECLASSIFICATIONS**

Certain amounts from the prior year have been reclassified to conform with the current presentation without affecting the changes in net assets and total net assets available for benefits.

**NOTE 2—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)****INVESTMENT VALUATION AND INCOME RECOGNITION**

The Plan's investments are held by John Hancock. Investments are stated at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors, custodian, and insurance company.

Purchases and sales of securities are reflected on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investment bought and sold as well as held during the year.

**NOTES RECEIVABLE FROM PARTICIPANTS**

Notes receivable from participants are valued at their unpaid principal balances plus any accrued but unpaid interest, which approximates fair value. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**BENEFIT PAYMENTS**

Benefit payments to participants are recorded when paid.

**NOTE 3—FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

## NOTES TO FINANCIAL STATEMENTS

**NOTE 3—FAIR VALUE MEASUREMENTS (Continued)**

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Level 1 Fair Value Measurements*

Mutual funds are valued at the daily closing price, as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are held with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage accounts consist primarily of interest-bearing cash, corporate debt instruments, mutual funds, common stocks, and unit investment trusts that are valued on the basis of readily determinable market prices.

*Level 2 Fair Value Measurements*

Level 2 Fair Value Measurements are not applicable to the Plan for 2024 and 2023.

*Level 3 Fair Value Measurements*

Level 3 Fair Value Measurements are not applicable to the Plan for 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In accordance with subtopic 820-10, certain investments that were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statement of net assets available for benefits.

Common collective trusts are valued at the net asset value (“NAV”) of shares held by the Plan at year-end. NAV is determined by each fund's recordkeeper based on the fair value of the underlying securities held less liabilities held by the fund. This practical expedient is not used when it is determined to be provable that the fund will sell the investment for an amount different than the reported NAV. Plan transactions (issuance and redemptions) may occur daily. There are no restrictions on a participant's ability to redeem investments. However, withdrawals prompted by certain events (e.g., termination of the managed income portfolio, changes in laws and regulations) may restrict a participant's ability to redeem the investment at its NAV.

**NOTE 4—FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The Plan holds a traditional investment contract with New York Life Insurance Company. This contract meets the fully benefit-responsive investment contract's criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because that is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than zero. Such interest rates were reviewed on a quarterly basis for resetting.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include: the Plan's failure to qualify under Section 401(a) of the Internal Revenue Code; premature termination of the contracts; Plan termination or merger; changes to the Plan's prohibition on competing investment options; bankruptcy of the Plan sponsor or other Plan sponsor events, such as divestitures or spinoffs of a subsidiary, that significantly affect the Plan's normal operations. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include: an uncured violation of the Plan's investment guidelines; a breach of material obligation under the contract; a material misrepresentation; a material amendment to the agreement without the consent of the issuer.

**NOTE 5—INFORMATION CERTIFIED BY THE PLAN'S RECORDKEEPER**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the John Hancock has certified that the following data included in the accompanying financial statements and schedule is complete and accurate.

- a. Investments, as shown in the accompanying statements of net assets available for benefits, as of December 31, 2024 and 2023.
- b. Investment income, as shown in the accompanying statements of changes in net assets available for benefits, for the years ended December 31, 2024 and 2023.
- c. The schedule of assets (held at end of year) as of December 31, 2024, as shown on Schedule H, Line 4(i).

**NOTE 5—INFORMATION CERTIFIED BY THE PLAN'S RECORDKEEPER (Continued)**

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**NOTE 6—PARTY-IN-INTEREST TRANSACTIONS**

The Plan's investments are managed by John Hancock, the custodian of the Plan's assets. John Hancock also provides certain administrative services to the Plan. Various fees are paid by the Plan to John Hancock for these services. Investment advisor fees are also paid by the Plan to Global Retirement Partners, LLC. All of these transactions qualify as a party-in-interest transactions. Some fees are netted against Plan earnings and some are shown directly as administrative expenses on the statements of changes in net assets available for benefits. None of the transactions with parties-in-interest are prohibited.

**NOTE 7—PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 8—TAX STATUS**

The Plan has adopted a non-standardized pre-approved plan sponsored by John Hancock Retirement Plan Services LLC for its original plan documents and amendments. The pre-approved plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by the Plan. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 9—RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
