Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of U.S. Oral Surgery Management, LLC Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Opinion

Note 1 – Description of the Plan

The following description of the U.S. Oral Surgery Management, LLC Retirement Plan (the Plan), provides only general information. Participants should refer to the Plan agreement, as amended, for a more complete description of the Plan's provisions.

General – The Plan, established on November 1, 1971, restated most recently March 27, 2020, is a defined contribution plan covering employees of U.S. Oral Surgery Management, LLC, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). U.S. Oral Surgery Management, LLC (the Company) is the Plan's Sponsor and serves as Plan administrator.

As a result of the Company's acquisitions during 2023 and 2024, 10 separate plans merged into the Plan during 2024. The merging plans transferred assets of \$12,160,584 into the Plan, included on the statement of changes in net assets available for benefits, for the year ending December 31, 2024.

Eligibility – Prior to January 1, 2024, employees of the Company were eligible to participate in the Plan upon reaching age 21 and after completing one month of service, except for those employees covered by a collective bargaining agreement, certain nonresident aliens, residents of Puerto Rico, and temporary or seasonal employees whose regularly scheduled service are less than 1,000 hours per year.

Effective January 1, 2024, the Plan amended the eligibility requirements reducing the age requirement to age 20 and allowing temporary and seasonal employees to participate if meeting all other requirements.

Participant contributions – Participants may make contributions to the Plan up to the lesser of 100% of compensation, as defined by the Plan document, or the maximum amount allowed by the statutes. Participants may also elect to make Roth contributions utilizing after-tax contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated fund until elected otherwise by the participant. Prior to October 1, 2024, deferrals were not subject to annual automatic increases.

Effective October 1, 2024, all automatically enrolled participants will be subject to an annual deferral rate increase of 1%, up to a maximum auto-deferral rate of 10%, applied on July 1st unless this occurs within the first six months of a participant's automatic enrollment.

Employer safe harbor contributions – The Company makes safe harbor non-elective employer contributions equal to 3% of the participant's eligible compensation for each of the Plan years ending December 31, 2024 and 2023.

Employer match and profit sharing contributions – The Company may elect to make a discretionary match to the Plan on behalf of eligible participants or a designated group of eligible participants equal to a uniform percentage of a participant's salary deferral. Additionally, the Company may make a discretionary profit sharing contribution to the Plan as determined annually by the Plan Sponsor. The Company made a profit sharing match of \$3,738,156, included in the employer contribution receivable on the statement of net assets available for benefits, for the year ending December 31, 2024.

Contributions are subject to regulatory limitations.

Participant accounts – Each participant’s account is credited with the participant’s contribution and an allocation of (a) the Company’s contribution, and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined in the Plan agreement. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan.

Vesting – Participants are immediately vested in their voluntary contributions and the Company’s safe harbor contributions, plus actual earnings thereon. Prior to December 1, 2023, vesting in the Company’s discretionary match and profit sharing contribution portions of their accounts were based on the following schedule and for merging plans, prior company contributions vested according to the provisions of the merging plan’s applicable plan document and not the following schedule:

Beginning December 1, 2023, participants are immediately vested in the Company’s discretionary match and profit sharing contributions portions of their accounts and for merging plans, prior company contributions will vest immediately upon merger.

Notes receivable from participants – Participants are permitted by the Plan to borrow funds up to 50% of their vested account balance or \$50,000, whichever is less. No notes are issued for less than \$1,000. Note transactions are treated as a transfer from the investment fund to the participant notes fund. Note terms range from one to five years, unless it is for the purchase of the participant’s principal residence in which case the note repayment period may not extend beyond 10 years from the date of the note. The notes are secured by the balance in the participant’s account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid through payroll deductions under a level amortization schedule. As of December 31, 2024, the rates of interest on outstanding loans ranged from 3.75% to 9.50% with various maturities through November 2033.

Payment of benefits – Distributions are made for separation in service upon retirement, death, disability, or termination of employment, equal to the value of the participant’s vested interest in his or her account. Participants who have not separated from service and have reached age 59½ can request distributions subject to certain restrictions. All distributions are made in lump sum amounts and recorded when paid.

Forfeited accounts – Forfeitures are the nonvested portion of a participant’s account that are lost upon termination of employment and are retained in the Plan. As of December 31, 2024, the forfeited nonvested accounts total was \$92,572. These accounts may be used to pay Plan expenses and reduce future employer contributions. In 2024, \$148,752 of forfeitures were used to reduce employer contributions and \$38,238 were used to reduce plan expenses. All remaining forfeitures were used in August 2025 to reduce employer contributions.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual method of accounting.

Use of estimates – The preparation of financial statements in conformity with GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment valuation – Investments are reported at fair value. The Plan’s Trustee, Fidelity Management Trust Company, certifies the fair market value of all investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the “exit price”) in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

Contributions – Contributions from participants and corresponding matching contributions are recorded in the year in which the employee contributions are withheld from compensation, or the related participant compensation is earned.

Notes receivable from participants – Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance, plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan agreement. No allowance for credit losses have been recorded as of December 31, 2024.

Expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Payment of benefits – Benefits are recorded when paid.

Subsequent events – Through the report date, the Plan has merged in several additional plan assets approximating \$18,831,725. The Plan administrator has evaluated subsequent events, through October 2, 2025, which is the date the financial statements were available to be issued.

Note 3 – Certified Investment Information

The Plan's administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's *Rules and Regulations for Reporting and Disclosure* under ERISA. Accordingly, Fidelity Management Trust Company, the Trustee of the Plan, has certified to the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, dividends, interest, and interest income from notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on the schedule of assets (held at end of year).

Note 4 – Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

Registered investment companies (mutual funds) and money market funds – Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

Self-directed brokerage accounts – Accounts primarily consist of mutual funds, money market funds, and common stocks that are valued on the basis of readily determinable market prices.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's investments in registered investment companies and self-directed brokerage accounts are classified as Level 1 under the fair value hierarchy at December 31, 2024 and 2023. There have been no changes in the techniques used at December 31, 2024 and 2023.

Note 5 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 6 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with the investment securities, that changes in the values of investments in the near term could materially affect a participant's account and the amounts reported in the statements of net assets available for benefits.

Note 7 – Party-in-Interest Transactions

The Plan paid expenses related to the Plan's operations and investment management to various service providers. Certain Plan investments are managed by the Trustee of the Plan. However, transactions with the Trustee qualify as exempt party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. In addition, during the year ended December 31, 2024, the Company paid audit and certain administrative custodial fees on behalf of the Plan.

Note 8 – Tax Status

The Plan document is a volume submitter defined contribution plan that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9 – Reconciliation to Form 5500

Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of U.S. Oral Surgery Management, LLC Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of U.S. Oral Surgery Management, LLC Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of U.S. Oral Surgery Management, LLC Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt U.S. Oral Surgery Management, LLC Retirement Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- exercise professional judgment and maintain professional skepticism throughout the audit.

Accordingly, no such opinion is expressed.

- conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about of U.S. Oral Surgery Management, LLC Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1 – Description of the Plan

The following description of the U.S. Oral Surgery Management, LLC Retirement Plan (the Plan), provides only general information. Participants should refer to the Plan agreement, as amended, for a more complete description of the Plan's provisions.

General – The Plan, established on November 1, 1971, restated most recently March 27, 2020, is a defined contribution plan covering employees of U.S. Oral Surgery Management, LLC, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). U.S. Oral Surgery Management, LLC (the Company) is the Plan's Sponsor and serves as Plan administrator.

As a result of the Company's acquisitions during 2023 and 2024, 10 separate plans merged into the Plan during 2024. The merging plans transferred assets of \$12,160,584 into the Plan, included on the statement of changes in net assets available for benefits, for the year ending December 31, 2024.

Eligibility – Prior to January 1, 2024, employees of the Company were eligible to participate in the Plan upon reaching age 21 and after completing one month of service, except for those employees covered by a collective bargaining agreement, certain nonresident aliens, residents of Puerto Rico, and temporary or seasonal employees whose regularly scheduled service are less than 1,000 hours per year.

Effective January 1, 2024, the Plan amended the eligibility requirements reducing the age requirement to age 20 and allowing temporary and seasonal employees to participate if meeting all other requirements.

Participant contributions – Participants may make contributions to the Plan up to the lesser of 100% of compensation, as defined by the Plan document, or the maximum amount allowed by the statutes. Participants may also elect to make Roth contributions utilizing after-tax contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated fund until elected otherwise by the participant. Prior to October 1, 2024, deferrals were not subject to annual automatic increases.

Effective October 1, 2024, all automatically enrolled participants will be subject to an annual deferral rate increase of 1%, up to a maximum auto-deferral rate of 10%, applied on July 1st unless this occurs within the first six months of a participant's automatic enrollment.

Employer safe harbor contributions – The Company makes safe harbor non-elective employer contributions equal to 3% of the participant's eligible compensation for each of the Plan years ending December 31, 2024 and 2023.

Employer match and profit sharing contributions – The Company may elect to make a discretionary match to the Plan on behalf of eligible participants or a designated group of eligible participants equal to a uniform percentage of a participant's salary deferral. Additionally, the Company may make a discretionary profit sharing contribution to the Plan as determined annually by the Plan Sponsor. The Company made a profit sharing match of \$3,738,156, included in the employer contribution receivable on the statement of net assets available for benefits, for the year ending December 31, 2024.

Contributions are subject to regulatory limitations.

Participant accounts – Each participant’s account is credited with the participant’s contribution and an allocation of (a) the Company’s contribution, and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined in the Plan agreement. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan.

Vesting – Participants are immediately vested in their voluntary contributions and the Company’s safe harbor contributions, plus actual earnings thereon. Prior to December 1, 2023, vesting in the Company’s discretionary match and profit sharing contribution portions of their accounts were based on the following schedule and for merging plans, prior company contributions vested according to the provisions of the merging plan’s applicable plan document and not the following schedule:

Beginning December 1, 2023, participants are immediately vested in the Company’s discretionary match and profit sharing contributions portions of their accounts and for merging plans, prior company contributions will vest immediately upon merger.

Notes receivable from participants – Participants are permitted by the Plan to borrow funds up to 50% of their vested account balance or \$50,000, whichever is less. No notes are issued for less than \$1,000. Note transactions are treated as a transfer from the investment fund to the participant notes fund. Note terms range from one to five years, unless it is for the purchase of the participant’s principal residence in which case the note repayment period may not extend beyond 10 years from the date of the note. The notes are secured by the balance in the participant’s account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid through payroll deductions under a level amortization schedule. As of December 31, 2024, the rates of interest on outstanding loans ranged from 3.75% to 9.50% with various maturities through November 2033.

Payment of benefits – Distributions are made for separation in service upon retirement, death, disability, or termination of employment, equal to the value of the participant’s vested interest in his or her account. Participants who have not separated from service and have reached age 59½ can request distributions subject to certain restrictions. All distributions are made in lump sum amounts and recorded when paid.

Forfeited accounts – Forfeitures are the nonvested portion of a participant’s account that are lost upon termination of employment and are retained in the Plan. As of December 31, 2024, the forfeited nonvested accounts total was \$92,572. These accounts may be used to pay Plan expenses and reduce future employer contributions. In 2024, \$148,752 of forfeitures were used to reduce employer contributions and \$38,238 were used to reduce plan expenses. All remaining forfeitures were used in August 2025 to reduce employer contributions.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual method of accounting.

Use of estimates – The preparation of financial statements in conformity with GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment valuation – Investments are reported at fair value. The Plan’s Trustee, Fidelity Management Trust Company, certifies the fair market value of all investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the “exit price”) in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

Contributions – Contributions from participants and corresponding matching contributions are recorded in the year in which the employee contributions are withheld from compensation, or the related participant compensation is earned.

Notes receivable from participants – Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance, plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan agreement. No allowance for credit losses have been recorded as of December 31, 2024.

Expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Payment of benefits – Benefits are recorded when paid.

Subsequent events – Through the report date, the Plan has merged in several additional plan assets approximating \$18,831,725. The Plan administrator has evaluated subsequent events, through October 2, 2025, which is the date the financial statements were available to be issued.

Note 3 – Certified Investment Information

The Plan's administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's *Rules and Regulations for Reporting and Disclosure* under ERISA. Accordingly, Fidelity Management Trust Company, the Trustee of the Plan, has certified to the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, dividends, interest, and interest income from notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on the schedule of assets (held at end of year).

Note 4 – Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

Registered investment companies (mutual funds) and money market funds – Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

Self-directed brokerage accounts – Accounts primarily consist of mutual funds, money market funds, and common stocks that are valued on the basis of readily determinable market prices.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's investments in registered investment companies and self-directed brokerage accounts are classified as Level 1 under the fair value hierarchy at December 31, 2024 and 2023. There have been no changes in the techniques used at December 31, 2024 and 2023.

Note 5 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 6 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with the investment securities, that changes in the values of investments in the near term could materially affect a participant's account and the amounts reported in the statements of net assets available for benefits.

Note 7 – Party-in-Interest Transactions

The Plan paid expenses related to the Plan's operations and investment management to various service providers. Certain Plan investments are managed by the Trustee of the Plan. However, transactions with the Trustee qualify as exempt party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. In addition, during the year ended December 31, 2024, the Company paid audit and certain administrative custodial fees on behalf of the Plan.

Note 8 – Tax Status

The Plan document is a volume submitter defined contribution plan that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9 – Reconciliation to Form 5500

- conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about of U.S. Oral Surgery Management, LLC Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA.
- the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Note 1 – Description of the Plan

The following description of the U.S. Oral Surgery Management, LLC Retirement Plan (the Plan), provides only general information. Participants should refer to the Plan agreement, as amended, for a more complete description of the Plan's provisions.

General – The Plan, established on November 1, 1971, restated most recently March 27, 2020, is a defined contribution plan covering employees of U.S. Oral Surgery Management, LLC, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). U.S. Oral Surgery Management, LLC (the Company) is the Plan's Sponsor and serves as Plan administrator.

As a result of the Company's acquisitions during 2023 and 2024, 10 separate plans merged into the Plan during 2024. The merging plans transferred assets of \$12,160,584 into the Plan, included on the statement of changes in net assets available for benefits, for the year ending December 31, 2024.

Eligibility – Prior to January 1, 2024, employees of the Company were eligible to participate in the Plan upon reaching age 21 and after completing one month of service, except for those employees covered by a collective bargaining agreement, certain nonresident aliens, residents of Puerto Rico, and temporary or seasonal employees whose regularly scheduled service are less than 1,000 hours per year.

Effective January 1, 2024, the Plan amended the eligibility requirements reducing the age requirement to age 20 and allowing temporary and seasonal employees to participate if meeting all other requirements.

Participant contributions – Participants may make contributions to the Plan up to the lesser of 100% of compensation, as defined by the Plan document, or the maximum amount allowed by the statutes. Participants may also elect to make Roth contributions utilizing after-tax contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated fund until elected otherwise by the participant. Prior to October 1, 2024, deferrals were not subject to annual automatic increases.

Effective October 1, 2024, all automatically enrolled participants will be subject to an annual deferral rate increase of 1%, up to a maximum auto-deferral rate of 10%, applied on July 1st unless this occurs within the first six months of a participant's automatic enrollment.

Employer safe harbor contributions – The Company makes safe harbor non-elective employer contributions equal to 3% of the participant's eligible compensation for each of the Plan years ending December 31, 2024 and 2023.

Employer match and profit sharing contributions – The Company may elect to make a discretionary match to the Plan on behalf of eligible participants or a designated group of eligible participants equal to a uniform percentage of a participant's salary deferral. Additionally, the Company may make a discretionary profit sharing contribution to the Plan as determined annually by the Plan Sponsor. The Company made a profit sharing match of \$3,738,156, included in the employer contribution receivable on the statement of net assets available for benefits, for the year ending December 31, 2024.

Contributions are subject to regulatory limitations.

Participant accounts – Each participant’s account is credited with the participant’s contribution and an allocation of (a) the Company’s contribution, and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined in the Plan agreement. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan.

Vesting – Participants are immediately vested in their voluntary contributions and the Company’s safe harbor contributions, plus actual earnings thereon. Prior to December 1, 2023, vesting in the Company’s discretionary match and profit sharing contribution portions of their accounts were based on the following schedule and for merging plans, prior company contributions vested according to the provisions of the merging plan’s applicable plan document and not the following schedule:

Beginning December 1, 2023, participants are immediately vested in the Company’s discretionary match and profit sharing contributions portions of their accounts and for merging plans, prior company contributions will vest immediately upon merger.

Notes receivable from participants – Participants are permitted by the Plan to borrow funds up to 50% of their vested account balance or \$50,000, whichever is less. No notes are issued for less than \$1,000. Note transactions are treated as a transfer from the investment fund to the participant notes fund. Note terms range from one to five years, unless it is for the purchase of the participant’s principal residence in which case the note repayment period may not extend beyond 10 years from the date of the note. The notes are secured by the balance in the participant’s account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid through payroll deductions under a level amortization schedule. As of December 31, 2024, the rates of interest on outstanding loans ranged from 3.75% to 9.50% with various maturities through November 2033.

Payment of benefits – Distributions are made for separation in service upon retirement, death, disability, or termination of employment, equal to the value of the participant’s vested interest in his or her account. Participants who have not separated from service and have reached age 59½ can request distributions subject to certain restrictions. All distributions are made in lump sum amounts and recorded when paid.

Forfeited accounts – Forfeitures are the nonvested portion of a participant’s account that are lost upon termination of employment and are retained in the Plan. As of December 31, 2024, the forfeited nonvested accounts total was \$92,572. These accounts may be used to pay Plan expenses and reduce future employer contributions. In 2024, \$148,752 of forfeitures were used to reduce employer contributions and \$38,238 were used to reduce plan expenses. All remaining forfeitures were used in August 2025 to reduce employer contributions.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual method of accounting.

Use of estimates – The preparation of financial statements in conformity with GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment valuation – Investments are reported at fair value. The Plan’s Trustee, Fidelity Management Trust Company, certifies the fair market value of all investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the “exit price”) in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

Contributions – Contributions from participants and corresponding matching contributions are recorded in the year in which the employee contributions are withheld from compensation, or the related participant compensation is earned.

Notes receivable from participants – Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance, plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan agreement. No allowance for credit losses have been recorded as of December 31, 2024.

Expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Payment of benefits – Benefits are recorded when paid.

Subsequent events – Through the report date, the Plan has merged in several additional plan assets approximating \$18,831,725. The Plan administrator has evaluated subsequent events, through October 2, 2025, which is the date the financial statements were available to be issued.

Note 3 – Certified Investment Information

The Plan's administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's *Rules and Regulations for Reporting and Disclosure* under ERISA. Accordingly, Fidelity Management Trust Company, the Trustee of the Plan, has certified to the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, dividends, interest, and interest income from notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on the schedule of assets (held at end of year).

Note 4 – Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

Registered investment companies (mutual funds) and money market funds – Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

Self-directed brokerage accounts – Accounts primarily consist of mutual funds, money market funds, and common stocks that are valued on the basis of readily determinable market prices.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's investments in registered investment companies and self-directed brokerage accounts are classified as Level 1 under the fair value hierarchy at December 31, 2024 and 2023. There have been no changes in the techniques used at December 31, 2024 and 2023.

Note 5 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 6 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with the investment securities, that changes in the values of investments in the near term could materially affect a participant's account and the amounts reported in the statements of net assets available for benefits.

Note 7 – Party-in-Interest Transactions

The Plan paid expenses related to the Plan's operations and investment management to various service providers. Certain Plan investments are managed by the Trustee of the Plan. However, transactions with the Trustee qualify as exempt party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. In addition, during the year ended December 31, 2024, the Company paid audit and certain administrative custodial fees on behalf of the Plan.

Note 8 – Tax Status

The Plan document is a volume submitter defined contribution plan that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9 – Reconciliation to Form 5500
