## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator  
SphereCommerce LLC 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the accompanying financial statements of SphereCommerce LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). 1. DESCRIPTION OF THE PLAN

The following description of the SphereCommerce LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan documents for a more comprehensive description of the Plan's provisions.

General

The Plan is a defined contribution profit sharing plan covering all employees of Sphere Acquisition Co., LLC and its subsidiaries (the "Company" or "Employer"), excluding nonresident aliens, leased employees, and employees covered by a collectively bargained agreement. Originally established on March 1, 2012, the Plan was restated on January 24, 2024. The Plan is designed to comply with the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, as amended (ERISA), and the Internal Revenue Code (IRC).

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 (SECURE 2.0) was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within SECURE 2.0 vary through 2026. The Plan Sponsor has until the end of the first Plan year beginning on or after January 1, 2026, to amend the Plan for the changes related to SECURE 2.0. The Plan has not been formally amended to adopt these provisions as of the date the financial statements were available to be issued.

Plan administration

The Company is the administrator of the Plan and, as such, carries out the duties imposed by ERISA. The Company has delegated certain responsibilities for the operation and administration of the Plan. The Plan's investments are held by the trustee of the Plan, Empower Trust Company, LLC (the "Trustee"). Empower Annuity Insurance Company of America ("EAIC" or "Custodian") is the asset custodian of the Plan's guaranteed interest account. Trustee, Custodian and recordkeeping services are provided by the Trustee, or one of its affiliates. These entities are responsible for holding the Plan's investment assets, executing investment transactions, and maintaining participant account records.

Eligibility

Eligible employees who have completed 30 days of service, as defined, are eligible to participate in the Plan. Participants must complete 90 days of service, as defined, to be eligible to receive Employer contributions. Entry dates are the first day of the month upon meeting eligibility requirements.

Contributions

Participants may elect to contribute a portion of their compensation to the Plan, subject to calendar year contribution limits set forth by the IRC. Participant contributions may be made on a pre-tax basis or after tax as Roth contributions. Participants who have attained age 50 and older before the end of the Plan year are eligible to make catch up contributions which are also subject to IRC limits. Participants may also contribute amounts (rollovers) representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Employer makes a safe harbor matching contribution equal to: 100% of a participant's deferrals up to the first 3% of compensation, plus 50% of the amount of a participant's deferrals up to the next 2% of compensation. The Employer may make additional discretionary contributions at the option of the Employer's board of directors, allocated as a uniform percentage of the Plan compensation. The Employer did not make additional discretionary contributions in 2024. Contributions are subject to IRC limitations.

Participant accounts

Each participant's account is credited with the participant's contributions, Employer safe harbor matching contributions, allocations of discretionary contributions, if any, and investment earnings, and charged with an allocation of investment losses and fees designated by the Plan. Allocations are based on participant earnings or account balances, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions into various investment options offered by the Plan.

Vesting

Participants are vested immediately in their contributions, Employer safe harbor matching contributions and actual earnings or losses thereon.

Vesting in additional Employer discretionary contributions, if any, is based on years of service as follows:

Forfeitures

Forfeitures of terminated participants' non-vested account balances are used to pay Plan expenses or reduce Employer contributions. Forfeited accounts available for the Employer to pay Plan expenses or reduce future Employer contributions totaled \$2,567 and \$8,791, as of December 31, 2024 and 2023, respectively. The Plan used \$6,581 in forfeitures to pay Plan expenses during the year ended December 31, 2024.

Notes receivable from participants

The Plan allows participants to borrow not less than \$1,000 and up to the lesser of \$50,000 or 50% of their vested account balance. Loan terms are generally five years, although it may be up to thirty years for the purchase of a primary residence. The loans are collateralized by the balance in the participant's account and bear interest at a rate commensurate with prevailing local market rates for similar loans as determined by the plan administrator. Principal and interest are paid ratably through monthly payroll deductions. As of December 31, 2024, the rates of interest on outstanding notes ranged from 4.25% to 9.50%. Participants loans outstanding as of December 31, 2024, have various maturity dates through October 2054.

Payment of benefits

Upon termination of service due to death, disability, retirement, or termination of employment from the Company, a participant may elect to receive a lump-sum payment for the participant's vested interest in his or her account. Upon termination, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The cash out provision of the Plan allows the Plan, upon termination of employment, to distribute vested account balances of less than or equal to \$1,000 without the participant's consent as a lump-sum distribution. In the absence of a participant's election, vested account balances greater than \$1,000 but less than or equal to \$5,000 are distributed to an individual retirement account for the benefit of the participant. If the account balance is greater than \$5,000, the participant can consent to either a distribution paid in the form of a lump-sum cash payment, a direct rollover into another qualified plan, or delay the distribution until the participant is required by law to receive minimum required distributions, as described in the plan documents.

In-service withdrawals from a participant's vested balance are permitted for participants who are 59 1/2 or older while still employed by the Company. The Plan also allows for hardship withdrawals, as defined in the plan document, by the participant.

Administrative expenses

Administrative expenses are generally paid by the Company, but may, at the discretion of the plan administrator, be paid by the Plan. Transaction fees for certain participant-initiated activity are charged to the specific account of the participant initiating any such transaction. The Plan is not required to reimburse the Company for expenses paid on its behalf.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent liabilities. Actual results could differ from these estimates.

Risk and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefit and changes therein.

Investment valuation and income recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value represents the amount participants would receive under the terms of the contract (Note 5).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on sale on investments bought and sold as well as held during the year.

Contribution and contributions receivables

Contributions from participants are recorded based on the date the contributions or note repayments have been separated from a participant's pay by the Employer, which is the pay date. Discretionary and Employer matching contributions, if any, are recorded in the year earned to coincide with the year in which the Employer records the contributions in its general ledger. The Plan records receivables for contributions based upon contributions recorded in the Plan year but received by the Plan subsequent to year end. Rollover contributions from participants are recorded based on the date the contributions are received by the Trustee.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are recorded as deemed distributions based upon the terms of the plan document.

Payment of benefits

Benefit payments are recorded when paid.

Administrative expenses

Administrative expenses are recorded when incurred.

Subsequent events

The Plan has evaluated subsequent events through October 6, 2025, the date the financial statements were available for issuance. No subsequent events have occurred that would have a material impact on the presentation of the Plan's financial statements.

3. INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE AND CUSTODIAN (UNAUDITED)

The plan administrator, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of ERISA. Accordingly, the Trustee and Custodian, determined to be qualified institutions by the plan administrator, have certified to the completeness and accuracy of:

- Investments and notes receivable from participants as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants as shown in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments and notes receivable from participants reflected on the schedule of assets (held at end of year) as of December 31, 2024, ("supplemental schedule").

Accordingly, as requested by the Plan administrator, the Plan's independent auditor performed no audit procedures on the certified information other than to agree the certified information to the related information included in the Plan's financial statements and supplemental schedule.

4. FAIR VALUE MEASUREMENTS

Accounting standards establish a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability; or

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement of the assets or liabilities.

In instances where the determination of fair value measurement is based on inputs from the different levels of the fair value hierarchy, the level in the fair value hierarchy within which the entire fair value measurement falls is based on the lowest level input that is significant to the fair value measurement in its entirety.

Transfers between levels within the fair value hierarchy are recognized when there is a change in the investments within a level or a change in inputs used to value those investments.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts (PSAs)-the initial pricing input is the quoted price obtained for the underlying mutual fund which is then adjusted to apply the expense factor disclosed in the annuity contract. The formula-calculated unit value is then compared to an accounting-driven unit value the following morning. The accounting unit value is determined in a manner similar to a mutual fund NAV calculation: dividing the net assets by the number of units outstanding. Each investment account is invested exclusively in shares of a specific mutual fund or other investment entities as directed by the contract holder and/or the participant. PSAs are included in the fair value hierarchy table as level 2 investments.

The Plan's investment in a Guaranteed Interest Account (GIA) through a group annuity contract is valued at contract value and is not disclosed within the fair value hierarchy under U.S. GAAP.

As of December 31, 2024 and 2023, there were no restrictions on redemptions or unfunded commitments for any of the major classes of assets.

5. GUARANTEED INTEREST ACCOUNT

The Plan's investment in the GIA is unconditionally guaranteed by EAIC. Contributions made to the GIA are invested in the general account of EAIC. The contract is considered a fully benefit-responsive investment contract. The Plan's balance in the GIA at December 31, 2024 and 2023, is \$77,487 and \$151,880, respectively.

For investment contracts that are benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for plan benefits attributable to the guaranteed investment contract. These contracts are included in the financial statements at contract value, as reported by EAIC. Contract value represents accumulated cash contributions made under the contract, interest credited to the contract, less participant withdrawals and transfers. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk for the contract issuer or otherwise. The GIA investment contract provides a guarantee of principal, a minimum annual rate of interest of 3%, and the opportunity for additional interest in excess of the guaranteed rate. When declared, additional amounts remain in effect for the six-month period beginning December 1 and June 1. Additional interest is not guaranteed for future years. No interest rate was in excess of 3% in 2024.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the Plan's trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with EAIC or with participants are probable of occurring.

The contracts above do not permit the respective issuer to terminate the agreement prior to the scheduled maturity date.

6. TAX STATUS

The Plan adopted the Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA Plan (the "profit sharing plan") sponsored by the Trustee. The Internal Revenue Service has issued an opinion letter dated November 14, 2022, stating that the profit sharing plan is designed in accordance with the applicable sections of the IRC and is appropriate for use by employers for the benefit of their employees. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore, believes that the Plan is qualified and is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

7. PLAN TERMINATION

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, amounts allocated to a participants' account become fully vested.

8. PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS

ERISA defines A party-in-interest similarly to the definition of a related party under U.S. GAAP, except that ERISA's definition is broader and includes all entities and individuals that provide services to the Plan; however, these entities may not necessarily be related parties. Management did not identify any related parties to the Plan that were not also considered to be parties-in-interest. The Plan did not enter into any material related party transactions during the Plan year related to compensation arrangements, expense allowances, or similar items.

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, and an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain Plan investments are PSAs and a GIA managed by affiliates of the Trustee. Certain fees paid to the Trustee and others for investment management services are incorporated into the expense ratios of the Plan's individual funds and paid directly from fund earnings, thus impacting Plan earnings.

The Trustee retains as compensation, any interest on amounts earned while certain transactions are pending. This applies to both contributions and distributions. Earnings are at institutional money market rates.
