**Schedule SB, Part V - Actuarial Assumptions / Methods**

- a. Mortality: The 2024 Static Mortality Tables [with no projection for mortality improvement] were used for the period after retirement age. The optional combined tables for small plans were used, separately for male and female lives.
- b. Interest: Benefits were discounted by 4.75% [first segment rate] for payments expected from January 1, 2024 – December 31, 2028, by 4.96% [second segment rate] for payments expected from January 1, 2029 – December 31, 2043, and by 5.59% [third segment rate] for payments expected on or after January 1, 2044. For calculations under IRC Section 404(o)(2), the following segment rates applied: 4.37%, 4.96% and 4.95%.
- c. Salary Scale: It was assumed that salaries would increase by 4%. It was assumed that all employees would work under 1000 hours during 2024 prior to February 29, 2024 (benefit freeze date).
- d. Severance of Employment: No discount for severance of employment was included in the determination of costs and liabilities due to the small number of participants and lack of credible plan experience.
- e. Assumed Retirement Age: It was assumed that all employees would retire at their Normal Retirement Age, or in one year if at or past Normal Retirement Age. It was determined that the effect of alternative retirement rates would not be significant since there are no subsidized benefits payable prior to normal retirement.
- f. Disability Retirement: No discount for disability retirement was included in the determination of costs and liabilities due to the lack of any actuarially subsidized benefit or credible plan experience.
- g. Form of Benefit Payment: It was assumed that there would be a 100% probability of electing lump sum payments and a 0% probability of electing monthly annuity payments. This assumption has been based on historical plan experience.
- h. Actuarial Value of Asset Valuation Method: The fair market value of assets was used.
- i. Expenses: The Target Normal Cost was increased by \$-0- to reflect anticipated expenses to be paid from the plan in the current year. This was based upon actual expenses paid by the plan during the prior plan year.
- j. Actuarial Cost Method: The method prescribed by IRC Section 430 was used which determines a minimum required contribution equal to the sum of the plan's Target Normal Cost for the plan year, plus a Shortfall Amortization charge [if any] and Waiver Amortization charge [if any] of a prior funding deficiency.
- k. Interest Crediting Rate: Based on average applicable rate during the current and last 4 plan years [or since plan inception, if shorter], which was 2.90%. The prior year assumption, using the same methodology, was 2.64%.

**Schedule SB, Part V - Summary Plan Provisions**

- a. Eligibility: All employees are eligible for membership in the Plan as of the January 1 or July 1 following one year of service of at least 1,000 hours and attainment of age 21. However, non-owner veterinarians are excluded from the plan.
- b. Normal Retirement: The later of age 65 or the 5th anniversary of the date of Plan Participation.
- c. Considered Compensation: Internal Revenue Code Section 415 Safe Harbor Compensation earned while a participant.
- d. Cash Balance Benefits: Benefit accruals were frozen effective 02-29-2024. Below were the benefits prior to the freeze. The value of a Participant's Cash Balance Account shall be determined by crediting the account each year with a Principal Credit and Interest Credit as follows:
  - Principal Credits: per plan provisions.
  - Interest Credit: Average 30 Year Treasury Rate as of the November preceding the Plan Year.
  - The Principal Credit is credited at the end of the Plan Year to eligible participants who have at least 1,000 hours of service during the Plan Year. The current value of the Cash Balance Account shall be the sum of all Principal Credits and Interest Credits as of such determination date.
- e. Standard Retirement Benefit: Value of Cash Balance Account.
- f. Death Benefits: Full value of Cash Balance Account.
- g. Severance Benefits: 0% vested after 1 year of service, 0% vested after 2 years of service, 100% vested after 3 years of service. Years of service are defined as Plan Years in which participant is credited with 1,000+ hours of service.
- h. Timing of Benefit Payments: As soon as administratively feasible following termination of employment.
- i. Disability Benefits: Full value of the Cash Balance Account.
- j. Optional Forms of Benefits: Life annuities with and without guaranteed periods, joint & survivor annuities with spousal survivor benefits equal to 50%, 75% or 100% of the amount payable to the participant and lump sum.
- k. Actuarial Equivalence: Applicable Mortality Table for the period after retirement and the 30-year Treasury rate for the November preceding year of determination.
- l. Top Heavy: Top heavy minimum benefits will be provided under The Marsh Hospital for Animals 401k Savings Plan.
