## INDEPENDENT AUDITORS' REPORT

To The Board of Trustees  
Cleveland Tile Layers Industry Pension Fund

### **Opinion**

We have audited the accompanying financial statements of Cleveland Tile Layers Industry Pension Fund, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of Cleveland Tile Layers Industry Pension Fund as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA.

In our opinion, the information in the accompanying schedules is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**Note 1 – Description of Plan:**

The following brief description of the Cleveland Tile Layers Industry Pension Plan provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General:

The Plan is a multi-employer defined contribution retirement plan. The Plan was established in 1974 under an agreement between the Cleveland Tile Layers Union Local 36, AFL-CIO and participating employers to provide retirement benefits for the members of the local union. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is funded by (a) investment income, and (b) employer contributions based on collective bargaining agreements for each hour worked. The Plan is administered by a Board of Trustees consisting of two representatives from the Union and two representatives from contributing employers, in accordance with the trust agreement.

Participant Accounts:

Each participant account is credited with the contributions made on his or her behalf and allocations of investment earnings or losses and administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting:

Each participant is fully vested in all contributions and investment income earned thereon.

Investment Options:

Participants select the investments funds to which their contributions are allocated. If a participant does not select an investment option, his or her contribution is credited to a default fund, Principal SAM Conservative Balanced Portfolio, as selected by the Trustees. Participants may transfer amounts between funds, subject to certain limitations. The Plan currently offers several mutual funds as investment options for participants.

Payment of Benefits:

On termination of service due to death, disability or retirement, a participant may elect to receive the account balance in a lump sum, or in monthly installments for a period certain, or in monthly installments for the lifetime of the recipient with a continuation of monthly benefits to the surviving spouse. Amounts due participants or beneficiaries at any time are limited in total to the net assets of the plan.

Termination:

Although it has not expressed intent to do so, the Board of Trustees has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, the assets in the Plan will be used for benefit payments and administrative expenses until the assets are fully expended.

**Note 2 - Summary of Significant Accounting Policies:**

*Basis of Accounting.* The accompanying financial statements are prepared on the accrual basis of accounting.

*Use of Estimates.* The preparation of financial statements in conformity with generally accepted accounting principles requires the trustees to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, disclosure of contingent assets and liabilities, and the actuarial present value of accumulated plan benefits at the date of the financial statements. Actual results could differ from those estimates. This difference may be material.

**Note 2 - Summary of Significant Accounting Policies (Continued):**

*Investment Valuation and Revenue Recognition.* Investments of the Plan are reported at fair value, with the exception of the guaranteed investment contract. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between the Plan's valuation policies utilizing information provided by its investment advisors. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains (losses) on the investments purchased and sold, as well as held, during the year.

*Payment of Benefits.* Benefit payments to participants are recorded upon distribution.

**Note 3 – Fully Benefit-Responsive Investment Contracts:**

The Plan holds a traditional fully benefit-responsive investment contract, for which contributions are maintained in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and interest at the specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer that is subject to a minimum interest rate. The crediting rate is reviewed on the annual basis for resetting. The Contract cannot be terminated before the scheduled maturity date. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value.

The Stable Value Fund investment objective is to maintain stability of principal through underlying assets which maintain an average S&P credit quality. Participant transactions (purchase and sales) may occur daily. All other withdrawals of assets may be delayed for up to twelve months at the sole discretion of the trustee.

As of December 31, 2024 and 2023, the contract value of the fully benefit-responsive investment contract was \$7,582 and \$7,443.

**Note 4 – Fair Value Measurements:**

*Fair Value Hierarchy*

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology are observable inputs, other than Level 1 prices, such as quoted prices for similar assets or liabilities in active markets, quoted prices in markets that were not sufficiently active to qualify as Level 1, other observable inputs, or inputs that can be corroborated by observable market data for substantially the full term of the assets or liabilities. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are significant to the fair value measurement and unobservable (for example, supported by little or no market activity).

**Note 4 – Fair Value Measurements (Continued)**

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023:

- Registered Investment Companies – Investments in registered investment companies are stated at the respective fund’s net asset value (NAV), which is determined based on quoted market prices on the last business day of the Plan year. The NAV is a quoted price on an active market.
- Common/Collective Trust – Stated at fair value as determined by the issuers of the common/collective trust based on the net asset value (NAV) of the underlying investments. The NAV as provided by Principal Life Insurance Company is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the funds less its liabilities. This practical expedient is not used when it is determined to be probable that the funds will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

The Plan obtained its latest determination letter in 2015 in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of Internal Revenue Code. The plan has been amended since receiving the determination letter. Plan management and plan's tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2017.

**Note 6 – Related Party Transactions:**

The plan shares office space and administrative services with the North Shore Chapter of the Bricklayers and Allied Craftworkers Local 23(Local 23), formally known as Tile Layers Union Local 36. The Plan paid rent in the amount of \$7,200 and \$7,200 for 2024 and 2023, respectively. The Plan incurred administrative secretarial services in the amount of approximately \$12,817 and \$24,723 for 2024 and 2023, respectively. The Plan owes Local 23 \$1,639 at December 31, 2024, and was owed \$26,339 from Local 23 at December 31, 2023.

**Note 7 – Risks and Uncertainties:**

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonable possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

**Note 8 – Plan Termination:**

Under certain conditions, the plan may be terminated. Upon termination, the assets then remaining should be subject to the applicable provisions of the plan then in effect and should be used until exhausted to pay benefits to employees in the order of their entitlement.

**Note 9 – Delinquent Contributions:**

During 2022, the Plan failed to remit to the Plan’s custodian certain employer contributions in the amount of \$96,997, within the period prescribed by Department of Labor’s regulations. Delays in remitting employer contributions to the custodian were due to administrative errors. The affected participants’ accounts were compensated for lost income in the amount approximating \$14,867 by Local 23 on August 25, 2025.

**Note 10 – Subsequent Events:**

The Plan evaluated subsequent events through September 18, 2025, the date the financial statements were available to be issued. Other than the payment of loss of earnings mentioned in Note 9, there were no subsequent events that required recognition or additional disclosure in these financial statements.
