### Note 1: Description of Plan

The following description of the Caribou Coffee Company, Inc. and Subsidiaries 401(k) Plan (the "Plan"), provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan was established as a defined-contribution plan covering all eligible employees of companies controlled by the Caribou Coffee Company, (the "Company"). The following brief description of the Plan is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Board of Trustees is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Trustees.

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. The Plan has adopted the required minimum distribution at age 73 effective January 1, 2023, and is in the process of evaluating other voluntary provisions. The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

#### Eligibility

Eligible employees include all regular employees of the Plan over the age of 21, who are not covered under a collective bargaining agreement, and have completed 3 months of service. Employees are eligible to participate in the Plan on the first day of the month subsequent to satisfying the eligibility requirements.

#### Contributions

Each year, participants may make voluntary contributions on a pretax basis, not to exceed the annual limit established by the Internal Revenue Service. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan can make discretionary matching contributions. The discretionary dollar amount is determined by the Company on a uniform basis for all participants. Company discretionary matching contributions are allocated according to participant investment elections. The Plan allows for discretionary matching contributions equal to 25% of the first 5% of base compensation that a participant contributes to the Plan. During the year ended December 31, 2024, the Company made discretionary matching contributions of \$608,431. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### **Contributions** (Continued)

The Company can also contribute a discretionary profit sharing contribution to the Plan as determined annually by the Company's Board of Directors. The discretionary profit sharing contribution is to be allocated among participants eligible to share in the contribution for the Plan year in the same proportion that each participant's gross compensation for the year bears to the total compensation of all participants for such year. Company profit sharing contributions are allocated according to participant investment elections. The Company did not make discretionary profit sharing contributions for the year ended December 31, 2024.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, Plan discretionary matching contributions, allocations of the Company's discretionary profit sharing contribution and administrative expenses, and plan earnings and losses. Allocation of plan earnings and losses is based on participant account balances as defined by the Plan. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are vested immediately in their voluntary contributions plus actual earnings thereon. Vesting in the Plan's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants vest at a rate of 25% per year beginning with the first year of service. Participants become fully vested after four years of service. A participant is also fully vested upon reaching age 65, upon death, or upon permanent disability.

#### **Forfeitures**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$32,242 and \$12,172, respectively. These accounts are used to reduce future Plan contributions or to pay administrative expenses of the Plan in accordance with the plan document. During 2024, the Plan did not use forfeited nonvested accounts to reduce administrative expenses or fund Company contributions.

#### **Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments if the account balance is greater than \$7,000. If the participant's vested account balance does not exceed \$7,000, it can be distributed only in a single lump-sum payment. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Under these circumstances, if the vested account balance is less than \$7,000, the balance of the vested account is distributed in full to the participant regardless of the participant's consent. In addition, hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2.

#### **Notes Receivable From Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest are paid ratably through payroll deductions.

#### **Administrative Expenses**

The Plan's administrative expenses are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain administrative functions are performed by employees of the Company at no charge to the Plan. Trustee and record keeping expenses charged in 2024 were paid by the Plan and are allocated proportionately to plan participants based on their respective account balances. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

#### **Plan Termination**

Although it has not expressed intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants become 100% vested in their Company contributions.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### **Use of Estimates in Preparation of Financial Statements**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains or losses on investments bought and sold as well as held during the year.

#### Payment of Benefits

Benefits are recorded when paid.

#### Subsequent Events

The Plan has evaluated subsequent events through September 30, 2025, which is the date the financial statements were available to be issued.

### Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Stable value fund:* the stable value fund is composed primarily of fully benefit-responsive investment contracts that are valued at NAV of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. There are no unfunded commitments. Participant transactions may occur daily. The redemption notice period is 30 days.

The following tables set forth by level, within the fair value hierarchy, the Plan's investment assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

### Note 4: Information Prepared and Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by The Standard Insurance Company, formerly known as Minnesota Life Insurance Company, the trustee of the Plan.

### Note 5: Tax Status

The Plan adopted a non-standardized pre-approved plan document with an IRS notification letter, which states the non-standardized pre-approved plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **Note 6: Related-Party Transactions and Party-in-Interest Transactions**

The Standard Insurance Company is the trustee, as defined by the Plan and, therefore, transactions with The Standard Insurance Company qualify as party-in-interest transactions. In 2024, trustee costs of \$105,365 were paid by the Plan to The Standard Insurance Company. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing rather than a direct payment.

### **Note 7: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
