Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements

We have performed an audit of the financial statements of The Mundy Companies Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years ended, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

1. Summary of Significant Accounting Policies

A summary of the major accounting policies followed by The Mundy Companies ("Companies") Retirement Savings Plan ("Plan") in the preparation of the accompanying financial statements is presented below:

The plan's investments are stated at fair market value as determined by Bank of America Merrill Lynch. Quoted market prices have been used. Purchases and sales of securities are recorded on a trade-date basis.

Interest income is accounted for on the accrual basis.

The Retirement Savings Plan is qualified under Section 401(a) of the Internal Revenue Code and is exempt from Federal Income Taxes under 501(a) of the Internal Revenue Code.

The Internal Revenue Service has determined and informed the Company by a letter dated October 13, 2017, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code.

The presentation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

2. Cash and Investments

The Plan's investments are held by a bank-administered trust fund and are composed of a money market fund and mutual fund.

4. Description of Plan

The following description of The Retirement Savings Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

GENERAL

The Plan is a defined contribution plan covering all full-time employees of the company who have sixty days of service and are age twenty-one or older. It is subject to the provisions of the Employee Retirement Security Act (ERISA).

CONTRIBUTIONS

Each year, the Company may make a discretionary contribution to the Plan in an amount determined by the Company's Board of Directors and reflected in an appropriate resolution adopted by the Directors. Participants may contribute from 1% to 15% of their gross income, subject to the annual IRS dollar limitations.

PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's contribution, (b) Plan earnings, and (c) forfeitures of terminated participant's nonvested accounts as determined by the plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

VESTING

Participants are immediately vested 100% upon entering the Plan.

FORFEITURES

Since a participant is 100% vested in the plan there are no current forfeitures. A balance of \$97 does remain in the Forfeiture account related to prior years when participants were not 100% vested until completing six years of service.

4. Description of Plan (Continued)

PAYMENT OF BENEFITS

On termination of service, a participant may elect to receive either a lump-sum amount equal to the value of his or her account, or annual installments as approved by the administrative committee.

A participant may at any time file with the Committee an appropriate written request for a hardship withdrawal of an amount from his Pre-Tax Contribution Account.

Each participant who has attained or will attain age 65 before the close of the Plan Year may elect, in the form and in the manner prescribed from time to time by the Committee on a uniform and non-discriminatory basis (but in no event more frequently than once per Plan Year), to withdraw the entire amount or any portion thereof from his Pre-Tax Contribution Account, Employer Contribution Account, and/or Rollover Account. All amounts distributed shall be paid in a lump sum payment in cash.

ADMINISTRATIVE CHARGES

All administrative expenses of the Plan, except amounts paid for certain investments, advisory services and bank charges, are paid by participants.

5. Continuation of Plan

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

6. Participant Directed Investments

Investments held by the Plan represent participant-directed accounts. That is, individual participants decide how funds held in trust for them are allocated among various investments. As of December 31, 2024 and 2023, all investments were held in the following types of participant-directed accounts:

- Money Market Fund

- Mutual Funds

7. Party-in-Interest Transactions

Plan investments are money market accounts and mutual funds managed by Bank of America Merrill Lynch, an entity that is a party-in-interest with respect to the Plan. These transactions are exempt and covered by the Prohibited Transaction Exemption provisions of ERISA and the Code.

7. Party-in-Interest Transactions (Continued)

The Company provides certain accounting, administrative, and investment management services to the Plan for which no fees are charged. Auditing fees paid by the Company on behalf of the Plan were \$14,004 and \$14,440 for the years ended December 31, 2024 and 2023.

8. Information Certified by the Trustee (Unaudited)

As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, information prepared and certified by a bank or insurance company, which is regulated, supervised and subject to periodic examination by a state or federal agency, need not be audited. The plan administrator has obtained certifications from the Bank of America, N.A. (custodian) that all information provided by them is complete and accurate. Information included in the accompanying financial statements and notes to financial statements as to investments, net appreciation (depreciation) in fair value of investments, interest income and all information in the Supplemental Schedule H, line 4i, Schedule of Assets (held at year end), is presented solely upon reliance on those certifications. The independent auditors did not perform auditing procedures with respect to this information except for comparing such information to the related information in the financial statements, notes to financial statements, and supplemental schedule.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

10. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No Level 2 or 3 inputs were available to the Plan.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end.

11. Subsequent Events

The Company has evaluated subsequent events for potential recognition and disclosure through September 22, 2025, the date of financial statement issuance.

12. Contingent Assets/Liabilities

Several participants received shortage pay during the plan year that did not include a 401k deduction. The Plan Sponsor notified the custodian of the plan (Bank of America) in order to make any necessary correcting contributions into the plan. The corrective contributions were determined and funded in 2025. The amount of the corrective contribution was \$749 plus the earnings attributal to that amount.
