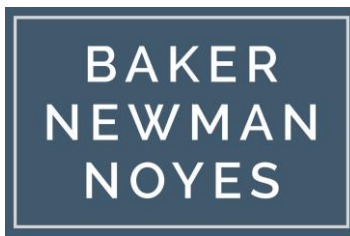

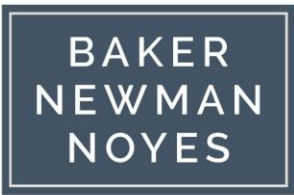

## INDEPENDENT AUDITORS' REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Prima CARE, P.C. Profit Sharing Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### 1. Description of Plan

The following description of the Prima CARE, P.C. Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering eligible employees of Prima CARE, P.C. (the Company) which was established in 1996. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

The Plan has engaged EPIC Advisors, Inc. (EPIC) to be its recordkeeper and third-party administrator. The investment custodian of the Plan is Matrix Trust Company (a d/b/a of MG Trust Company).

On December 29, 2022, the *Setting Every Community Up for Retirement Enhancement Act of 2022* (SECURE Act 2.0) was signed into law. It includes mandatory and optional provisions impacting defined contribution plans. Applicable provisions outlined in the SECURE Act 2.0 will be adopted if elected and/or required. Plan amendments for these changes are not yet required.

#### Eligibility

Employees who have reached the age of twenty-one and have completed at least ninety days of service are eligible to participate in the Plan on the first day of the month coinciding with or next following satisfaction of the age and service requirements.

#### Contributions

Participants may voluntarily contribute a portion of their compensation subject to Internal Revenue Service (IRS) limits on a pre-tax or Roth basis. The Plan includes an auto-enrollment and auto-escalate feature where employees will be enrolled at 6% and this rate will increase by 1% each year until it reaches 12% unless otherwise elected by the employee.

The Company makes safe harbor contributions in the amount of 3% of an eligible participants' compensation. In addition, the Company may also make employer discretionary matching and employer discretionary profit-sharing contributions. An employee must work at least 1,000 hours during the Plan year to receive employer discretionary matching contributions. An employee must work at least 1,000 hours during the Plan year and be active on the last day of the year to receive employer discretionary profit-sharing contributions. No employer discretionary contributions were made in 2024 or 2023.

Participants may elect to rollover distributions from other qualified plans.

#### Participant Accounts

Each participant's account is credited with an allocation of contributions and Plan earnings. Administrative fees are allocated and charged against each participant's account. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct their contributions to be invested in any of the investment options offered by the Plan.

### 1. Description of Plan (Continued)

#### Vesting

Participants are immediately vested in their voluntary contributions, the employer safe harbor contributions, and rollover amounts, plus actual earnings or losses thereon. The vesting for employer discretionary contributions is based on years of continuous service. A participant is 100% vested after six years of service.

#### Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

#### Notes Receivable From Participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Participants are allowed to have two outstanding notes from the Plan at any time. Note terms generally range from 1 to 5 years. The notes are secured by the balance in the participant's account and bear interest at a rate of Prime plus 1%. Principal and interest are paid ratably through payroll deductions. Interest rates range from 4.25% to 9.50% at December 31, 2024 with various maturities through 2029.

#### Forfeitures

Forfeitures of amounts attributable to the nonvested portion of a participant's account can be used to offset administrative expenses of the Plan or to reduce future employer contributions. At December 31, 2024 and 2023, forfeited amounts included in net assets available for benefits totaled \$75,426 and \$59,064, respectively. There were no forfeitures used during 2024 and 2023.

#### Distribution of Benefits

On termination of service due to death, disability, retirement, or any other reason, a participant may elect to receive a distribution in a single lump-sum. In addition, participants who have attained the age of 59 1/2 may elect to withdraw all or part of their vested balance from the Plan without penalty. The Plan also allows automatic mandatory distributions to an individual retirement account for inactive participants with vested account balances of \$1,000 or less. The Plan also provides for automatic rollover distributions to an individual retirement account for inactive participants with vested balances greater than \$1,000 and less than \$5,000. Additionally, the Plan allows hardship distributions from employee deferral sources when certain requirements are met.

Included in the SECURE Act 2.0 provisions was a required change to the age at which required minimum distributions must commence from 72 to 73 for individuals who attain age 72 on or after January 1, 2023, and from 73 to 75 for individuals who attain age 73 on or after January 1, 2033.

#### Administrative Expenses

The Plan pays substantially all administrative expenses. To the extent expenses are not paid by the Plan, they are paid by the Company.

### 2. Summary of Significant Accounting Policies

#### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

#### Risks and Uncertainties

The Plan provides for various investment options which in turn invest in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### Investments

The Plan's investments are reported at fair value. See note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes realized gains and losses on investments that were both bought and sold during the year, as well as unrealized appreciation on investments held at year end.

#### Notes Receivable From Participants

Notes receivable from participants are measured at the notes' unpaid principal balance plus accrued but unpaid interest. Defaulted notes receivable are reclassified as a distribution in accordance with the terms of the Plan documents.

#### Payment of Benefits

Benefits are recorded when paid.

#### *Contributions*

Contributions are recorded in the period in which payroll deductions are made. Safe harbor employer contributions are recorded when the related compensation becomes payable. Employer discretionary contributions, if any, are recorded in the year for which the related employee service was performed.

#### *Subsequent Events*

Events occurring after the statements of assets available for benefits date are evaluated by management to determine whether such events should be recognized or disclosed in the financial statements. Management has evaluated subsequent events through October 1, 2025, which is the date the financial statements were available to be issued.

### 3. **Information Certified by the Custodian**

The Plan Administrator has elected the method of compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the United States Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's auditors not to perform any auditing procedures with respect to the information certified by Matrix Trust Company, the custodian, as of and for the years ended December 31, 2024 and 2023, except for comparing such certified information to information included in the Plan's financial statements and supplemental schedule. The Plan Administrator has determined that the custodian meets the requirements of a qualified institution as defined by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The Plan Administrator has obtained certifications from the custodian stating that the information provided to the Plan Administrator by the custodian is complete and accurate. Such information includes noninterest bearing cash, investments, investment income, including interest and dividends and net appreciation in fair value of investments, and investment transactions. Notes receivable from participants and the related income were subject to audit procedures under auditing standards generally accepted in the United States of America.

### 4. **Fair Value Measurements**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. In determining fair value, the Plan uses various methods including market, income and cost approaches. Based on these approaches, the Plan often utilizes certain assumptions that market participants would use in pricing the asset or liability, including assumptions about risk and or the risks inherent in the inputs to the valuation technique. These inputs can be readily observable, market corroborated, or generally unobservable inputs. The Plan utilizes valuation techniques that maximize the use of observable inputs and minimize the use of unobservable inputs. Based on the observability of the inputs used in the valuation techniques, the Plan is required to provide the following information according to the fair value hierarchy based on the lowest level of any input that is significant to the fair value measurement. The fair value hierarchy ranks the quality and reliability of the information used to determine fair values. Financial assets and liabilities carried at fair value will be classified and disclosed in one of the following three categories:

Level 1 – Valuations based on quoted prices in active markets for identical assets or liabilities. Valuations are obtained from readily available pricing sources for market transactions involving assets or liabilities.

Level 2 – Valuations for assets and liabilities traded in less active dealer or broker markets. Valuations are obtained from third party pricing services for identical or similar assets or liabilities.

Level 3 – Valuations for assets and liabilities that are derived from other valuation methodologies, including option pricing models, discounted cash flow models and similar techniques, and not based on market exchange, dealer, or broker traded transactions. Level 3 valuations incorporate certain assumptions and projections in determining the fair value assigned to such assets or liabilities. All assets and liabilities for which the fair value measurement is based on significant unobservable inputs are classified as Level 3.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Tax Status

The Plan has adopted a preapproved plan document sponsored by EPIC for which the IRS issued a favorable opinion letter dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan has subsequently been amended. The Plan Administrator believes that the Plan is designed, and is being operated, in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. Management evaluated the Plan's tax positions and concluded that the Plan has maintained its tax exempt status and has taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements.

### 6. Party-in-Interest Transactions

The Plan pays administrative fees to EPIC, the Plan's recordkeeper and third-party administrator, and investment advisor fees to Plimoth Investment Advisors (Plimoth). Such fees amounted to \$369,761 and \$350,292 in 2024 and 2023, respectively. Transactions with EPIC and Plimoth qualify as party-in-interest transactions. In addition, notes receivable from participants qualify as party-in-interest.

### 7. Reconciliation of Financial Statements to Form 5500

Participant notes receivable are reflected as investments in the Form 5500 as of December 31, 2024 and 2023 and the related interest income is shown as investment income on the Form 5500 for the years ended December 31, 2024 and 2023.
