We have performed audits of the financial statements of Allied Digestive Health 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Notes to Financial Statements

### **NOTE 1 – DESCRIPTION OF THE PLAN**

The following description of the Allied Digestive Health 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### **General**

The Plan, established on January 1, 2015, is a participant-directed defined contribution plan covering all eligible employees of Allied Digestive Health, LLC (collectively referred to as the “Company,” “Employer,” or “Plan Sponsor”) who have completed four months of employment and have reached 21 years of age, except for members of a collective bargaining agreement, non-resident aliens and leased employees. The Plan provides certain benefits in the event of death, disability, or other termination of employment. Assets of the Plan are held by a trust established under the Plan with Empower Annuity Insurance Company of America and its subsidiaries including, Empower Retirement LLC (“Empower” or the “Trustee”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

#### **Plan Administration**

The Company is the administrator of the Plan and as such, carries out the duties imposed by ERISA. The Company has appointed the Administrative Committee to oversee the operation and administration of the Plan. The Trustee serves as the Plan’s directed trustee and asset custodian and an affiliate of Empower provides record-keeping services and manages participant accounts and participant related transactions.

#### **Contributions**

Each year, participants may contribute to the Plan up to 92% of compensation on a pre-tax and after-tax basis, with dollar limits established by the Internal Revenue Code (“IRC”). Such contributions are excluded from the participant’s Federal taxable income until received as a withdrawal or distribution from the Plan. Participants may contribute amounts representing distributions from other qualified plans (rollovers). Participants may also elect to make Roth contributions, on an “after tax” basis to the Plan. Contributions are subject to certain limitations. During 2024 the maximum annual 401(k) pre-tax contribution limit was \$23,000, and the maximum annual catch-up contribution for participants aged 50 and older was \$7,500.

The Plan provides for an employer match contribution for all eligible participants with a minimum of 4 months of service and have attained age 21. For the year ended December 31, 2024, the Company matched 3% of an eligible employee’s compensation for a total safe harbor contribution of \$2,863,631. Additionally, for the year ended December 31, 2024, the Company established a discretionary employer profit share match for a total discretionary contribution of \$4,936,438 for all eligible participants with a minimum of 1 year of service. The Plan’s total of all employer contributions was \$7,800,079 for the year ended December 31, 2024.

#### **Participant Accounts**

Each participant’s account is credited with the participant’s elective deferral contributions, rollover contributions, the Company’s safe harbor nonelective contribution, as well as allocations of the Company’s discretionary matching and nonelective profit sharing contributions, the Plan’s investments earnings/(losses), net of investment expenses, and charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### Vesting

Participants are immediately vested in their contributions, rollovers, and safe harbor contributions plus actual earnings thereon.

Vesting in matching and profit sharing contributions plus actual earnings thereon is based on years of continuous service. A participant is 100% vested in matching and profit sharing contributions and earnings thereon after six years of credited service.

#### Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their contribution investment options daily and may transfer part or all of past investments to other investment options daily. Participants may also elect to change their percentage on a daily basis.

#### Self-directed Brokerage Accounts

Participants can choose to invest a portion of their accounts in investments included in the Plan's fund lineup with the Trustees. Self-directed brokerage accounts are segregated accounts within the trust fund and are treated for investment purposes as an investment of the account of the participant who has the self-directed brokerage account. The self-directed brokerage accounts are certified by the Trustee.

#### Notes Receivable from Participants

Participants may borrow from their vested fund account balance a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested interest of the participant in the Plan. A participant may have no more than one loan outstanding at any time. All loans are required to be repaid within five (5) years from the date of the loan or up to thirty (30) years for the purchase of a principal residence. The loans are secured by the balance in the participant's account and, unless otherwise determined by the Plan Administrator, bear interest at a fixed rate using the prevailing prime rate (7.50% and 8.50% at December 31, 2024 and 2023, respectively) plus 1% that is set at the date of the loan. Principal and interest is paid ratably through bi-weekly payroll deductions. Loans mature at various dates through December 2029 with interest rates ranging from 3.25% to 9.50%.

#### Hardship and In-Service Withdrawals

The Plan Administrator may authorize a lump-sum distribution of up to 100% of the participant's vested account balance but not to exceed the amount necessary to meet the financial need created by the hardship provided the participant submits positive evidence of an immediate and heavy financial need as defined in the Plan. In-service distributions of the participant's vested interest are available for any reason upon attaining age 59½.

#### **Deemed Distributions**

When a participant fails to make loan repayments under the terms of the loan agreement, the loan is considered to be in default. Deemed distributions on defaulted loans are recorded in the calendar quarter following the calendar quarter during which the loan was defaulted. There were deemed distributions of \$46,776 during the year ended December 31, 2024.

#### **Benefit Payments**

Upon termination of service due to death, disability or retirement, as defined in the Plan, participants are entitled to a fully vested lump sum payment of their account balance. For termination of service due to other reasons, participants are entitled to the value of the vested interest in their account as a lump-sum distribution. As of December 31, 2024 and 2023, all employees who elected to withdraw from the Plan had been paid.

#### **Forfeited Accounts**

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account, as defined by the Plan, represents a forfeiture. However, if the participant is re-employed and fulfills certain requirements as defined by the Plan, the participant's account will be reinstated. Unused forfeitures may be used to reduce administrative costs of the Plan. Any remaining amounts may then be used to reduce future employer profit-sharing contributions. During 2024, there were no forfeitures used to reduce the employer contributions.

#### **Expenses of the Plan**

Administrative functions are performed by the officers or employees of the Employer. No such officer or employee received compensation from the Plan. Certain plan expenses are deducted from participant accounts, and the remainder of the Plan expenses are generally paid by the Employer.

### **NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### **Basis of Accounting**

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

#### **Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

#### **Investment Valuation and Income Recognition**

All Plan investments are held by the Trustee. The Plan's investments are reported at fair value except for the guaranteed investment contract ("GIC"). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are reflected on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The Plan presents, in the Statement of Changes in Net Assets Available for Benefits, the net depreciation in the fair value of its investments, which consists of the realized gains or losses and the unrealized depreciation on those investments. Management fees and operating expenses charged to the Plan for investments in the self-directed brokerage accounts are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as components of net appreciation or decline in fair market value of investments for such investments.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

#### **Subsequent Events**

The Plan has evaluated subsequent events for recognition or disclosure through the date these financial statements were available for issuance, October 2, 2025.

### **NOTE 3 – INVESTMENT CONTRACTS WITH INSURANCE COMPANY**

The Plan maintains one GIC named the fixed account investment option. The contract underlying this investment options is considered to be fully benefit responsive in accordance with Accounting Standards Codification ("ASC") Topic 962. As of December 31, 2024 and 2023, the contract value of the investment was \$1,324,132 and \$719,781, respectively, which approximates fair value.

The trustees' determination of credited interest rates reflects a number of factors, including mortality and expense risks, interest rate guarantees, the investment income earned on invested assets and the amortization of any capital gains and/or losses realized on the sale of invested assets. The declared interest rate was 2.80% as of December 31, 2024, and 1.65% as of December 31, 2023. A market value adjustment may apply to amounts withdrawn at the request of the contract holder.

The underlying contracts have no restrictions on the use of Plan assets and there are no valuation reserves recorded to adjust contract amounts.

Because the GIC is fully benefit-responsive, contract value is the relevant measurement for that portion of the net assets available for benefits attributable to both investments. Contract value as reported by the trustees represent participant contributions made under the contract, plus credited interest earnings, less participant withdrawals and administrative expenses. Contract value also includes the effects of market value adjustments required in the event of a full or partial plan or contract termination.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete termination or merger with another plan), (2) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

### **NOTE 4 – INFORMATION CERTIFIED BY THE TRUSTEE**

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower, the Trustee of the Plan, has certified to the completeness and accuracy of the:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net appreciation in the fair value of the investments, interest and dividends, and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024; and
- Investments reflected on the schedule of assets (held at end of year) as of December 31, 2024.

### **NOTE 5 – FAIR VALUE MEASUREMENTS**

The Financial Accounting Standards Board ("FASB") established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the quoted market prices of share or units held by the Plan. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-directed brokerage accounts:* Valued at the daily closing price as reported by the fund. All of the mutual funds are open-ended and are registered with the Securities and Exchange Commission. These mutual funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and categorized as Level 1.

*Pooled separate accounts:* Valued at quoted market prices which represent the NAV of shares or unites held by the Plan.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **NOTE 6 – EXEMPT PARTY-IN-INTEREST**

At December 31, 2024, certain Plan investments were managed by Empower, the Trustee of the Plan, and therefore, these transactions qualify as party-in-interest transactions. Administrative fees paid by the Plan to the Trustee totaled \$158,947 for the year ended December 31, 2024. Notes receivable from participants also qualify as party-in-interest transactions.

### **NOTE 7 – PLAN TERMINATION**

Although it has not expressed any intention to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their account.

### **NOTE 8 – TAX STATUS**

The Company adopted a Non-Standardized Pre-Approved Profit-Sharing Plan with a Cash or Deferred Arrangement (“CODA”) sponsored by Ascensus LLC. The Internal Revenue Service (“IRS”) has issued a favorable opinion letter dated June 30, 2020, on the prototype plan that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator does not believe there are any uncertain tax positions.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### **NOTE 9 – PROHIBITED TRANSACTIONS**

The DOL considers late deposits to be prohibited transactions. Plan Management determined that during the years ended December 31, 2024, 2022 and 2021, the Plan Sponsor failed to remit certain employee deferrals to the Plan in a timely manner according to DOL regulations. These late remittances totaled \$81, \$21,538 and \$191,710, for the plan years December 31, 2024, 2022 and 2021, respectively. The Employer has undertaken the necessary procedures in accordance with DOL guidance to calculate and reimburse the affected participants for lost earnings due to these late contributions. For the year ended December 31, 2024, lost earnings were calculated to be \$0.19. During September 2025, corrections for lost earnings and interest thereon, have been fully restored to the participants’ accounts for the late contributions made in the year ended December 31, 2024.
