Scope and Nature of the ERISA 103(a)(3)(c) Audit

We have performed audits of the accompanying financial statements of CCN America, LP Pension Plan (“Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from Empower Trust Company, LLC, a qualified institution, as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTES TO FINANCIAL STATEMENTS

NOTE 1 - PLAN DESCRIPTION

The following description of the CCN America, LP Pension Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. Effective January 2023, the Plan's adoption agreement was amended to allow for safe harbor contributions and to conform with certain other legislative and regulatory changes, including allowing participants to make Roth contributions.

General

The Plan is a defined contribution profit sharing and 401(k) plan available to provide benefits to eligible employees of CCN America, LP (the "Company" or "Plan Sponsor"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and is administered by a trustee.

Eligibility

Employees become eligible to participate in the Plan on the first day of the month following completion of one year (1,000 hours) of employment. Employees who are nonresident aliens and/or represented by a collective bargaining unit are not eligible to participate in the Plan.

Contributions

Participants may contribute up to 100% of their compensation on either a pretax or Roth basis. Contributions for any calendar year are subject to limitations (\$23,000 in 2024 and \$22,500 in 2023) imposed by the Internal Revenue Code ("IRC"). Participants who have attained age 50 by the end of the Plan year are eligible under the IRC to make additional catch-up contributions (limited to \$7,500 in 2024 and 2023). Deferred salary contributions are classified as participant contributions in the statements of changes in assets available for benefits. In addition, participants who receive qualified distributions from another qualified plan may be able to rollover such distributions into the Plan. Participant rollover contributions during 2024 and 2023 totaled \$29,023 and \$206,402, respectively.

The Plan allows for the Company to make safe harbor contributions in the amount of 4% of an eligible participant's compensation. For the years ended December 31, 2024 and 2023, employer contributions in the statements of changes in assets available for benefits consist of these contributions. The Plan also allows the Company to make a discretionary non-elective contribution on behalf of all eligible participants. The Company did not make a discretionary non-elective contribution for the years ended December 31, 2024 and 2023.

NOTE 1 - PLAN DESCRIPTION (continued)

Participant accounts

Each participant's account is credited with the participant's contribution, allocations of Company contributions, investment earnings (losses), and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. The participants direct their contributions to purchase shares in any of the available investment options.

Vesting

Participants are immediately vested in their contributions and company safe harbor contributions, plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100 percent vested after six years of credited service. Vesting is as follows:

Notes receivable from participants

Participants may borrow from their vested account balance in amounts ranging from a minimum of \$1,000 to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The notes are secured by the participant's account balance. Fixed interest rates on loans issued are based on the Prime rate on the first business day of each month plus 1%. Interest rates in effect on outstanding loans ranged from 4.25% to 9.50% during 2024. Principal and interest is paid ratably through monthly payroll deductions according to terms of the promissory note and prepayments may be made at any time. There is a maximum repayment period of five years for participant loans.

Under the Plan's policy, the balance of notes in default (as defined) is reported to the participant as taxable income and is subject to personal income taxes and penalties. Such notes remain outstanding and continue to accrue interest even though they have been reported to a participant on Form 1099 (a "deemed distribution"). Notes will not be charged against the participant's vested account balance until approval is received to offset the note due to the participant's termination of service, retirement, death, disability, attainment age of 59-1/2, or reaching the earliest date that distribution is permitted under the Plan.

Administrative expenses

Certain expenses incurred in the administration of the Plan are paid directly by the Company.

Payment of benefits

Upon termination of employment, after the attainment of age 59 ½ or due to death, disability or retirement, a participant or their beneficiaries may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account or equal installments over a period not more than his or her assumed life expectancy. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

Plan termination

Although it has not expressed any intention to do so, the Company may terminate the Plan at any time. In the event of termination, the interest of participants affected by the termination and their beneficiaries under the Plan shall be non-forfeitable.

Forfeited accounts

As of December 31, 2024 and 2023, \$64,274 and \$56,871, respectively, of forfeited non-vested accounts were held by the Plan and available to reduce future employer contributions or to pay Plan expenses. During 2024 and 2023, respectively, the Plan utilized \$5,900 and \$0 of the forfeiture balance to cover Plan expenses and \$3,454 and \$0 to reduce employer contributions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of presentation

The accompanying financial statements have been prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of estimates

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities as of the date of the financial statements and the reported amounts of changes in assets during the reporting period. Actual results could differ from those estimates.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Investment valuation and income recognition

As of December 31, 2024 and 2023, mutual fund investments are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities Exchange Commission. These funds publish their daily fair value and transact at that price. The mutual funds held by the Plan are deemed to be actively traded. The Plan's investment in the Key Guaranteed Portfolio Fund fixed account is a fully benefit-responsive investment contract and is included in the financial statements at contract value. Contract value is the relevant measurement attribute for that portion of the assets available for benefits of a defined contribution plan attributable to fully-benefit responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Investment transactions are accounted for on the trade date (date the order to buy or sell is executed). Interest income is recorded as earned and dividend income is recorded on the ex-dividend date. All gains and losses (realized and unrealized) on investments recorded at fair value, bought and sold as well as held during the year, are included in net appreciation in fair value of investments reported within the statements of changes in assets available for benefits. Gains, losses, and interest income incurred on investments reported at contract value are included in interest and dividend income within the statements of changes in assets available for benefits.

The Plan provides for various investment options that are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of assets available for benefits.

Payment of benefits

Benefits are recorded when paid.

Subsequent events

The Plan evaluates events and transactions occurring subsequent to the date of the financial statements for matters requiring recognition or disclosure in the financial statements. The accompanying financial statements consider events through September 25, 2025, the date on which the financial statements were available to be issued.

NOTE 3 - TAX STATUS

The Plan obtained an opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that Metro Benefits Inc. Non-Standardized Pre-Approved Profit Sharing Plan with CODA, as adopted by the Company on October 30, 2006, was designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and is being operated in accordance with the terms of the Plan.

In accordance with GAAP, Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by applicable taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 - CERTIFICATION

Certain information related to investments and notes receivable from participants disclosed in the financial statements and schedule of assets held at end of year, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividend income for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC ("Empower"), the custodian of the Plan, in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

NOTE 5 - INVESTMENTS

The Plan provides participants the opportunity to direct both participant and employer contributions into separate investment funds. However, investment managers have the authority to make investment decisions within each fund.

Fair value measurements

Investments measured and reported at fair value are classified and disclosed in one of the following categories based on the extent of market observability:

Level I – Quoted prices are available in active markets for identical investments as of the reporting date. The type of investments reported as Level I include listed mutual funds.

Level II – Pricing inputs are other than quoted market prices included in Level I, however, are observable either directly or indirectly for the investment. The Plan does not carry any of these investments.

Level III – Pricing inputs are unobservable for the investment and includes situations where there is little, if any, market activity for the investment. The inputs into the determination of fair value require significant management judgment or estimation. The Plan does not carry any of these investments.

Fixed account

The Plan holds a fully benefit-responsive investment in the Key Guaranteed Portfolio Fund, offered by Empower Annuity Insurance Company ("EAIC"), an affiliated entity of Empower. The fixed account was included in the financial statements at contract value. The Key Guaranteed Portfolio Fund is an obligation of EAIC's general account, which supports all of EAIC's insurance and annuity commitments. All payment guarantees of contractual interest and redemption of invested funds are based on the financial strength and claims-paying ability of EAIC, who is solely responsible for all obligations under its contracts.

The nature of the Key Guaranteed Portfolio Fund is such that the Plan participants may withdraw assets without restrictions; however, the custodian may impose a hold period at the contract level in the event of a full contract discontinuance or partial contract discontinuance. The occurrence of an event that limits the ability of the investment to transact at contract value between the custodian and a participant holding the investment is not probable.

The Key Guaranteed Portfolio Fund guaranteed principal, and a guaranteed minimum interest rate ("GMIR") for the life of the contract, as well as featuring two declared interest rates: a credited rate, and a guaranteed minimum floor rate declared for a defined period - currently one calendar year. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Interest crediting rate is reset quarterly.

The guaranteed minimum floor rate may change after a defined period, but it will never be lower than the 0% for the life of the contract. The current rate, the guaranteed minimum floor rate, and the GMIR are expressed as annual effective yields. The average yield earned by the plan for the benefit responsive fund can be derived by averaging the quarterly gross interest rates for the fund over the year. The average yields for the years ended December 31, 2024 and 2023 were 1.41% and 1.23%, respectively.

NOTE 6 - RELATED PARTY TRANSACTIONS

The Plan holds notes receivable from participants and is invested in a fixed account that is managed by Empower, which qualify as party-in-interest transactions.

These party-in-interest transactions are not deemed prohibited because they are covered by statutory and administrative exemptions from the IRC and the rules of prohibited transactions of ERISA.
