Opinion

NOTES TO FINANCIAL STATEMENTS
DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN:

The following description of the St. Thomas Community Health Center Retirement Plan ("the Plan") provides only general information. Participants should refer to the Plan Description and the Adoption Agreement for a more complete description of the Plan's provisions.

General:

The Plan was originally effective on July 1, 2006 with subsequent amendments effective April 1, 2017, and January 1, 2018. On September 14, 2020 the Plan's assets were transferred to a new custodian. On November 12, 2020, the Plan was amended to adopt CARES Act. The amendment included Coronavirus-related distributions, increased loan limits, delay of loan payments and required minimum distributions.

The Plan covers all eligible employees who have ninety days of service (1000 service hours) during any Plan year and have attained age 18. The Plan is a Profit Sharing Safe-Harbor Plan which requires employer contributions to be fully vested upon payment to the Plan. Under a safe-harbor plan, the employer must make either a matching contribution or a non-elective contribution. The employer may match contributions equal to a discretionary percentage to be determined by the employer.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions:

The St. Thomas Community Health Center's Board of Directors makes a safe-harbor matching contribution to the Plan equal to 100% of the first 6% of elective contributions. Additional discretionary profit-sharing amounts may be contributed at the option of the St. Thomas Community Health Center's Board of Directors. Contributions are subject to certain limitations.

Participant Accounts:

Each participant's account is credited with the participant's contribution, the Company's safe-harbor match, the Company's profit-sharing contribution and Plan earnings. Participant accounts are also charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are immediately vested in their voluntary and Company safe-harbor and matching contributions plus actual earnings thereon. Vesting in the Company's discretionary profit-sharing contribution is based on years of continuous service. A participant is 100% vested after four years of service. Participants also become fully vested upon death and total, permanent disability.

1. DESCRIPTION OF THE PLAN: (Continued)

Notes Receivable from Participants:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000, or 50% of their vested account balance, whichever is less. Participants may only have one outstanding loan at any time. The notes are secured by the balance in the participant's account and bear interest at the "bank prime rate" as reported by the U.S. Federal Reserve on the last business day of a calendar quarter effective for notes made on and after the first day of the subsequent quarter.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considered the participant loan in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. All participant notes are fully collateralized by the related participant's account balance.

Payments of Benefits:

On termination of service due to death, disability or early normal retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or a life annuity or joint and survivor annuity. Hardship distributions are permitted from the participant's elective deferral account. For termination of service due to other reasons, a participant may receive the value of the vested benefit in his or her account as a lump-sum distribution.

Forfeitures:

Forfeiture of employer matching contributions will be applied to reduce future employer contributions or to pay Plan expenses. During the years 2024 and 2023, forfeitures in the amounts of \$508 and \$67, respectively, was used to reduce employer contributions. During the years ended December 31, 2024 and 2023, forfeitures used to pay plan expenses were \$7,705 and \$3,871, respectively. As of December 31, 2024 and 2023, there were \$4 and \$3, respectively, available in the forfeiture account.

Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will be 100% vested in their accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of Accounting:

The financial statements of the Plan are prepared using the accrual method of accounting.

Plan Administration and Certification of Information:

The Plan is administered by the Company through a Trustee. Principal Trust Company held the Plan's investment assets, maintained the details on each participant's account, and executed transactions for the years ended December 31, 2024 and 2023.

Investment information included in the accompanying financial statements is based on information certified by Principal Trust Company to be complete and accurate, in accordance with Section 2520.103-5 of the Department of Labor Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

Investment Valuation and Income Recognition:

Investments are reported at fair value except for the guaranteed investment contract which is reported at contract value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. The Trustee invests contributions within investment options directed by the participants.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Payments of Benefits:

Benefits are recorded when paid.

Plan Amendments – Secure Act:

Effective November 1, 2024, participants may request a distribution of up to \$5,000 per child as a qualified birth or adoption distribution, provided certain conditions are met in accordance with the Plan document.

The Plan has been amended to conform to recent changes to required minimum distribution that are effective after December 31, 2019. The law now requires complete distributions to certain beneficiaries of deceased participants no later than December 31, ten years following the year of the participant's death. Additionally, distributions must generally begin April 1st of the calendar year following the year the participant turns age 70 1/2 if born before July 1, 1949 or age 72 if you were born after June 30, 1949.

Plan Amendments – Secure Act: (Continued)

Long-term part-time (LTPT) participants as defined in the Plan document will be credited with a year of service for each year in which the LTPT participant is credited with more than 500 hours of service beginning after year December 31, 2020, if the participant has attained age 21.

Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

4. FAIR VALUE MEASUREMENTS: (Unaudited)

The Plan applies the provisions of FASB ASC 820, *Fair Value Measurements and Disclosures*. ASC 820 defines fair value, establishes a framework for measuring fair value in generally accepted accounting principles and expands disclosures regarding fair value measurements. ASC 820-10 also establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs are based on quoted prices in markets that are not active or for which all significant inputs are observable, either directly or indirectly. Level 3 inputs have the lowest priority and are based on inputs that are unobservable and significant to the fair value measurement. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally proved the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used when Level 1 or Level 2 inputs were not available.

Level 1 Fair Value Measurements

Mutual funds: Mutual funds are valued at the daily closing price as reported by the Fund. Mutual funds held by the Fund are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Level 2 Fair Value Measurements

Collective investment trust (CITs): CITs are defined as pooled investment vehicles sponsored and maintained by a bank or trust company. Principal has a trust company subsidiary that establishes trusts and maintains their activities. All redemptions of CITs are computed at that days NAV. The NAV is not a publicly quoted price in an active market but its available to current investors via the employer website. CITs have a readily determinable fair value. CITs may invest in equities, fixed incomes, mutual funds, PSA, other CITs, ETFs, and alternative investment vehicles.

Pooled separate accounts (PSAs): PSAs are available through a group annuity contract with Principal Life Insurance Company. The underlying assets are composed of common stocks of companies listed in the S&P Small Cap 600 index and the S&P Mid Cap 400 index which are traded in active markets.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no significant transfers between Levels 1 and 2 and no transfers into or out of Level 3.

5. INVESTMENTS AT CONTRACT VALUE: (Unaudited)

Guaranteed Investment Contract

The Principal Guaranteed Option is a guaranteed general account-backed group annuity contract issued by Principal Life Insurance Company (PLIC) to Principal Life Trust Company as custodian. The assets in the general account are supported by the financial stability of PLIC. A rate of interest contractually guaranteed by PLIC is credited to the participant account balances. Benefit payments to participants are made without restriction for plan benefit events, including retirement, termination of employment, disability, plan termination, death, loans, and withdrawals, as allowed by the plan. Participants can generally transfer assets into or out of the contract without early termination or surrender charges.

The Principal Guaranteed Contract Option is reported at contract value, as these investment contracts are fully benefit responsive. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. As of December 31, 2024 and 2023, \$58,580 and \$53,414, respectively, were reported at contract value. The Guaranteed Investment Contract Option interest rate as of December 31, 2024 and 2023 was 2.55% and 1.90%, respectively.

6. TRANSACTIONS WITH PARTIES-IN-INTEREST:

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, or an employer whose employees are covered by the Plan. Certain Plan investments are managed by the Trustee; therefore, these transactions qualify as party-in-interest transactions. Transactions with parties-in-interest also include fees paid during the year for trustee, accounting, and other services, as well as contributions paid to the Plan by the Company and loans made to participants. All of these transactions are exempted from prohibited transaction rules under ERISA.

7. TAX STATUS:

The IRS has determined and informed the Plan sponsor by a letter dated April 2, 2012, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

8. ADMINISTRATION OF PLAN ASSETS:

Administrative expenses in the amount of \$7,705 and \$3,871 were paid out of the Plan's forfeiture account during 2024 and 2023, respectively. Administrative fees totaling \$47,681 and \$38,937 for the years ended December 31, 2024 and 2023, respectively, were paid by participants.

9. TERMINATED EMPLOYEES:

As of December 31, 2024 and 2023, accounts of separated participants with deferred vested benefits for future payment totaled \$2,013,243 and \$1,489,927, respectively.

10. RISKS AND UNCERTAINTIES:

Investments in mutual funds and collective investment trusts represent a significant portion of net assets available for plan benefits. Such investments are subject to interest rate, market and credit risks. Due to the level of risk associated with these investments, it is at least reasonably possible that changes in the values will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for plan benefits.
