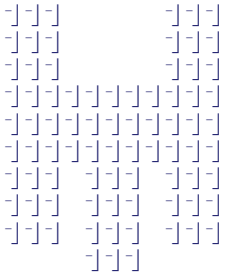

INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants of
Riviera Country Club 401(k) Retirement Plan
Coral Gables, Florida

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Riviera Country Club 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Riviera Country Club 401(k) Retirement Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Riviera Country Club 401(k) Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental schedule of assets held for investment purposes as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion—

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. **Description of Plan**

The following description of the Riviera Country Club 401(k) Retirement Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan Adoption Agreement for a more complete description of the Plan's provisions.

- a) *General* – The Plan is a defined contribution plan covering all employees of Riviera Country Club of Coral Gables, Inc. (the "Organization") who have at least one year of service to the Organization and have attained the age of twenty-one. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was formed on January 1, 1998, and restated in its entirety on January 1, 2022, as required by Internal Revenue Service's (IRS) restatement cycle.
- b) *Plan Administration* – The Plan is administered by the Plan's trustee and by Ingham Group, a third-party administrator (TPA). As of December 31, 2024 and 2023, the Plan's trustee is Reliance Trust Company (Reliance), which directs the custody and management of the Plan's assets. Ingham Group performs such duties as preparation of government forms, calculation of benefit and contribution requirements, compilation of participant data and maintenance of accounting records. As of December 31, 2024 and 2023 the actual custody of the Plan assets is with Fidelity Investments (Fidelity).
- c) *Contributions* – Each year participants may make pretax and/or Roth 401(k) contributions to the Plan of up to 100% of annual compensation, as defined in the Plan and as subject to limitations defined by the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified plans. The Plan is a qualified automatic contribution arrangement 401(k) plan or QACA Safe Harbor plan, where the Organization currently matches 100% of salary deferrals on the first 1% of compensation, plus 50% of deferrals between 1% and 6% of compensation. Furthermore, the Organization may make discretionary profit-sharing contributions and qualified non-elective contributions to the Plan. For the year ended December 31, 2024, the Organization did not make any discretionary contributions.
- d) *Participant Accounts* – Each participant's account is credited with participant's contribution, the employer's matching contribution and Plan earnings. In addition, participant accounts may be credited with an allocation of employer non-matching contributions. Allocations of employer non-matching contributions would be based upon an eligible participant's relative compensation contributed to the Plan.
- e) *Vesting* – Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Organization's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years on continuous service. Participants become 100% vested on the Organization's Safe Harbor matching contributions after two years of credited service. Vesting in the Organization's contributions that are not considered Safe Harbor matching contributions is based on years of continuous service. A participant becomes 100% vested in such contributions after six years of credited service or immediately upon death or disability.
- f) *Administrative Expenses* – The Plan administrator has elected to pay the administrative costs associated with Plan operations and compliance. Individual participants pay for investment management fees and recordkeeping fees, which is based on the participant asset balances.

1. **Description of Plan, continued**

- g) *Investment Options* – Upon enrollment in the Plan, a participant may direct employee contributions in any of the investment options offered in the Fidelity Investment program. Participants may change their investment options via phone or internet access at any time.
- h) *Participant Notes Receivable* – This Plan does not permit loans to Participants.
- i) *Payments of Benefits* – Upon retirement, disability, death, or termination of service, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. In-service distributions are permitted for employees attaining age 59 ½. Hardship distributions are also permitted from the employee elective deferral account.
- j) *Forfeited Accounts* – Forfeitures, when they occur, are used to reduce employer match contributions, and are allocated to employee accounts accordingly. Total forfeitures available as of December 31, 2024 and 2023 amounted to \$1,792 and \$1,044, respectively. During the year ended December 31, 2024, \$672 was forfeited by employees.

2. **Summary of Significant Accounting Policies**

The following are the significant accounting policies followed by the Plan:

- a) *Basis of Accounting* – The accompanying financial statements are prepared on the accrual basis of accounting.
- b) *Use of Estimates* – The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
- c) *Valuation of Investments and Income Recognition* – Investments in registered investment companies (i.e., mutual funds and mutual funds held in common collective trust) are reported at fair value of the fund's quoted market price. Investment options that do not have readily available market quotations are valued according to quotations from the custodian. Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date.
- d) *Plan Risk and Uncertainties* – The Plan and the Plan assets are sensitive to economic pressures prevalent in the investment market. The pressures primarily stem from interest rates, market and credit risk and their effect on bond rates, mortgage rates, the value of real estate, stock prices, and the overall stability of the market. Additionally, the financial position of the Plan Sponsor, Riviera Country Club of Coral Gables, Inc., may have a significant impact on the Plan. Specifically, this includes the ability of the Plan Sponsor to continue to make contributions under the program and/or the stability of the Plan Sponsor's operations. Other external factors which may affect the Plan, and the Plan assets include legislation or regulations established by the Internal Revenue Service, Employee Retirement Income Security Act of 1974, and/or Department of Labor (DOL).
- e) *Payment of Benefits* – Benefits are recorded when paid.

3. Fair Value Measurements

Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) 820-10, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value for assets and liabilities that are measured at fair value on a recurring basis. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following descriptions provide the valuation methodologies used for assets measured at fair value in the tables below. There have been no changes in the methodologies used as of December 31, 2024.

- a) *Interest-bearing cash* – Includes cash reserves valued at \$1 per unit, and money market funds valued at quoted market prices of a national securities exchange on the last business day of the year of units held by the Plan at year end.
- b) *Mutual funds* – Valued at quoted market prices of a national securities exchange on the last business day of the year, of units held by the Plan at year end.
- c) *Mutual funds held in common collective trusts (CCT)* – Valued at net asset value (NAV), as quoted by the investment manager, of shares held by the plan at year end. In this instance the NAV is used as a practical expedient to estimate fair value.

4. Information Certified by the Plan's Trustee

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the trustee, Reliance Trust Company, has certified that the data included in the accompanying financial statements and supplemental schedule is complete and accurate. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule. 5. Related Party Transactions

Certain Plan investments include shares of mutual funds held by Fidelity Investments. Fidelity is the investment custodian of the Plan's assets as of December 31, 2024 and 2023, and therefore, these transactions qualify as party-in-interest transactions. However, they are not considered prohibited transactions in accordance with appropriate ERISA exceptions.

6. Tax Status

The Plan is utilizing a Pre-Approved Defined Contribution Plan document provided by its TPA, Ingham Group. The Plan reflects the implementation of recent legislative changes in the regulations governing qualified tax-deferred arrangements via the IRS Cycle 3 restatement. The restated Plan received an opinion letter issued by the Internal Revenue Service dated January 25, 2021. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and therefore believes that the Plan is qualified and is tax-exempt. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Plan Termination

Although the Organization has not expressed any intent to do so, it does have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts, and accrued benefits, to the extent funded or required to be funded, must be distributed to the participants.

8. Subsequent Events

The Plan's management has evaluated subsequent events through October 3, 2025, the date on which the financial statements were available to be issued, and determined no additional disclosures were required to be presented in these financial statements.
