As stated in our engagement letter dated July 9, 2025, our responsibility, as described by professional standards, is to conduct our audit in accordance with U.S. GAAS except that, as permitted by Regulation 2520.103-8 of the Department of Labor’s (DOL) Rules and Regulations for Reporting and Disclosure under ERISA and as elected by management, we did not perform any auditing procedures with respect to asset information prepared and certified to by Fidelity Management Trust Company, the trustee, in accordance with DOL Regulation 2520.103-5, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements and ERISA-required supplemental schedule, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting.

Our responsibility for the ERISA-required supplemental schedule accompanying the financial statements is to perform adequate procedures to evaluate whether the form and content of the ERISA-required supplemental schedule, other than that agreed to or derived from the certified investment information, is presented in compliance with the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA, and whether the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Significant Audit Matters

Qualitative Aspects of Accounting Practices

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by the Plan are described in Note 2 to the financial statements. No new accounting policies were adopted and the application of existing policies was not changed during 2024. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. The most sensitive estimate affecting the financial statements was the fair value of investments as disclosed in Note 4 to the financial statements.

Certain financial statement disclosures are particularly sensitive because of their significance to financial statement users. The most sensitive disclosure affecting the financial statements was the information prepared and certified by the trustee in Note 7 to the financial statements.

The financial statement disclosures are neutral, consistent and clear.

Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in dealing with management in performing and completing our audit.

A material weakness is a deficiency, or a combination of deficiencies in internal control, such that there is a reasonable possibility that a material misstatement of the Plan’s financial statements will not be prevented, or detected and corrected, on a timely basis.

The most sensitive estimate affecting the financial statements was the fair value of investments as disclosed in Note 4 to the financial statements.

Certain financial statement disclosures are particularly sensitive because of their significance to financial statement users. The most sensitive disclosure affecting the financial statements was the information prepared and certified by the trustee in Note 7 to the financial statements.

The financial statement disclosures are neutral, consistent and clear.

Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in dealing with management in performing and completing our audit.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. We did not identify any known or likely significant misstatements during our audit.

Disagreements with Management

Their report dated October 14, 2024 indicated that in their opinion (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with the modified cash basis of accounting, which is a basis of accounting other than U.S. GAAP, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Notes to Financial Statements

December 31, 2024 and 2023

1. Plan Description

The following brief description of Wilcox Industries Corp. 401k Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a tax-exempt defined contribution plan sponsored by Wilcox Industries Corp. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Employees of the Company who have attained 18 years of age are eligible to participate in the Plan on the first day of the month after completing 60 days of employment.

Contributions and Vesting

Participants may contribute up to 100% of eligible compensation, as defined in the plan document, to the Plan, subject to the limitations established by the Internal Revenue Code (the Code). In addition, participant contributions may also consist of rollovers from other qualified retirement plans.

The Company provides a safe harbor matching contribution equal to 100% of the first 4% of the participants' eligible compensation, as defined in the plan document, that is contributed to the Plan by participants. The Company may also provide a discretionary profit sharing contribution to the Plan. There was no discretionary profit sharing contribution made in 2024.

Participants are immediately vested in their elective deferrals and Company contributions.

Distributions

Amounts contributed to participant accounts by rollover from other qualified retirement plans may be distributed to participants at any time. No other amounts may be distributed to participants from their accounts prior to their termination of employment, death, disability or their attainment of age 59½, unless the participant has incurred a hardship, as defined by the Code. Participants with less than \$1,000 in their vested account balance will receive an involuntary cash out of their account upon termination of employment.

Participant Accounts

Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's and employer's contributions and an allocation of investment income. A participant's account shall be reduced by any distributions, investment losses and certain administrative expenses. Allocations are based on participants' earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements

December 31, 2024 and 2023

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms range from 1-5 years or 30 years for the purchase of a primary residence. The loans are secured by the balance of the participant's account and bear interest at a rate of 1% over the prime interest rate. Principal and interest are paid ratably through payroll deductions.

Investments

Upon enrollment in the Plan, a participant may direct his or her account balance among the various investments offered by the Plan. The Plan offers several mutual funds, money market fund, and common collective trusts. In 2023, the Plan's investments were liquidated and converted to cash while the funds were transferred to a different trustee.

Administrative Expenses

The Company pays substantially all administrative expenses associated with the Plan. Certain redemption and loan distribution and administration fees are paid directly by the Plan participants.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the modified cash basis of accounting. Accordingly, certain revenue and related assets are recognized when received, rather than when earned, and certain expenses are recognized when paid, rather than when incurred.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the cash basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. Interest is recorded on the cash basis.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Management has considered transactions or events occurring through September 29, 2025, the date the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

3. Investments in Common Collective Trusts

The Plan has investments in the Morley Stable Value Fund and Federated Hermes Capital Preservation Fund, both of which are common collective trusts with values based on the quoted market prices of the underlying assets in the common collective trust. The investment objective of the Morley Stable Value Fund is to seek the preservation of capital relatively stable returns consistent with its comparatively low risk profile, and liquidity for benefit responsive plan or participant payments. The investment objective of the Federated Hermes Capital Preservation Fund is to preserve principal and current income. Withdrawals from the Morley Stable Value Fund and Federated Hermes Capital Preservation Fund are permitted at any time by participants.

The common collective trust contracts are not considered fully benefit responsive contracts because the contracts are with a trust and not directly with the Plan. There were no redemption restrictions for these investments.

4. Fair Value Measurement

Financial Accounting Standards Board Accounting Standards Codification Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value that provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Mutual funds and money market funds: Valued using market quotations.

Common collective trusts: Valued at net asset value (NAV) of shares held by the Plan at year-end. NAV is a practical expedient; therefore, the common collective trusts are excluded from the fair value hierarchy table below.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

As of December 31, 2023, the Plan held no investments measured at fair value.

5. Plan Termination

Although it has not expressed intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. Upon termination, investments shall be liquidated and proceeds, less expenses of termination, distributed to participants.

6. Tax Status

The Internal Revenue Service has determined and informed the trustee by a letter dated June 30, 2020 that the Plan and related trust are designed in accordance with applicable sections of the Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

7. Information Certified by Trustee

The cash, investments, investment transactions, notes receivable from participants, net appreciation in fair value of investments and interest and dividend amounts were obtained by management and agreed to or derived from the information certified by the trustee as complete and accurate. This information is included in the following:

- Statements of Net Assets Available for Benefits (Modified Cash Basis);
- Statement of Changes in Net Assets Available for Benefits (Modified Cash Basis); and
- Schedule H, line 4i – Schedule of Assets (Held at End of Year).

8. Parties-in-Interest

Certain plan investments are managed by the Plan's trustee. Certain distributions made by the trustee are in the form of loans to the Plan's participants. The Plan incurred certain administrative, recordkeeping, distribution and loan processing fees which were paid to the trustee and amounted to \$57,283 for the year ended December 31, 2024. These transactions are considered to be party-in-interest transactions.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that these changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits (modified cash basis).
