INDEPENDENT AUDITORS' REPORT

To the Board of Directors

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Tax-Deferred Annuity Plan of Lincoln, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the related Statements of Changes in Net Assets Available for Benefits for the years ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Tax-Deferred Annuity Plan of Lincoln's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Tax-Deferred Annuity Plan of Lincoln and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Tax-Deferred Annuity Plan of Lincoln's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Tax-Deferred Annuity Plan of Lincoln's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



NOTES TO FINANCIAL STATEMENTS

1. Description of Plan

The following brief description of Tax-Deferred Annuity Plan of Lincoln (“the Plan”) is provided for general information purposes only. Participants should refer to the Plan’s agreement for a more complete description of the Plan’s provisions.

General

The Plan, a defined contribution tax deferred savings plan intended to qualify under Section 403(b) and related provisions of the Internal Revenue Code (“the Code”), was established effective March 1, 1980. The Plan is designed to provide participants with a means to defer a portion of their compensation for retirement and to provide benefits in the event of disability, death, termination, or financial hardship. Generally, the Plan covers all employees of Lincoln. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), and subsequent laws.

Plan Administration

The employer is the administrator of the Plan and, as such, carries out the duties imposed by ERISA. The employer has delegated certain responsibilities for the operation and administration of the Plan. Trustee and recordkeeping services are provided by Mutual of America Life Insurance Company (“Mutual”) and American United Life Insurance Company (“AUL”).

All administrative expenses of the Plan, including recordkeeping were paid out of the Plan for the year ended December 31, 2024. Investment fees, which may vary according to the individual funds selected, are paid out of the assets of the Plan. Participants should refer to the prospectus of the individual investment funds for further details on individual investment fees.

Contributions

Under the provisions of the Plan, participants may contribute any percentage of their annual compensation up to the maximum limit as permitted by the Code. Contributions may be made on a pre-tax basis or, effective January 1, 2024, on an after-tax basis as Roth elective deferrals. Roth contributions are tracked separately from pre-tax deferrals within each participant’s account and are maintained as a distinct source for recordkeeping purposes. In addition, participants qualifying for age-based provisions may contribute additional catch-up deferrals. Participants may also contribute amounts representing distributions from other eligible retirement plans. Plan earnings are allocated to all participant-directed accounts, with each participant having a separate and distinct basis for earnings allocation, and may be valued at any time during the year. No contributions are made to the Plan by the employer.

Participants Accounts

Each participant's account is credited with the participant's contributions and earnings thereon and is charged with an allocation of applicable administrative expenses. Investment allocations are based on account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s account.

1. Description of Plan, continued

Vesting

Participants' contributions are fully and immediately vested.

Investment Options

Upon enrollment in the Plan, a participant may direct employee contributions in any of the investment options offered by the trustees. Participants may change their investment options at any time.

Notes Receivable from Participants

Participants may borrow up to 50% against their vested account balance minus any current outstanding loans to a maximum loan of \$50,000. The minimum loan is \$1,000. The maximum loan term is five years. The loans are secured by an equal amount of the loan value in the participant's general account. Loans are subject to a commercially reasonable rate of interest, currently at 5.00%. Unpaid loan amounts will be taxed as ordinary income and may incur a 10% federal tax penalty if the participant is under age 59½.

Payment of Benefit

Upon attaining age 59½ or the termination of employment for any reason, a participant may request a complete distribution of their account in a single sum or as even installments over a period not to exceed the participant's life expectancy. Hardship withdrawals are also available. Distributions that are neither based on hardship nor installments over a ten-year period or more will ordinarily be eligible for rollover to another eligible retirement plan.

2. Summary of Significant Accounting Policies

A summary of the significant accounting policies applied in the preparation of the accompanying financial statements is as follows:

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and (losses) on investments bought and sold as well as held during the year.

2. Summary of Significant Accounting Policies, continued

Payment of Benefits

Benefits are recorded when paid.

Fair Value Measurements

Generally accepted accounting principles provide guidance on how fair value should be determined when financial statement elements are required to be measured at fair value. Valuation techniques are ranked in three levels depending on the degree of objectivity of the inputs used with each level:

Level 1 inputs - quoted prices in active markets for identical assets

Level 2 inputs - quoted prices in active or inactive markets for the same or similar assets

Level 3 inputs - estimates using the best information available when there is little or no market

The Plan is required to measure investments at fair value. The specific techniques used to measure fair value for the financial statement element is described in the notes below that relate to the element.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures as of the date and for the period presented. Actual results may differ from those estimates.

Administrative Expenses

The Plan generally will pay the expenses of plan administration and will assess the expenses paid against the accounts of all participants in the Plan. Lincoln may, from time to time, change the manner in which expenses are allocated. During the years ended December 31, 2024 and 2023, total administrative charges were \$497 and \$434, respectively.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risk. It is reasonably possible, given the level of risk associated with certain investment securities that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

The Plan's exposure to a concentration of credit risk is limited by diversification of investments across various assets classes and the utilization of investment managers.

Subsequent Events

Management has evaluated subsequent events through October 1, 2025, the date which the financial statements were available for issue. No events or transactions have occurred during this period that appear to require recognition or disclosure in the financial statements.

3. Notes Receivable from Participants

Notes receivable from participants are repaid at an interest rate of 5.00% with various maturities. Notes receivable from participants are repaid biweekly with AUL and quarterly with Mutual. Notes receivable from participants at December 31, 2024 and 2023 were \$65,940 and \$17,142, respectively.

4. Information Prepared and Certified by the Trustees

No auditing procedures were performed on investments and interest income as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

The Plan invests in the Interest Accumulation Account, a guaranteed general account investment contract provided through a group annuity contract issued by Mutual. This contract is backed solely by the insurer's general account assets, with principal and interest guaranteed based on Mutual's financial strength and claims-paying ability. A composite crediting rate, contractually guaranteed by Mutual, is applied to account balances and compounded daily to produce the stated effective annual yield. As of year-end, the net credited interest rate was 3.00%, with a minimum guaranteed rate of 3.00%, which may be adjusted annually as of January 1. Participant withdrawals and transfers are permitted daily at contract value, subject only to normal plan rules, with no penalties, fees, or market value adjustments; under all circumstances, including plan termination or significant plan-level events, payment is made at contract value. This investment is reported at contract value, representing contributions plus credited interest less withdrawals, with no fair value measurement used for plan reporting. Refer to the contract or plan description for full investment details, including administrative fees which may apply.

The Plan offers an interest-bearing stable value investment option through a fully benefit-responsive group annuity contract issued by AUL, backed solely by AUL's general account assets, with participants having no ownership interest in the underlying investments. As of December 31, 2024, the contract provided a net credited interest rate of 1.75%, with 2.00% declared for 2025. This rate is net of administrative and investment-related fees retained by AUL and is compounded daily to produce the stated annual yield, with no possibility of a negative rate or a stated minimum guaranteed rate. Participant account balances may be transferred or withdrawn daily at contract value, subject to standard plan provisions, except that transfers to competing investment options are subject to a 90-day equity wash restriction. In the event of plan termination, significant sponsor-initiated withdrawals, or certain plan-level events, a 12-month put provision applies before balances may be withdrawn at contract value, and no market value adjustments will be made. The investment is reported at contract value, representing contributions plus credited interest less participant withdrawals, with no fair value measurement applied.

7. Related Party and Party-in-Interest Transactions

ERISA defines parties-in-interest more broadly than generally accepted accounting principles' related parties, encompassing all service providers to the Plan. Management identified no related parties that were not also parties-in-interest, and no material related party transactions occurred during the Plan year regarding compensation arrangements, expense allowances, or similar items.

Parties-in-interest transactions include those with Plan fiduciaries or employees, service providers, employers with covered employees, employee organizations with covered members, and persons owning 50% or more of such employers or employee associations, along with their relatives. Trustee transactions, including revenue sharing and fee offset agreements, as well as the Plan's payment of certain plan fees and expenses, qualify as parties-in-interest transactions. Administrative fees paid by the Plan to the trustee were \$497.

The Plan's investment options include funds managed by the custodian or its affiliates. As custodian and recordkeeper, AUL's transactions qualify as exempt parties-in-interest transactions. In addition, Mutual serves as a custodian for certain Plan investments. Transactions involving both AUL and Mutual qualify as exempt party-in-interest transactions under ERISA due to their roles in administering and holding Plan assets.

8. Plan Termination

Although it has not expressed any intent to do so, Lincoln has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA.

9. Tax Status

The Plan presently does not have a tax determination letter from the Internal Revenue Service (“IRS”) since 403(b) plans currently are not required to submit plans to the IRS for determination. However, the plan administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.
