INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of
Uniloy 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Uniloy 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Uniloy 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Responsibilities of Management for the Financial Statements

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTES TO THE FINANCIAL STATEMENTS**

NOTE 1 - DESCRIPTION OF THE PLAN

The following brief description of the Uniloy 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the summary plan description and to the plan agreement for complete information.

The Plan is a qualified retirement plan under Sections 401(a) and 401(k) of the Internal Revenue Code covering all employees of Uniloy, Inc. (Company or employer).

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each employee who participates in the Plan may enter into a compensation reduction agreement with the Company. Employees are immediately eligible to contribute to the plan upon hire date. The amounts deferred shall be contributed by the Company on behalf of the participant into the Plan for allocation to the participant's Employee Contribution Account. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Employees are automatically enrolled in the Plan at a 4% deferral rate and a 1% automatic annual increase until a deferral rate of 10% is obtained. Any employees that do not wish to participate in the Plan must opt out of the Plan.

Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). The Plan received \$264,291 and \$204,332 in rollover contributions during 2024 and 2023, respectively.

The company contributes a matching contribution of 50% of the first 6% of employee contributions up to a maximum of 3% of eligible wages (as defined). During the years ended December 31, 2024 and 2023, the Company made \$1,412,089 and \$1,186,697, respectively, of matching contributions to the Plan.

The Company may also make annual discretionary contributions. All participants who were active during the plan year will be eligible to receive an allocation of the company discretionary contribution. There was no annual discretionary contribution during 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant's contributions, employer's qualifying contributions, and an allocation of Plan earnings and expenses. Each participant shall direct their participant contribution and the employer's qualifying contributions to one or more funds, all of which are maintained by Principal Trust Company. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their vested accounts for specific purposes in cases of financial hardship. The minimum amount is \$1,000 and the maximum is the lesser of \$50,000 or 50% of the vested portion of their participant account as of the date the loan is approved. Participants may have a maximum of one loan outstanding in any 12-month period. The loans are secured by the balance in the participant's account and bear interest to be fixed by the plan administrator, and shall be fully repaid on or before five years from the date of disbursement, except in the case of a loan for a principal residence.

NOTE 1 - DESCRIPTION OF THE PLAN (continued)

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contributions portion of their account is based on the number of years of service. In all cases, participants are 100% vested after one year.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$5,304 and \$12,013, respectively. These accounts will be used to reduce future employer contributions or administrative fees. For the years ended December 31, 2024 and 2023, employer contributions and administrative expenses were reduced by \$12,477 and \$9,346 from forfeited nonvested accounts.

Hardship Withdrawals

A participant may elect to withdraw the balance of their account attributable to their salary reduction election (plus earnings thereon) provided such withdrawal is to meet their immediate and significant financial needs.

Payment of Benefit

Upon retirement (normal retirement on or after age 65), early retirement (age 55), or other separation of employment because of death, disability or for other in-service reasons, a participant will receive their benefits as either a lump-sum, installment payments, or an annuity. Upon termination of employment, if the vested participant account balance does not exceed \$5,000, the entire account balance will be distributed in the form of a lump sum payment.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The books of the Plan are maintained on the accrual basis of accounting. The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 9 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Benefits are recorded when paid. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Benefit payments are recorded when paid.

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of the notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

The Plan evaluates events and transactions that occur after year end for potential recognition in the financial statements. These subsequent events have been considered through September 19, 2025, which is the date the financial statements were available to be issued.

NOTE 3 - INVESTMENT CONTRACTS WITH INSURANCE COMPANIES

The Plan has entered into a fully benefit-responsive investment contract with Principal Life Insurance Company (Principal Fixed Income Guaranteed Option). The accounts are credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by the insurance company. The contracts are included in the financial statements at contract value as reported to the Plan by Principal Life Insurance Company. The investment contracts issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates are reviewed on a semiannual basis for resetting but may not be less than 1.00 percent. When establishing interest crediting rates for this product, Principal Life Insurance Company considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract. Contract value, as reported to the Plan by Principal Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

There are no events that allow the issuer to terminate the contract and that require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time.

NOTE 4 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company reserves the right under the Plan to terminate the Plan in whole or in part at any time, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 5 - FINANCIAL INSTRUMENTS

The Plan is required to disclose significant concentrations of credit risk regardless of the degree of such risk.

The Plan's investments consist of mutual funds, pooled separate accounts, guaranteed interest accounts, and self-directed brokerage accounts. These investments represent a wide variety of companies and industries and, in the opinion of plan management, any potential concentration of credit risk is minimal.

NOTE 6 - INCOME TAX STATUS

The Plan has adopted the prototype plan of Principal Financial Group. The prototype plan sponsor has obtained a determination letter in which the Internal Revenue Service stated that the prototype plan, as designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - TRANSACTIONS WITH PARTIES-IN-INTEREST

Certain administrative expenses of the Plan are paid by the sponsor and not charged to the Plan.

Plan investments are units of mutual funds, pooled separate accounts, self-directed brokerage accounts, and guaranteed interest contracts managed by Principal Trust Company. Principal Trust Company is the trustee for Plan investments; therefore, these transactions qualify as party-in-interest transactions.

NOTE 9 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts: Valued at net asset value (NAV) of units held by the Plan at year end.

Self-Directed Brokerage Accounts: Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
