INDEPENDENT AUDITORS' REPORT

To the Plan Administrator,
SIMEDHealth Retirement Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of SIMEDHealth Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of SIMEDHealth Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

(1) **Description of the Plan:**

The following description of SIMEDHealth Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

(a) **General**—The Plan is a defined contribution profit sharing 401(k) plan covering substantially all employees of SIMEDHealth, L.L.C. (the Company) who have attained the age of 18 years and completed 1,000 hours of service in 12 months of service on the Plan entrance date, as defined in the Plan agreement. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

(b) **Contributions**—Each year, participants may contribute up to 85% of pretax and certain after-tax annual compensation, as defined by the Plan. If a participant is subject to the Plan's automatic enrollment, the Company will begin to automatically deduct 3% from pre-tax compensation as a deferral contribution to the Plan, with that deferral increased annually by 1% until a deferral rate of 10% is reached. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

At the Company's discretion, it may make matching contributions that combined with the participant contributions may not exceed the lesser of the maximum amount allowed as defined by the Secretary of the Treasury or 100% of the participant's annual compensation. The Company has also elected to make Safe Harbor Nonelective Employer Contributions to all participants that were eligible to participate in the Plan during the Plan year equal to 3% of such eligible participants' compensation during the Plan year. Furthermore, the Company has elected to make qualified automatic contribution arrangement (QACA) Fixed Profit-Sharing contributions to all eligible participants during the Plan year.

(c) **Vesting**—Participants are vested immediately in their contributions plus actual earnings thereon. Participants are vested in the Company's contribution portion of their accounts based on years of service. A participant begins vesting after two years of credited service and is 100% vested after six years of credited service. All employees with QACA Fixed Profit-Sharing contributions are 100% vested after two years. Participants become immediately 100% vested in the Company's contribution upon death or disability.

(d) **Participant accounts**—Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's matching contribution and (b) plan net earnings or losses. The Company currently offers 30 mutual funds, one money market fund, one common collective trust, and self-directed brokerage accounts as investment options for participants. Participants may change their investment options daily. The benefit to which a participant is entitled is the participant's vested account balance.

(e) **Notes receivable from participants**—Participants may borrow from their fund a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested balance. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate charged by persons in the business of lending money for loans that would be made under similar circumstances (current rates on loans range from 4.25% – 9.5%). Principal and interest is paid ratably at least as frequently as quarterly over a reasonable amount of time not to exceed five years (ten years for personal residence).

(1) **Description of the Plan:** (Continued)

(f) **Payment of benefits**—Upon termination of service due to death, retirement or other reasons, the participant or beneficiary may elect to receive a qualified joint and survivor annuity (limited to certain participants), or lump sum payment, the default method of payout is a lump sum distribution. Participants may make in-service withdrawals in the event of financial hardship. Participants who have terminated are identified at the end of the fiscal year and funds are available in the first quarter after year end.

(g) **Forfeited accounts**—As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$30,743 and \$26,922, respectively. These accounts will be used to reduce employer contributions or pay administrative expenses of the Plan. Forfeitures used to reduce employer contributions totaled \$26,921 and to offset administrative expenses totaled \$125 during 2024.

(h) **Administrative expenses**—The fund administrative expenses reduce the value of account balances of participants in the Plan. However, the Company has elected to pay certain significant operating expenses of the Plan, such as audit fees, on behalf of the Plan. The remaining plan administration and investment management fees reduce the participants' account balances (see Note 8). Expenses relating to specific participant transactions (i.e., loan setup, distribution request, etc.) are charged directly against the appropriate participant's account.

(i) **Plan amendments**—Effective January 1, 2025, the Plan was amended to increase the maximum auto enrollment escalation from 10% to 15%.

(2) **Summary of Significant Accounting Policies:**

(a) **Basis of accounting**—The accompanying financial statements of the Plan are presented on the accrual basis of accounting.

(b) **Investment valuation and income recognition**—Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Interest and dividend income are recorded when paid. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(c) **Notes receivable from participants**—Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. For terminated employees, delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

(d) **Payment of benefits**—Benefits are recorded against participant accounts when paid.

(e) **Use of estimates**—The process of preparing financial statements in conformity with generally accepted accounting principles requires the use of estimates and assumptions regarding certain types of assets, liabilities, revenues, and expenses. Such estimates primarily relate to unsettled transactions and events as of the date of the financial statements. Accordingly, upon settlement, actual results may differ from estimated amounts.

(2) **Summary of Significant Accounting Policies:** (Continued)

(f) **Subsequent events**—The plan has evaluated events and transactions for potential recognition or disclosure in the financial statements through October 2, 2025, the date the financial statements were available to be issued. Other than the plan amendment discussion at Note 1(i), there were no other subsequent events requiring recognition or disclosure.

(3) **Information Certified by the Trustee:**

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments and participant loans held at December 31, 2024 and 2023, and the net appreciation in fair value of investments and interest and dividend income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Trust Management Company (FTMC), a qualified institution and trustee of the Plan.

(4) **Investments and Fair Value Measurements:**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities in active markets, (2) quoted prices for identical or similar assets or liabilities in inactive markets, (3) inputs other than quoted prices that are observable for the asset or liability, and (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common stocks – Valued at the closing price reported on the active market on which the individual securities are traded.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market – Valued at the NAV of shares held by the Plan at year-end. The NAV is based on the underlying market value of the fund’s investments and other assets less the liabilities.

Common collective trust – Composed primarily of fully benefit-responsive investment contracts that are valued at the NAV of units of the bank collective trust. The NAV is used as the practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months’ notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

Self-directed brokerage accounts – Valued at the daily closing price as reported by the broker. Common stock, preferred stock, mutual funds and money market funds are registered with the Securities and Exchange Commission. Mutual and money market funds are required to publish their daily NAV and to transact at that price. The accounts held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(4) **Investments and Fair Value Measurements:** (Continued)

Investment earnings for amounts held in mutual funds and money market accounts reflect a combination of interest income, dividend income, realized gains and losses and unrealized gains and losses depending on the composition of the underlying investments. Contributions made by the Company shall be applied or invested in accordance with participant directed allocations.

(5) **Plan Termination:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

(6) **Income Tax Status:**

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's income tax returns for the past three periods are subject to examination by tax authorities and may change upon examination.

(7) **Risks and Uncertainties:**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of certain investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

(8) **Parties-in-Interest:**

FTMC is the custodian of the Plan assets (see Note 3) and derives fees based on the asset values, which are included in the net appreciation/depreciation in fair value of investments. FTMC provides third-party administrative services to the Plan, which are included in administrative expenses. BKS Financial Investments, LLC provides advisory services to the Plan, which are included in administrative expenses.
