Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the 401(K) Profit-Sharing Plan for Employees of Senior Citizens Home Assistance Service, Inc. (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Opinion

Notes to the Financial Statements

December 31, 2024 and 2023

(1) Description of plan

The following description of the 401(K) Profit-Sharing Plan for Employees of Senior Citizens Home Assistance Service, Inc. (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution plan which was adopted to provide retirement benefits for employees of Senior Citizens Home Assistance Service, Inc., SCHAS, LLC, and SCHAS Claiborne, LLC, (collectively, the "Plan Sponsor"). The Plan covers substantially all employees who are age eighteen or older (the "participants"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

(b) Contributions

Participants may voluntarily make qualified retirement contributions to the Plan which are deductible by the participants for federal income tax purposes under Section 401(k) of the Internal Revenue Code ("IRC"). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Employees may make contributions up to 100% of compensation, subject to IRC limits. Participants are automatically enrolled into the Plan at a 2% deferral rate with the ability to opt out or modify their contribution rate. A participant has the option to designate all or a portion of his or her elective deferral as Roth elective deferrals.

Each participant is eligible for employer matching contributions after one year of service in which the participant completes a minimum of 1,000 hours of service. The Plan Sponsor contributes employer matching contributions of 100% of participant contributions up to 2% of the participant's compensation. The Plan Sponsor may also elect to make a discretionary matching contribution to the Plan. Discretionary matching contributions of \$9,203 and \$11,037 were contributed for Plan years 2024 and 2023, respectively.

(c) Participant accounts

Each participant's account is credited (charged) with the participant's contributions, allocations of Plan Sponsor contributions, investment earnings (losses), and administrative expenses. Allocations are based on participant compensation or account balances as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) Vesting

Participants are immediately vested in their elective salary deferral plus actual earnings (losses) thereon. Vesting in the Plan Sponsor's contribution is based on years of continuous service and age. Participants vest after three years of credited service or after attaining the age of 55.

(e) Participant notes receivable

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. The loans are secured by the balances in the respective participants' accounts and bear interest at fixed rates (currently between 4.25% and 9.50%) which are commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest are paid ratably through payroll deductions.

(f) Payment of benefits

On termination of service due to death, permanent disability, or retirement, a participant may elect to receive either a lump-sum payment or installments over a specified period equal to his or her entire account. For termination of service due to other reasons, a participant will be entitled to receive only the vested interest in his or her account as a lump-sum distribution.

(g) Forfeited accounts

Forfeitures are created when participants terminate employment prior to becoming fully vested in the Plan Sponsor contribution portion of their accounts. Such forfeitures reduce the Plan Sponsor's future contributions to the Plan.

(h) Hardship withdrawals

The Plan permits distributions in the event of a hardship, as defined in the plan agreement. These distributions are taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant is younger than age 59½. Hardship withdrawals are limited to the participant's elective account balance.

(i) Administrative expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the processing of distributions are included in administrative expenses and charged directly to the participant's account. Fees incurred by the Plan for investment management services or record keeping are charged against, and are reflected in, the value of the Plan's investments. Other participant and transaction fees are paid by the Plan and are included in administrative expenses in these financial statements.

(j) Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

(2) Summary of significant accounting policies

(a) Basis of accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

(b) Investment valuation and income recognition

Investments are stated at fair value except for the investment in the insurance contract which is stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

(c) Participant notes receivable

Participant notes receivable are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant notes receivable are reclassified as distributions based upon the terms of the plan document.

(d) Payment of benefits

Benefits are recorded when paid.

(e) Use of estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(f) Events occurring after reporting date

The Plan Sponsor has evaluated events and transactions that occurred between December 31, 2024 and September 25, 2025, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

(3) Certified information

Certain information related to investments reported and disclosed in the accompanying financial statements and supplemental schedule of assets (held at end of year), including the fair and contract value of investments and participant notes receivable held at December 31, 2024 and 2023, net appreciation in fair value of investments, interest and interest income on participant notes receivable for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Mutual of America Life Insurance Company.

(4) Investments measured at net asset value using the practical expedient

The Plan's investments in pooled separate accounts are measured at net asset value ("NAV") as a practical expedient to estimate fair value and, therefore, have not been classified in the fair value hierarchy. The NAV is based on the market value of the underlying investments held by the pooled separate accounts at year end.

The following summarizes investments for which fair value is measured using the NAV as a practical expedient as of December 31, 2024 and 2023, respectively. There are no participant redemption restrictions for these investments.

The pooled separate accounts available to the Plan include the following significant types of investment strategies:

- Pooled separate accounts that seek to mirror the investment objectives and strategies of the underlying mutual fund for which the pooled separate account is named.
- Lifestyle funds including conservative, moderate, balance, growth and aggressive strategies which seek returns consistent with these investments styles.
- Target date funds that seek capital appreciation and current income consistent with asset allocation that become more conservative over time to the specified retirement date.

(5) Insurance contract

The Plan holds a fully benefit responsive insurance contract with Mutual of America Life Insurance Company. The insurance company maintains the Plan's contributions in the general account which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value, as reported to the Plan by Mutual of America Life Insurance Company. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The average crediting interest rate was approximately 3.00% for 2024 and 2.00% for 2023. Such interest rates are reviewed on a monthly basis for resetting. Participants may transfer amounts to or from the annuity contract in accordance with terms of the Plan, IRC and the contract. Mutual of America Life Insurance Company has certain rights to delay certain transfers and withdrawals for up to six months following the date of the request.

(6) Income tax status

The Plan Sponsor adopted a non-standardized pre-approved profit sharing plan, which received a favorable opinion letter from the Internal Revenue Service ("IRS") on November 30, 2020, which stated that the non-standardized pre-approved profit sharing plan was designed in accordance with the applicable sections of the IRC. The Plan itself has not received a determination letter from the IRS stating that the Plan is qualified under Section 401(a) of the IRC. However, the plan administrator believes that the adopted non-standardized pre-approved profit sharing plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and is therefore, qualified and exempt from taxation.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(7) Untimely remittance of participant contributions

The Plan Sponsor is required by Department of Labor regulation to remit participant contributions as soon as practicable, but by no later than the fifteenth business day following the end of the month in which the amounts were withheld from wages. For certain contributions totaling \$22,593 and \$30,775 during 2023 and 2022, respectively, the funds were not remitted on a timely basis. Imputed lost yearnings applicable to these contributions has been calculated and contributed to the plan in 2024.

(8) Related party and party-in-interest transactions

Certain plan investments are units of pooled separate accounts and an insurance contract managed by Mutual of America Life Insurance Company and, therefore, these transactions qualify as party-in-interest transactions under ERISA. As described in Note (1), the Plan paid expenses to various service providers which also qualify as party-in-interest transactions. The plan holds notes receivable from participants, which also qualify as party-in-interest transactions.
