NOTES TO FINANCIAL STATEMENTS

Note 1. Description of Plan

The following description of the Tom Nehl Truck Company Employees 401(K) Savings and Retirement Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan was established on January 1, 1995 and restated January 1, 2022. The Plan is a defined contribution plan covering all employees of the sponsoring companies (sponsors), excluding leased employees, who have thirty days of service and are age eighteen or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions:

Eligible employees are automatically enrolled, with five percent of compensation being contributed, although a participant may elect to defer a different percentage of their compensation as an elective deferral contribution. The sponsors may make a discretionary matching contribution on behalf of each participant. The amount of the matching contribution shall be determined annually by the sponsors' directors. Additionally, the sponsors may make a discretionary non-elective contribution each year as determined by the sponsors' directors which is allocated to each participant in the ratio that a given participant's compensation bears to the compensation of the total sponsoring company's plan participants.

Participant Accounts:

Each participant's account is credited with the participant's contributions and an allocation of (a) the sponsors' contribution, (b) Plan earnings, and (c) forfeitures of terminated participants' non-vested accounts and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. A participant is 100% vested after six years of service. Vesting in the sponsors' contributions portion of their accounts plus actual earnings thereon is based on years of continuous service as follows:

Note 1. Description of Plan (Continued)

Payment of Benefits:

On termination of service due to death, disability, retirement, or other reasons, a participant (or beneficiary) receives an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount or, if the benefits qualify as eligible rollovers, all or a portion of the benefits may be rolled over to another qualified plan or IRA.

Forfeited Accounts:

Forfeitures of non-vested company contributions may be used by the Plan as payment of Plan expenses. Any remaining forfeitures will be added to any employer discretionary matching contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$47,494 and \$57,936 respectively.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting:

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principals generally accepted in the United States of America.

Estimates:

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition:

The Plan's investments are stated at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits:

Benefits are recorded when paid.

Subsequent Events:

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through September 29, 2025, the date the financial statements were available to be issued.

Note 3. Investments

During the year ended December 31, 2024, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$1,842,776.

Note 5. Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2021, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently operated in compliance with the applicable requirements of the IRC.

Note 6. Fair Values Measurements

The Plan applies generally accepted accounting principles for fair value measurements of financial assets and liabilities. These accounting principles define fair value and establish a hierarchy that prioritizes fair value measurements based on the types of inputs used for the various valuation techniques. The three levels of inputs used to measure fair value are as follows:

- Level 1 - Values measured using quoted prices in active markets for identical investments.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, either directly or indirectly.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price, and are deemed to be actively traded, and are considered Level 1 investments.

Fixed account: reported based upon observable inputs, including the Plan's assumptions as to what market participants would use in pricing such instruments.

NOTES TO FINANCIAL STATEMENTS

Note 6. Fair Values Measurements (Continued)

Common collective trust fund: these funds are valued at the NAV of units of the collective fund. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the funds will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

Note 7. Fair Value of Investments in Entities that Use NAV Practical Expedient

The following table summarizes investments for which fair value is measured using the NAV per share practical expedient as of December 31, 2024 and 2023. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

The Plan recognizes transfers between the levels as of the actual date of the event or change in circumstances that caused the transfer. There were no gross transfers between the levels for the year ended December 31, 2024.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 8. Plan Termination

Although it has not expressed any intent to do so, the sponsors have the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 9. Party-in-Interest Transactions

Certain investments of the Plan are shares of funds managed by the members of Voya Retirement Insurance and Annuity Company. Voya Retirement Insurance and Annuity Company is considered the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan paid Voya Retirement Insurance and Annuity Company \$30,201 in 2024.

NOTES TO FINANCIAL STATEMENTS

Note 10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.
