### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

### (1) Description of Plan

The following description of the TA Realty LLC 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan which covers substantially all employees of TA Realty LLC and TA Digital Group, LLC (the Company or Employer) immediately upon their start date. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Plan Administrator is TA Realty. Fidelity Investments currently serves as recordkeeper and Fidelity Management Trust Company as Trustee of the Plan. The Plan's advisor is Alpha Pension Group (HUB International).

#### Contributions

Each year, participants may elect to contribute from 1% to 100% of eligible compensation or a specified dollar amount to be contributed each payroll period. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also designate a portion, or all of the deferral contributions made as Roth 401(k) contributions. Rollover contributions for eligible employees are also allowed. Participants direct the investment of their contributions into various investment options offered by the Plan. Pursuant to Internal Revenue Service (IRS) regulations, contributions are subject to limitations based on annual compensation limits.

Each year, the Company may also make a discretionary non-elective contribution to the Plan. Participants must be actively employed on the last day of the Plan year to receive the Company contribution. The non-elective contribution will be allocated among participants eligible to share in the contribution for the Plan year. For the year ended December 31, 2024, the Company declared the following discretionary contributions: i) for all Non-Highly Compensated Employees (NHCE) as defined by IRS regulations, the greater of 6% of a participant's total compensation or 10% of a participant's total compensation up to a maximum compensation of \$100,000 per participant, ii) for all Highly Compensated Employees (HCE) as defined by IRS regulations, 10% of a participant's total compensation up to a maximum compensation of \$100,000 per participant, and iii) for all TA Realty Partner participants, an additional \$36,000.

#### Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's contributions and Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants in the Plan are vested immediately in their contributions at the date of hire. Employer contributions and actual earnings thereon are subject to a vesting period. Participants earn vesting credit for the number of years the participant has worked for the Company, based on whole years worked. The vesting schedule is a four-year graded schedule, earning 25% each year and being 100% vested in employer non-elective contributions and earnings thereon after the completion of four years of credited service.

#### Forfeitures

Upon termination of employment, participants forfeit their nonvested portion of their employer account. Forfeited balances of terminated participants' nonvested accounts may be used to reduce Company contributions or to pay

administrative expenses. The balance of unallocated forfeitures as of December 31, 2024 and 2023 was \$2,031 and \$1,433, respectively. Forfeitures used to offset Company non-elective contributions were \$58,476 during 2024.

#### Participant Loans

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of the current value of the participant's vested interest in their account. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates, as determined by the Trustee. Principal and interest are paid through payroll deductions. Loan terms range from 1 to 5 years from the date of the loan, unless such loan is for the purchase of a participant's primary residence which has a repayment term of up to 10 years.

#### Payment of Benefits

Upon separation of service due to death, disability, termination or retirement, a participant may elect to receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account. In-service withdrawals are available in certain limited circumstances, as defined by the Plan. On an annual basis, the Plan Administrator reviews balances for separated employees and the Trustee cashes out any participants with a balance of \$1,000 or less. For those accounts with a balance between \$1,000 to \$7,000, the Trustee rolls those balances into an IRA. Participants are notified of the cash out or rollover prior to the advisor taking such action.

#### Administrative Expenses

Plan fees and expenses, including fees and expenses connected with providing administrative services by external service providers, are paid for by the Plan. Participants pay, through the Plan, transaction fees for borrowing from their accounts, obtaining investment advice, and redemption of investments when due under terms of the investment. Certain expenses are paid by the Company, such expenses are excluded from these financial statements.

#### Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, participants will become 100% vested in their accounts.

## (2) Summary of Significant Accounting Policies and Practices

#### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance, plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan payments and the Trustee deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded (Deemed Distributions). Deemed Distribution balances were \$0 as of December 31, 2024 and 2023.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates that affect the reported amounts in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

### Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). See Note 4 for further discussion and disclosures related to fair value measurements. Net appreciation of the fair value of investments includes realized gains and losses on investments sold during the year, as well as the current year change in unrealized appreciation and depreciation of investments held at the end of the year. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest is recorded as earned.

### Payment of Benefits

Benefits are recorded when paid.

### (3) Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information provided to the Plan Administrator and certified as complete and accurate by the Trustee.

### (4) Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level of input that is significant to the fair value measurement in its entirety.

Assets and liabilities measured and reported at fair value are classified and disclosed in one of the following categories:

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability.

Level 3 – Significant unobservable inputs for the asset or liability (i.e., supported by little or no market activity).

In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, an asset's or liability's level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Management's assessment of the significance of a particular input to the fair value measurement in its entirety requires judgment and considers factors specific to the asset or liability.

Publicly traded: Mutual funds are valued using quoted market prices in active markets.

### (5) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

### (6) Related Party and Party-in-Interest Transactions

The Plan paid \$29,088 to Fidelity Investments for recordkeeping fees and \$30,000 to Alpha Pension Group for their services as an Advisor during the year ended December 31, 2024.

The Plan holds mutual funds managed by Fidelity Management Trust Company, the Trustee of the Plan. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

### (7) Tax Status

The underlying pre-approved plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the written form of the underlying pre-approved document is qualified under Section 401 of the Internal Revenue Code (the Code). Any employer adopting this form of the plan will be considered to have a plan qualified under Section 401 of the Code, and, therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **(8) Subsequent Events**

Management evaluated subsequent events for the Plan through October 2, 2025, the date the financial statements were available to be issued. No significant events occurred through that date.
