## INDEPENDENT AUDITORS' REPORT

To the Trustees and Participants of  
City Furniture Profit Sharing Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of City Furniture Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise of the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of City Furniture Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

## NOTES TO FINANCIAL STATEMENTS YEARS ENDED DECEMBER 31, 2024 AND 2023

---

### 1. DESCRIPTION OF THE PLAN

The following brief description of the City Furniture Profit Sharing Plan is provided for general information purposes only. Participants should refer to the City Furniture Profit Sharing Plan (the “Plan”) agreement for more complete information.

**General** - The Plan was established effective November 1, 1981, and has since been amended and restated. The Plan is a defined contribution multiple-employer plan covering all employees of City Furniture and Kevin Charles Furniture (the “Company”) who have completed three months of service and are age eighteen or older. An employee shall become a participant on the first day of the quarter following the date the employee completes the age and service requirements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) as amended. The Plan allows for automatic deferrals and auto escalation.

**Contributions** – Participants may elect to contribute a percentage of their compensation into the Plan with pretax or post tax dollars, subject to certain Internal Revenue Code (IRC) limitations. Participants may also contribute amounts representing distributions from other qualified defined contribution plans. The Company may make a discretionary matching contribution. Discretionary matching contributions, if made, will be computed by the Company based on eligible compensation deferred into the Plan each Plan Year excluding Age 50 and Over Catch-Up Contributions. Participants must make deferral contributions and be employed on the last day of the contribution period to be eligible for any matching contribution. Contributions are subject to certain limitations. For the year ended December 31, 2023, the Company made a discretionary matching contribution of 50% of the employee’s contribution up to 2% of eligible compensation. For the year ended December 31, 2024, the Company did not make a discretionary matching contribution. Reconciliation adjustments of \$105 were transferred to the forfeiture account and posted as an employer contribution for the year ended December 31, 2024.

**Participant Accounts** - Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and (b) plan investment results. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the vested portion of his or her account balance. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

**Vesting** - Participants are 100% vested in all employer and employee contributions, plus any earnings thereon.

**Payment of Benefits** - On termination of service due to death, disability, or retirement, a participant may elect to receive (1) a lump-sum amount equal to the value of the participant’s vested interest in his or her account or (2) a direct rollover into an individual retirement account (IRA) or to another employer’s tax qualified plan. If a participant’s account balance is between \$1,000 and \$7,000, and the participant has not elected otherwise, the amount of the participant’s distribution will automatically be rolled over to an IRA established by an IRA provider selected by the Company. If the account balance is less than \$1,000, the amount of participant’s distribution will be distributed in a lump-sum. The Plan also allows hardship withdrawals in certain circumstances and active participants may take distributions from the Plan upon attainment of age 59 ½.

**Notes Receivable from Participants** – Participants may borrow from their fund accounts a minimum of \$1,000 but may not exceed a maximum of the lesser of \$50,000 or 50% of their vested account balances. Loan repayment periods are for a maximum of 5 years unless the loan is for the purchase of a primary residence. The loans are secured by the balance in the participant’s account and bear interest at a reasonable rate commensurate with the prevailing interest rate charged on similar commercial loans under like circumstances. Principal and interest are paid through payroll deductions. The Plan provides for single, lump-sum repayment at any time. Participants may not have more than one loan outstanding at any time.

**Forfeitures** - As of December 31, 2024 and 2023, forfeited invested accounts totaled \$0 and \$27, respectively. During the year ended December 31, 2024, excess employer contributions plus earnings of \$40,802 were used to pay plan administrative expenses.

**Plan Termination** - Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. The Plan administrator is responsible for distributing account balances in accordance with the provisions of the Plan and ERISA after payment of all administrative and liquidation expenses by the Trustee.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** - The financial statements have been prepared using the accrual basis of accounting.

**Investments Valuation and Income Recognition** – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the plan’s gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued unpaid interest. Interest income is reported on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

**Use of Estimates and Risks and Uncertainties**- The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts in the financial statements. Actual results could differ from those estimates. The Plan utilizes various investment instruments. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the financial statements.

**Cash and cash equivalents** – Cash and cash equivalents consist of uninvested cash and accrued income receivables with original maturities of three months or less.

**Payment of Benefits** – Benefits are recorded when paid. Corrective distributions payable generally represent the distribution of certain assets to employees in order for the plan to comply with ERISA nondiscrimination tests.

**Expenses** – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

**Subsequent Events** - The Plan has evaluated subsequent events through September 25, 2025, the date the financial statements were available to be issued.

### 3. CERTIFIED INVESTMENTS

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by the Company and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (FMTC), a qualified institution.

### 4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Significant other observable inputs other than level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual Fund:** The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (level 1 inputs).

*Collective Trusts:* The fair values of participation units held in collective trusts are based on the net asset values per unit as reported by the fund managers. The collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. TAX STATUS**

On June 30, 2020, the Internal Revenue Service (IRS) stated that the prototype adopted by the Plan, as then designed, qualifies under Section 401(a) of the IRC. Although the Plan has been amended since the original determination, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of

December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

## **6. PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain Plan investments are shares of mutual funds issued by FMTC or an affiliate of FMTC. FMTC is the Plan trustee and, therefore, these transactions and the Plan's payment of trustee fees to FMTC qualify as party-in-interest. Notes receivable from participants are also considered party-in-interest.

Certain professional fees related to the administration of the Plan were paid by the Company on behalf of the Plan. Certain administrative functions are performed by employees of the Company. No such officer or employee receives compensation from the Plan.

Investment management fees paid to parties-in-interest are reflected as reductions in the investment returns earned by the Plan on its investments.
