Opinion

We have audited the financial statements of the Lutron Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1. Description of Plan

The following description of the Lutron Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution and profit-sharing plan established by Lutron Electronics Co., Inc. (the Plan Sponsor) for the benefit of eligible employees. No minimum age or service requirement must be fulfilled to be eligible for the Plan, and eligible employees enter the Plan on their date of hire. In order to be eligible for the Plan Sponsor's discretionary profit-sharing contributions, an employee generally must be employed on the last day of the Plan year. The Investment Advisory Committee is responsible for oversight of the Plan. The Investment Advisory Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance inclusive of investment fees. The Investment Advisory Committee also monitors the appropriateness of all Plan administration fees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Auto-enrollment: The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their salary deferral rate set at 6% of eligible compensation and their contributions invested in an age-appropriate target date retirement trust, which serves as the Plan's Qualified Default Investment Alternative (QDIA) unless changed by the participant.

Auto-increase: The Plan also includes an auto-increase provision whereby participants are subjected to an annual automatic deferral rate increase of 1% until their deferral rate reaches 6% of eligible compensation. Participants may elect to discontinue their participation in the auto-increase at any time.

Contributions: Participants may elect to contribute up to 50% of their eligible compensation, as defined in the Plan, subject to an annual maximum dollar limitation as determined by government regulations. Participants are also permitted to contribute Roth after-tax deferrals to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing rollover distributions from other qualified plans.

Employer matching contributions are limited to 100% on the first 4% of an employee's salary deferral.

Annual profit-sharing contributions to the Plan are determined at the discretion of the employer. Employer discretionary profit-sharing contributions are allocated to the Plan's participants based upon the ratio of each participant's eligible compensation for the Plan year to total eligible compensation of all participants for the Plan year.

Participant accounts: Each participant's account is credited with the participant's contributions, employer's matching contribution, investment earnings, an allocation of the employer's discretionary profit-sharing contributions and any available forfeitures of terminated participant's nonvested balances of profit sharing. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balances.

Vesting: Participants are immediately vested in their contributions, employer matching contributions, and employer discretionary profit-sharing contributions plus actual earnings thereon.

Note 1. Description of Plan (Continued)

Notes receivable from participants: Participants may borrow from their accounts an amount equal to the lesser of (a) \$50,000 reduced by the excess, if any, of their highest outstanding balance of loans from the Plan during the one-year period prior to the date of the loan over their current outstanding balance of loans or (b) 50% of the vested interest of the participant's account balance in the Plan. Loan terms range from one to five years, or up to 10 years if purpose of the loan is for the purchase of a participant's primary residence. Loans are secured by the vested balance in the participant's account and bear fixed interest at the rate in effect at the inception of the loan. Interest rates range from 3.25% to 8.50% and loans mature through 2034. Payments on the loans are generally made ratably through payroll deductions.

Participant investment options: Participants must direct their salary deferral contributions and employer matching contributions to selected investments as made available by the Plan Administrator and determined by the Investment Advisory Committee of the Plan or be defaulted to the age appropriate QDIA. Participants may change their investment options at any time by logging onto their Plan account or contacting the Plan recordkeeper. Employer discretionary profit-sharing contributions are directed to the Profit Sharing Portfolio (Portfolio) by Plan design. The Investment Advisory Committee directs how profit-sharing contributions are invested in the underlying investments in this Portfolio. However, once employer discretionary profit-sharing contributions are made to the Plan, participants have the ability to transfer the funds to any available Plan investment option of their choice.

Payment of benefits: In the case of normal retirement, retirement due to permanent disability or termination of employment, participants may elect to receive the value of their vested interest, in accordance with the provisions of the Plan, in a lump-sum distribution or in installments. In the event of death, the beneficiary will receive the value of the participant's accumulated Plan benefits in a lump-sum or installment distribution.

Forfeited accounts: At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0 and \$17,455, respectively. During 2024, \$18,343 was used to reduce employer matching contributions.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan's management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from management's estimates.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make scheduled repayments and the Plan Administrator deems the participant to be in default, the participant's note receivable is reduced, and a benefit payment is recorded based on the terms of the Plan. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Contributions: Contributions from Plan participants, matching contributions and profit-sharing from the Plan Sponsor are recorded in the year in which participant compensation is earned.

Note 2. Summary of Significant Accounting Policies (Continued)

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Advisory Committee determines the Plan's valuation policies utilizing information provided by outside investment advisors. See Note 3 for additional information on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near-term, and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Payment of benefits: Benefits are recorded when paid.

Administrative expenses: Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Loan origination fees are charged to the participant. Investment-related expenses are included in net appreciation in fair value of investments.

Subsequent events: The Plan has evaluated subsequent events (events occurring after December 31, 2024) through October 1, 2025, the date the financial statements were available to be issued.

Note 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Note 3. Fair Value Measurements (Continued)

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market fund: Valued at cost that equals fair value.

Common investment trusts: Valued based on the net asset value (NAV) of units of the common investment trust. The NAV is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Registered investment companies (mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

RREEF American REIT II—The fund seeks to generate attractive, predictable investment returns from a target portfolio of low-risk equity investments in income-producing real estate while maximizing the total return to shareholders through cash dividends and appreciation in the value of its shares. Redemption requires notification 45 days prior to quarter-end and is subject to Board approval. On August 12, 2022, the Plan requested a total liquidation of the shares it holds in the fund. RREEF approved the request and has been providing quarterly redemption payments. Final liquidation of all shares is expected to be completed in late 2026 or early 2027 (at the earliest).

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits.

Note 4. Related-Party and Party-in-Interest Transactions

Certain Plan investments are invested in funds managed by T. Rowe Price. T. Rowe Price is the recordkeeper as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

The Plan Sponsor provides for all of the administrative expenses of the Plan.

Note 5. Plan Termination

Although management has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 6. Tax Status

The Plan has received its latest determination letter from the Internal Revenue Service, dated August 19, 2020, stating that the Plan, as then designed, is qualified under Section 401(k) of the Internal Revenue Code (the Code) and, therefore, the related trust is exempt of taxation. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes the Plan is designed, and is currently being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan, as amended, is qualified and the related trust is tax exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken any significant uncertain tax positions that more likely than not would be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
