## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of the  
Holt and Bugbee Company Retirement Savings Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Holt and Bugbee Company Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the Statements of Net Assets Available for Plan Benefits as of December 31, 2024 and 2023, and the related Statement of Changes in Net Assets Available for Plan Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### Opinion

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

**1. Description of the Plan**

The following description of the Holt and Bugbee Company Retirement Savings Plan (the Plan) is intended to provide only general information regarding the Plan. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

***General***

The Plan is a participant-directed defined contribution 401(k) plan covering all employees of Holt and Bugbee Company (the Employer) who are age 21 or older and have completed one year of eligible service, as defined in the Plan Agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is maintained by an administrator and a trustee. The administrator maintains participants' account records and instructs the trustee to execute transactions such as benefit payments to participants. The trustee reports to the Plan's management regarding investments and changes in those investments.

***Contributions***

Participants may elect to contribute a dollar amount or percentage of the participant's eligible compensation, on a pre-tax or after-tax basis, not to exceed the limits permitted by the Internal Revenue Service (IRS). Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (participant rollovers).

The Employer matches 50% of the participant's contribution to the Plan up to a maximum of 5% of the total participant's eligible compensation.

The Employer, with the consent of its board of directors, may make discretionary profit-sharing contributions to the Plan. A participant's share of this contribution is based on a compensation formula and contributions are subject to certain requirements and limitations. During 2024, the Employer did not elect to make any discretionary Employer contributions.

***Participant Accounts***

Each participant's account is credited with the participant's contribution and their allocation of the Employer's matching and discretionary profit-sharing contributions, the Plan's earnings and losses and investment expenses. The allocation of earnings and losses is performed based on individual participant account balances. The benefit to which a participant is entitled is the benefit provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their voluntary, rollover and Employer contributions, and actual earnings thereon.

***Payment of Benefits***

Benefits are available for distribution upon retirement, death, disability or termination in a single lump-sum distribution or in periodic installments, as elected by the participant or beneficiary. In the event of termination for any reason other than retirement, death or disability, payment of vested benefits will be made by the Plan Administrator in accordance with the procedures described in the Plan. If a participant's vested balance is less than \$1,000, the participant will receive an immediate cash-out of their vested account balance. Hardship withdrawals from the Plan are permitted subject to the applicable IRS laws and cannot exceed the amount required to meet the immediate financial need created by the hardship.

***Forfeitures***

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,852 and \$1,763, respectively. These accounts may be used to reduce future Employer contributions. For the year ended December 31, 2024, the Plan Administrator did not use any forfeited participant account balances to reduce Employer contributions.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

***Valuation of Investments and Income Recognition***

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 3).

Purchases and sales of investments are recorded on a trade date basis. Interest and dividend income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation included in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Contributions***

Employer matching and participant contributions are recorded weekly when the Employer remits the payroll deductions for investment into the Plan.

***Excess Contributions Refundable***

Amounts refundable to participants for contributions in excess amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributes the excess contributions to the applicable participants in the subsequent year.

***Payment of Benefits***

Benefits are recognized when paid to participants or their designated beneficiaries.

***Administrative Expenses***

Expenses incurred in the administration of the Plan are paid by the Employer unless the Employer directs that such expenses be paid by the Plan. Expenses that are paid by the Employer are excluded from these financial statements. Investment management and recordkeeping fees, if applicable, are paid by the Plan through revenue sharing as a reduction of investment income (net appreciation or depreciation) from the related investment fund.

***Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported changes in net assets. Accordingly, actual results may differ from those estimates.

***Risks and Uncertainties***

The Plan provides for various investment options with various investment objectives. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

The Plan invested in four mutual funds that accounted for approximately 72% and 70% of total Plan investments as of December 31, 2024 and 2023, respectively.

***Financial Instruments with a Concentration of Credit Risk***

The Plan's investments are held by a single trustee. The Plan's exposure to credit risk is associated with the outside trustee's non-performance of its fiduciary responsibilities relating to these amounts as specified in the agreements. Benefits provided by the Plan are not insured or guaranteed by the Pension Benefit Guaranty Corporation.

***Subsequent Events***

The Plan Administrator has evaluated subsequent events through September 30, 2025, which is the date these financial statements were available to be issued.

**3. Fair Value Measurements**

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy and inputs to the valuation methodologies are described as follows:

Level 1 inputs are unadjusted quoted prices in active markets for identical assets the Plan has the ability to access.

Level 2 inputs are other than quoted prices in active markets that are observable either directly or indirectly for the asset. Such inputs are derived principally from or corroborated by observable market data for similar assets by correlation or other means, over substantially the full contractual term of the asset, if applicable.

Level 3 inputs are unobservable and significant to the fair value measurement. Such inputs generally rely on the Plan's own assumptions about the assumptions that market participants would use in pricing the asset.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

*Cash and Cash Equivalents:* The carrying amounts of cash and cash equivalents are deemed to be valued at deposit amount plus accrued interest, as determined according to stated terms.

*Mutual Funds:* Valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

As of December 31, 2024 and 2023, the Plan's investments in cash and cash equivalents and mutual funds are reported at level 1 within the fair value hierarchy.

**4. Plan Termination**

The Employer expects to continue the Plan indefinitely. However, the Employer reserves the right to amend the Plan or contributions thereto, at any time and in any manner that it deems advisable, provided that no amendment shall have the effect of diverting Plan assets for purposes other than for the exclusive benefit of the Plan participants and any Plan termination would be subject to the provisions of ERISA.

In the event of Plan termination, the participants would become fully vested and entitled to receive all amounts credited to their accounts.

**5. Income Tax Status**

The Plan is an adoption of a prototype plan which received an opinion letter from the IRS dated June 30, 2020. The Plan has been amended since receiving the opinion letter in order to comply with the latest applicable tax laws and regulations. However, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**7. Related Party Transactions and Party-in-Interest Transactions**

Plan investments are held and managed by the trustee of the Plan. Therefore, these transactions qualify as party-in-interest transactions. The Plan made direct payments to Ascensus, LLC for administrative services totaling \$3,315 for the year ended December 31, 2024.

**8. Differences from Form 5500**

Differences between the Annual Return/Report of Employee Benefit Plan, Form 5500, and these financial statements are a result of different classifications between line items in the accrual basis financial statements. Total Plan assets are in agreement.
