INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee and participants of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is substantial likelihood that, individually or in the aggregate, they would influence the judgement made by a reasonable user based on the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of the Plan

The following description of the Mölnlycke Pension Plan (the Plan) provides only general information. Participants should refer to the Plan document, copies of which are available from the plan administrator, for a more complete description of the Plan's provisions.

General

The Plan is a non-contributory defined benefit plan that provides retirement benefits for eligible salaried employees and for certain hourly employees of Mölnlycke Health Care, Inc. (the Company or Plan Sponsor). All contributions to the Plan are made by the Plan Sponsor based on the actuarially determined financial requirements of the Plan and in a manner consistent with the requirements of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company elected to freeze the Plan effective April 30, 2005 (the freeze date) for the non-union participants who were covered by the Mölnlycke Health Care, Inc. Retirement Savings Plan. All non-union participants became 100% vested in their accrued benefits as of the freeze date. Retirement benefits under the Plan will not increase because of any service after April 30, 2005, although the amounts accrued through April 30, 2005 under the Plan's benefit formula will not be diminished. During 2006, the Company closed the location that employed all union participants and no new union employees will be eligible to enter the Plan. At December 31, 2024, approximately 10% of participants were union participants, none of whom are current employees.

Contributions

Contributions are based upon annual funding amounts actuarially determined such that the Plan will have sufficient assets with which to pay pension benefits to participants at the time they retire. As of December 31, 2024 and 2023, the Plan has met the minimum funding requirements of ERISA.

Benefits

Non-union participants with 5 or more years of service at the freeze date are entitled to annual pension benefits beginning at normal retirement age (65) equal to (a) 1.2% of their final 5-year average annual compensation at the freeze date for each year of service; and (b) 0.5% of their final average annual compensation at the freeze date in excess of the social security taxable wage base. Union participants are entitled to annual pension benefits beginning at normal retirement age (65) equal to \$17.50 per month multiplied by number of years of service at the freeze date. Participants who were receiving benefits as of the freeze date are fully vested after 5 years of service. Participants will receive their pension benefits in the form of a joint and survivor annuity. Participants may elect to receive the value of their accumulated plan benefits as a lump-sum distribution upon termination if the present value of the vested interest is less than or equal to \$5,000.

In addition to the normal retirement benefits, the Plan, under certain conditions as described in the Plan document, also provides for early retirement at ages 55-64, postponed retirement benefits, and deferred vested benefits.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, disclosure of contingent assets and liabilities, and the actuarial present value of accumulated Plan benefits at the date of the financial statements. Actual results could differ from those estimates, and such differences may be material to the financial statements.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

As of December 31, 2024 and 2023, respectively, the net increase in fair value of investments includes interest, dividends, and realized and unrealized gains and losses on those investments. Interest income is recorded when received.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses are paid by the Plan to the extent they are not paid by the Company. In 2024 and 2023, all administrative expenses and the Pension Benefit Guaranty Corporation (PBGC) payments were paid by the Company. The Company does not expect reimbursement for any expenses paid on behalf of the Plan. Fees incurred by the Plan for the investment management services are included in the net increase in fair value of investments as of December 31, 2024 and 2023, respectively.

Actuarial Present Value of Accumulated Plan Benefits

The actuarial present value of accumulated Plan benefits are those future periodic payments, including lump-sum distributions, that are attributable under the Plan's provisions to the service employees have rendered at the freeze date. Accumulated Plan benefits include benefits expected to be paid to: (a) retired employees and beneficiaries, (b) terminated and transferred employees with deferred vested benefits, (c) employees eligible for retirement and fully vested employees. Accumulated Plan benefits for participants are determined based upon the average of the highest five consecutive calendar years of compensation paid during the last ten years of participation in which the participant was credited with service at the freeze date. Benefits payable under all circumstances (retirement, death, and termination of employment), are included to the extent that they are deemed attributable to employee service rendered to the valuation date.

Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 7, 2025, which is the date the financial statements were available to be issued.

3. Information Certified by the Qualified Institution

All information in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and the net increase in fair value of investments for the years then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company, the Plan's qualified institution.

4. Investments

Investments are exposed to various risks, such as market, interest rate, currency, and credit risks. Market risks include U.S. and global events which could impact the value of Plan investments. Such events would include healthcare crises, such as a pandemic, international conflicts, supply chain disruptions, global monetary policy decisions, significant exogenous economic influences, significant cybersecurity attacks, etc. It is at least reasonably possible that changes in their fair values will occur in the near term and that such changes could materially affect participants' account balances.

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices for identical assets in inactive markets

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan’s own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Fair value in mutual funds is determined based on quoted market prices for the identical security in an active market (Level 1).

5. Benefit Obligations

The actuarial present value of accumulated Plan benefits is determined by a consulting actuary, Standard Retirement Services, Inc., and is the amount that results in applying actuarial assumptions to adjust the accumulated Plan benefits for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, withdrawal, or retirement) between the valuation date and the expected date of payment. The significant actuarial assumptions used in the valuation as of January 1, 2023 and 2024 were: (a) termination of participants at a range of rates based on employee age and years of service, (b) retirements occurring at various times between the ages of 55 and 65, (c) an assumed mortality rate based upon published statistics (RP-2014 with MP-2021 improvement scale for January 1, 2023 and 2024), and (d) an interest rate used for determining normal funding of 6% for 2023 and 2024. The foregoing actuarial assumptions are based upon the presumption that the Plan will continue in existence. If the Plan were to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated Plan benefits.

As of January 1, 2024, the mortality assumption changed from the 2023 IRS Optional Small Plan Combined Mortality Table to the IRS 2024 Small Plan Combined Static Mortality table. This change did not have a material impact on the overall actuarial present value of accumulated Plan benefits as of January 1, 2024.

Plan contributions are made, and the actuarial present value of accumulated Plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.

The Plan's Adjusted Funding Target Attainment Percentage (AFTAP), calculated under provisions of the Internal Revenue Code (IRC), was 101.13% at January 1, 2024. Accordingly, there are no restrictions on distributions for the year ended December 31, 2024.

6. Termination of the Plan

The Plan may be discontinued at the option of the Board of Directors of the Company subject to the provisions of ERISA. In the event of Plan termination, the net assets of the Plan will be allocated as prescribed by ERISA and its related regulations governing the priority order of participants' claims to the net assets of the Plan. To the extent unfunded vested benefits exist, ERISA provides that such benefits are payable by the PBGC, a U.S. Government agency.

In general, the PBGC will guarantee the payment of most vested normal retirement age benefits and early retirement age benefits that employees were receiving or were entitled to receive as of the date the Plan terminated. Such benefits, however, are only guaranteed to the extent of the actuarial value of the vested benefits as of the date the Plan terminated, payable in the form of a straight-life annuity commencing at age 65. Additionally, the total amount of such guaranteed benefits is subject to an overall ceiling that is adjusted periodically by the PBGC.

7. Income Taxes

The Plan obtained its latest determination letter on February 28, 2023, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable sections of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan's income tax returns for the past three years are subject to examination by taxing authorities and may change upon examination.

If after attaining age 55 and completing 10 years of Service, an unmarried participant dies while actively employed by the Employer or on an approved Leave of Absence, or a married participant who has elected (with spousal consent) out of the standard pre-retirement death benefit dies, then their beneficiary will be entitled to receive a death benefit for 60 months, equal to the benefit that would have been payable to the Participant had the Participant elected to retire with a single life annuity form of benefit.

None except as provided by the annuity form elected.
