We have performed audits of the accompanying financial statements of the Luck Bros., Inc. Profit Sharing/401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTES TO FINANCIAL STATEMENTS**

**1. DESCRIPTION OF THE PLAN**

The following brief description of the Luck Bros., Inc. Profit Sharing/401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution and savings plan covering all eligible employees. The Plan is subject to the provisions of the Employer Retirement Income Security Act of 1974 (ERISA).

Luck Bros., Inc. manages the operation and administration of the Plan. Empower Trust Company, LLC serves as the trustee of the Plan, and Empower Plan Services, LLC (d/b/a Empower) serves as the record keeper of the Plan and is responsible for the overall administration of the Plan, including maintaining participant account balances.

**Eligibility Requirements**

Participants who have attained the age of 21 are eligible to participate in the Plan. This age eligibility requirement was imposed effective May 1, 1998. Employees who previously entered the Plan as a participant will not be made ineligible to participate based on this requirement.

**Vesting**

The vested percentage in a participant's account is determined under the following schedule and is based on vesting years of service. All participants, however, are 100% vested upon reaching normal retirement age (age 59 1/2).

A participant has completed a year of service when (s)he has been credited with 1,000 hours of service during a plan year.

**Contributions**

**Salary Deferrals**

Plan participants may elect to reduce their compensation by a specific percentage or dollar amount not to exceed the dollar limit which is set by law and have that amount contributed to the Plan as a salary deferral. There are two types of salary deferrals: pre-tax 401 (k) deferrals and Roth 401(k) deferrals.

**Rollover Contributions**

At the discretion of the Plan administrator, once you become a participant you may be permitted to deposit into the Plan rollover distributions you have received from other retirement plans.

**Profit Sharing Contributions**

The employer may make discretionary profit-sharing contributions to eligible employees. Each year the employer will determine the amount of the discretionary percentage.

**(Continued)**

**Prevailing Wage Contributions**

If the work performed for the employer is subject to prevailing wage laws, then the employer will make contributions to the Plan to help satisfy the fringe benefit requirements by law. This contribution is 100% vested.

In accordance with Plan provisions, participants direct all contributions and earnings thereon among the current funds offered by the Plan.

**Forfeitures**

Forfeitures of terminating participants are used to first pay for the Plan expenses. Any remaining forfeitures will be used to reduce the Company's subsequent contributions to the Plan. As of December 31, 2024 and 2023, there were \$45,099 and \$17,349, respectively, in allocated forfeitures available to reduce Plan expenses and/or Company contributions.

During both 2024 and 2023, \$-0- was used to pay Plan expenses and \$-0- was used to reduce employer contributions.

**Participants' Accounts**

Participants' accounts are credited with the participant's allocable share of the employer contribution, if any, and Plan earnings or losses. Allocations of contributions are based on participant compensation, as defined by the Plan. Allocation of investment earnings or losses is based on account balances. The benefit to which a participant is entitled is equal to the vested portion of the participant's accounts.

**Pension Benefits**

Participants are entitled to receive retirement benefits equal to their account balance on attaining age 59 1/2. Distribution options are determined based on marital status as well as the elections a participant and his/her spouse may make. The Plan also provides for early and late retirement benefits, termination benefits, disability benefits, and death benefits.

If a Plan participant terminates employment for any reason other than retirement, death, or disability, (s)he is entitled to receive the vested portion of his account. Any non-vested portion becomes a forfeiture.

**Investment Options**

The Plan provides that contributions shall be invested in any one or more of the available investment accounts. Participants may change their investment options any time throughout the year via internet or direct phone access with Empower.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis Of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with the accounting principles generally accepted in the United States.

Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts, such as the Empower Investments Fixed Account and the Transamerica Stable Value Advantage Fund, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The statements of net assets available for benefits presents the contract value of the fully benefit-responsive investment contracts.

The statement of changes in net assets available for benefits is also prepared on a contract value basis.

**Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Reclassification Of Financial Statement Presentation**

Certain reclassifications have been made to the 2023 financial statements to conform with the 2024 financial statement presentation. Such reclassifications have had no effect on the net increase in net assets or net assets available for benefits previously reported.

**Investment Valuation And Income Recognition**

The Plan's investments, other than fully benefit-responsive investment contracts (FBRICs) are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

FBRICs are reported at contract value, which is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan invests in FBRICs through the Empower Investments Fixed Account.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable From Participants**

Loans are available to all participants and their beneficiaries on a uniform and non-discriminatory basis. The loans must be adequately secured and are limited to one-half of the vested account balance. Loans must be at least \$1,000 and each participant is limited to one loan. At December 31, 2024 and 2023 participant loans totaled \$298,896 and \$288,514, respectively.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. As of December 31, 2024, interest rates ranged from 4.16% to 9.5%. Principal and interest are paid ratably through bi-weekly payroll deductions. Delinquent participant loans are reclassified as distributions based on terms of the Plan Document.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan will distribute the excess contributions to the applicable participants.

**Payment of Benefits**

Withdrawals from the Plan are generally permitted when an employee terminates employment, retires, reaches the age of 59 ½, becomes permanently disabled, dies, or has a severe hardship, as defined under the Plan. A participant who becomes totally and permanently disabled becomes 100% vested in the Plan Sponsors' matching contributions and will be considered as terminated. In-service distributions and hardship withdrawals are made in accordance with applicable plan provisions.

**Risks And Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

**Plan Fees**

Plan fees are paid by the Plan.

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

**Events Occurring After Reporting Date**

The Company has evaluated events and transactions that occurred between December 31, 2024 and September 22, 2025 which is the date the financial statements were available to be issued, for possible disclosure and recognition in the financial statements.

**3. INFORMATION CERTIFIED BY TRUSTEE**

Under the Department of Labor's regulations, certain assets and related information held by a bank, trust company or similar institution, or insurance company, that is regulated and subject to periodic examination by a state or federal agency does not have to be audited, provided the plan administrator exercises this option and the institution holding the assets certifies the required information. Empower Life & Annuity Insurance Company of New York and Empower Trust Company, LLC, custodian of the trust, has provided certification as to the completeness and accuracy of the investments and notes receivable from participants presented in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023 and in the statement of changes in net assets available for benefits for years ended December 31, 2024 and 2023. The accompanying supplemental schedule also includes investment information certified by Empower Life & Annuity Insurance Company of New York and Empower Trust Company, LLC as being complete and accurate.

**4. INVESTMENT CONTRACTS WITH INSURANCE COMPANIES**

The Plan holds a fully benefit-responsive group annuity contract, the Empower Investments Fixed Account - Series Class I, with Empower Annuity Insurance Company of America. The Empower Investments Fixed Account - Series Class I is a general account product of Empower Annuity Insurance Company of America. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, and prevailing market conditions. The interest crediting rate is reset quarterly. As described in Note 2, contract value is the relevant measurement attribute for this fund. The average yield earned by the Plan for the years ended December 31, 2024 and 2023 was 1.56% and 1.34%, respectively.

Certain events limit the ability of the Plan to transact at contract value with Empower Annuity Insurance Company of America. Such events include premature termination of the contracts by the Plan, layoffs, Plan termination, bankruptcy, mergers, and early retirement incentives. The Plan does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable. There are no reserves against contract value for credit risk of Empower Annuity Insurance Company of America or otherwise.

The appropriate measure to use to value the Empower Investments Fixed Account investment choice's strengths are the issuer's financial ratings. The credit ratings for the insurance companies issuing contracts containing the Empower Investments Fixed Account investment choices are:

**5. FAIR VALUE**

As discussed in Note 2, the Plan uses the fair value measurement framework under U. S. Generally Accepted Accounting Principles.

***Fair Value Measurement***

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. The fair value hierarchy requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The three levels of inputs that may be used to measure fair value are:

**Level 1** – Assets include equity securities that are traded in an active exchange market, as well as certain money market instruments. Valuations are obtained from readily available pricing sources for market transactions involving identical assets.

**Level 2** – Observable inputs other than Level 1 prices such as quoted prices for similar assets; quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of assets.

**Level 3** – Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities. Level 3 assets include financial instruments whose value is determined using pricing models, for which the determination of fair value requires significant management judgement or estimation. As of December 31, 2024 and 2023, the Plan did not have such assets.

The following is a description of the valuation methodologies used for instruments measured at fair value:

*Money Market Account:* Stated at fair value, which approximates cost plus accumulated interest earnings less distributions to date.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The estimated fair value is subjective in nature and involves uncertainties and matters of significant judgment and, therefore, cannot be determined with precision. Changes in assumptions could affect these fair value estimates. The fair value estimates do not take into consideration the value of future business and the value of assets and liabilities that are not financial instruments.

*Group Annuity Contracts:* Valued at contract value. These are investments in the general accounts of Empower and the values are guaranteed. Regardless of the activity in the general fund, Empower pays the stated interest rates and backs the capital deposit where the “risk” is measured by the funds’ credit ratings.

Investments can be redeemed with no advance notice on any day which the New York Stock Exchange is open for trading.

**6. OTHER ASSETS**

Empower rebates certain amounts to the Plan based on a fee concession. This rebate is calculated on a monthly basis and credited to the Plan Expense Account (PEA), a suspense account used by Empower.

The Plan Expense Account may be used for Plan expenses or allocated to participants as additional income. For the years ended December 31, 2024 and 2023, Plan expenses of \$82,360 and \$73,736, respectively, were paid from the PEA and \$-0- was allocated to participants. The balances remaining in the PEA at December 31, 2024 and 2023 are included in Other Assets in the Statements of Net Assets Available for Benefits.

**7. EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

The Plan invests in pooled separate accounts managed by Empower, the Plan's custodian. These transactions qualify as exempt party-in-interest transactions. Fees for investment management services are not paid by the Plan from Plan assets, but reduce the amount of income available for distribution to the Plan.

**8. SUBSEQUENT EVENTS**

Management has evaluated subsequent events through the date that the financial statements were available to be issued. There were no events that met the criteria for accrual or disclosure.

**9. TAX STATUS**

The IRS has determined and informed the Plan sponsor by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.
