Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental schedules listed in the table of contents are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to, or is derived from, the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to, or is derived from, the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Note 1. Description of the Plan

General

The following description of Day Kimball Hospital Defined Contribution Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by Day Kimball Hospital (Hospital) covering salaried and hourly employees of the Hospital and Day Kimball Medical Group, Inc. (DKMG), and employees of Physician Practices of Northeast Connecticut, LLC (Physician Practices), which is a wholly owned subsidiary of the Hospital. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Contributions

The Plan permits non-highly compensated employees through a salary deferral election to have the Hospital make annual contributions up to the maximum allowed by the Internal Revenue Code as a pre-tax or Roth deferral. Highly compensated employees may defer any amount up to 6% of compensation. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions.

For employees age 21 and older and with one year of service, the Hospital may make a discretionary matching contribution equal to 50% of eligible employee's contributions up to 6% of compensation. Employees participating in the elective deferral portion of the Plan are eligible for the discretionary matching contribution once credited with 1,000 hours of service in the plan year, as long as they are employed on the last day of the plan year (unless termination during the year was due to normal retirement, disability, or death). The Hospital may also make an additional discretionary nonelective contribution to employees credited with one year of service.

Contributions are subject to certain limitations.

Participant Investment Account Options

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily. During November 2024, the Plan's investment committee authorized the replacement of the Plan's risk-based model portfolio options with target date funds. In order to properly execute the fund changes, there was a temporary blackout period from November 12 to November 15, 2025. During the blackout period, affected participants could not access their accounts, make changes to their investments or take distributions.

Participant Accounts

Each participant's account may be credited with the participant's contributions as well as the Hospital's contribution and plan earnings. Participant accounts are also charged with an allocation of administrative expenses as defined by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are 100% vested in their elective deferral, rollover, and employer matching contributions plus earnings thereon. Vesting in discretionary nonelective contributions is based on years of continuous service. Participants are 100% vested in these accounts after three years of service. Additionally, participants who were employed prior to December 31, 2008, were 100% vested in all of their accounts. For actively employed participants, all contributions are immediately vested at early retirement date or upon termination due to death or total and permanent disability.

Payment of Benefits

Participants can request distributions upon the attainment of normal retirement age (the later of age 65 or the fifth anniversary of the date of which an individual becomes a participant) or termination of service. The Plan also provides for early retirement upon attainment of age 55 and completion of five years of service. Participants can request distributions of their vested account balances in the form of lump sum, installment, or partial payments as defined by the Plan. Terminated participants with vested account balances that are not more than \$1,000 will receive a lump-sum distribution. Withdrawals other than for retirement or termination are permitted under certain circumstances.

At December 31, 2024 and 2023, plan assets include \$8,000 and \$8,157, respectively, allocated to accounts of terminated or retired participants who have elected to withdraw from the Plan but have not yet been paid.

Notes Receivable from Participants

The plan document includes provisions authorizing loans from the Plan to eligible participants. The minimum amount of a loan is \$1,000, while the maximum is determined by the lesser of \$50,000 or 50% of a participant's vested account balance. Loan terms range from one to five years, not to exceed five years (except for loans for purchase of a primary residence) and are repaid through payroll deductions. The loans are secured by the balance in the participant's account and bear interest at a rate of the prime rate plus 1% as determined quarterly by the plan administrator.

Forfeited Accounts

Forfeiture accounts may be used to reduce future employer contributions or to pay plan expenses. For 2024 and 2023, there was no forfeiture account activity and forfeited nonvested accounts totaled \$0 as of December 31, 2024 and 2023.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held at year-end.

The Plan's interest in the collective investment trust is valued based on information reported by the investment advisor using the audited financial statements of the collective trust at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document.

Transfers to Other Plans

Highly compensated employees' contributions in excess of 6% of compensation during 2023 and 2022 were transferred to the affected participants' accounts in the Hospital's Section 403(b) Plan during 2024 and 2023, respectively.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

The Plan established a nonallocated plan expense account to pay necessary and reasonable plan related expenses in accordance with the Department of Labor's guidance. The Hospital is responsible for determining what expenses the third-party administrator will reimburse from the account. All funds utilized from this account are treated as administrative expenses on the statement of changes in net assets available for benefits. During 2024 and 2023, increases to the account from revenue sharing and related income were \$182,699 and \$162,427, respectively. During 2024 and 2023, respectively, administrative expenses of \$215,630 and \$191,313 were paid from the account. The account's balance at December 31, 2024 and 2023, was \$3,847 and \$36,306, respectively, and is included in the mutual funds balance on the statements of net assets available for benefits.

Administrative expenses may be paid by the Hospital or the Plan, at the Hospital's discretion.

Note 3. Certification of Plan Custodian

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at year-end) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

Level 1 Quoted prices in active markets for identical assets or liabilities.

Level 2 Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities.

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. Level 1 securities include mutual funds which are valued at the net asset value (NAV) of shares held at year-end. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

Investments Measured Using the Net Asset Value per Share Practical Expedient

The following table summarizes investments for which fair value is measured using the net asset value per share practical expedient as of December 31, 2024 and 2023. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan. This fund files a Department of Labor Form 5500 as a direct filing entity.

For financial statement reporting, revenue sharing credits are netted against administrative expenses. For Form 5500 purposes, administrative expenses are shown gross of revenue sharing credits and those credits are included in net investment gain.

Note 6. Related Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain plan investments are a mutual fund managed by an affiliate of Charles Schwab Trust Bank, the custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions.

The Plan incurs expenses related to general administration, investment advisory, and record-keeping. Direct fees paid by the Plan to the third-party service providers totaled \$229,972 and \$204,790 for the years ended December 31, 2024 and 2023, respectively. The Hospital provides certain administrative services at no cost to the Plan.

Note 7. Nonexempt Transactions

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets. While the Hospital has remitted all employee contributions to the Plan, contributions of \$903 and \$462 were not remitted within the required time period for the years ended December 31, 2024 and 2023, respectively.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9. Plan Termination

Although it has not expressed an intention to do so, the Hospital has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA.

Note 10. Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a pre-approved profit-sharing plan document sponsored by CCH Incorporated, DBA ftwilliams.com. The profit-sharing plan document has obtained an advisory letter from the Internal Revenue Service stating the plan document satisfies the requirements under Section 401 of the Internal Revenue Code. The Plan has not obtained or requested a determination letter. However, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 11. Subsequent Events

Subsequent events have been evaluated through October 6, 2025, which is the date the financial statements were available to be issued.

Plan Amendment

Effective January 1, 2025, the Plan was restated and amended to remove the age 21 eligibility requirement for participation in the Plan's discretionary employer contributions.
