## INDEPENDENT AUDITOR'S REPORT

**To the Plan Administrator of  
Brighton Health Plan Solutions, LLC 401(k) Retirement Plan**

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Brighton Health Plan Solutions, LLC 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (financial statements).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

## *NOTES TO FINANCIAL STATEMENTS* *DECEMBER 31, 2024 AND 2023*

### **1. DESCRIPTION OF PLAN**

The following description of the Brighton Health Plan Solutions, LLC 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan formed effective January 1, 1994. The Plan was most recently restated effective January 1, 2021. The Plan covers substantially all employees of Brighton Health Plan Solutions, LLC (the “Company”) who are not non-resident aliens and are not temporary employees/interns of the company. The eligibility requirements for employee and employer contributions are eligible employees who are 21 years of age and who have completed two months of service for employee and employer matching contributions and six months of service for non-elective contributions. The entry dates for Plan participation the first day of the calendar month coincident with or next following the date eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

#### **Contributions**

The Plan allows for both pre-tax salary deferrals and roth deferrals. Participants who have attained age of 50 before the end of the Plan year are eligible to make catch-up contributions. Employees may rollover eligible amounts from other qualified plans to the Plan which are fully vested and non-forfeitable. Participants direct the investment of their balances into various investment options offered by the Plan. The Plan includes an automatic enrollment feature under which newly eligible employees are automatically enrolled in the plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested in the participant’s investment choice, or into the Plan’s Qualified Default Investment Alternative (“QDIA”). The Plan has elected the American Funds Target Date Retirement Fund series as its QDIA.

The Company may make a matching contribution equal to 50% of the participant’s elective deferral that does not exceed 4% of the participant’s eligible compensation. The Company may also make a discretionary non-elective contribution in a percentage as determined by the Company. For the year December 31, 2024 the Company made a matching contribution of approximately \$748,000. For the year ended December 31, 2024 the Company made a non-elective contribution of approximately \$1,340,000 based on 3.25% of the participant’s eligible compensation. Contributions are subject to certain statutory limitations.

### **Participant Accounts**

Each participant's account is credited with the participant's contribution, an allocation of the Company's matching contribution and discretionary non-elective contribution, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's matching contribution and discretionary non-elective contribution portions of their accounts is based on years of continuous service as follows:

### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 minus the difference between the highest outstanding balance of loans in the past 12 months and the outstanding balance of loans from the Plan on the date the loan is made, or 50 percent of their vested account balance. Notes receivable from participants are secured by the balance in the participant's account. The default loan interest rate is the prime rate plus 1.5%. The interest rate on outstanding loans is 4.75% to 10.00% per annum. Principal and interest is paid ratably through payroll deductions.

### **Payment of Benefits**

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive a lump sum amount equal to the vested value of his or her account. The Plan permits in-service withdrawals upon attainment of age 59½ and hardship distribution, as defined in the Plan document.

### **Forfeitures**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$55,151 and \$54,759, respectively. The Company uses forfeited amounts to reduce employer

contributions or administrative expenses of the Plan. For the year ended December 31, 2024, \$160,757 were used to reduce employer contributions.

### **Revenue Credit Account**

At December 31, 2024 and 2023, the revenue credit account totaled \$95,715 and \$79,703, respectively. The Company uses revenue credit amounts to reduce employer contributions or pay administrative expenses of the Plan. For the year ended December 31, 2024, \$59,269 were used to pay administrative expenses.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the plan's gains and losses on investments bought and sold as well as held during the year.

### **Contributions**

Contributions from Plan participants and employer contributions from the Company are recorded in the year in which participant compensation is earned.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan document.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net change in fair value of investments.

## **3. CERTIFIED INFORMATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments at fair value, investments at contract value, and notes receivable from participants held at December 31, 2024 and 2023, and net change in fair value of investments, interest and dividends, and interest income from notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Life & Annuity Insurance Company of New York ("Empower Life") and Empower Trust Company, LLC, the insurance company and custodian of the Plan, respectively.

## **4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

### **Mutual Funds**

Valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are deemed to be actively traded.

Gains and losses included in the statement of changes in net assets available for benefits for the year ended December 31, 2024, are reported in net change in fair value of investments.

For the year ended December 31, 2024, there were no significant transfers between Level 1 and 2 and no transfers into or out of Level 3.

### **5. GROUP ANNUITY CONTRACT WITH EMPOWER LIFE**

In 2014, the Plan entered into a fully benefit-responsive group annuity contract with Great-West Life & Annuity Insurance Company (now called Empower Life). Empower Life maintains the contributions in the Key Guaranteed Portfolio Fund, which is a part of Empower Life's general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The group annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting rate is reviewed on a quarterly basis for resetting.

Because the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. The group annuity contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Empower Life, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, were \$1,357,836 and \$1,250,364.

Certain events limit the Plan's ability to transact at contract value with Empower Life. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction

exemption under ERISA, or (e) premature termination of the contract. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

### **6. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS**

Associated Pension Consultants, Inc. ("Associated Pension") is the third party administrator of the Plan and therefore certain transactions qualify as exempt party-in-interest transactions. Administrative fees of approximately \$36,300 were paid to Associated Pension from the Plan during the year ended December 31, 2024.

Empower Life is the recordkeeper of the Plan and therefore certain transactions qualify as exempt party-in-interest transactions. Administrative fees of approximately \$12,300 were paid to Empower Life from the Plan during the year ended December 31, 2024.

Empower Advisory Group, LLC ("Empower Advisory") is the investment advisor of the Plan and therefore certain transactions qualify as exempt party-in-interest transactions. Administrative fees of approximately \$13,300 were paid to Empower Advisory from the Plan during the year ended December 31, 2024.

Lilling & Company LLP ("Lilling") is the independent auditor of the Plan and therefore certain transactions qualify as exempt party-in-interest transactions. Administrative fees of approximately \$16,200 were paid to Lilling from the Plan during the year ended December 31, 2024.

The Plan's service agreement with Merrill Lynch, Pierce, Fenner & Smith Incorporated ("Merrill Lynch") includes a revenue credit program. If the total fees to Merrill Lynch are less than the Investment-Related Fund Revenue, as defined, to be received by Merrill Lynch with respect to the Plan for such quarter, Merrill Lynch shall remit to the Plan the amount exceeding such fees. These amounts are allocated to the revenue credit account. For the year ended December 31, 2024, the Plan received approximately \$74,000 in revenue credits which has been recorded as other income on the statement of changes in net assets available for benefits.

### **7. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

### **8. TAX STATUS**

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (“IRS”) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however there are currently no audits for any tax periods in progress.

### **9. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.
