### Opinion

We have audited the accompanying financial statements of the IP VEBA Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of IP VEBA Plan & Trust as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. **NOTE 1 - DESCRIPTION OF PLAN**

The following description of IP VEBA Plan & Trust (the Plan) provides only general information about the Plan's provisions. Participants should refer to the plan agreement for a more complete description of the Plan's provisions, copies of which may be obtained from the plan sponsor.

**General**

The Plan provides health and other benefits to eligible employees of IP Corporation (Company) with an average of at least 30 hours per week of service, and covered dependents. Employees become eligible upon 60 days of service and can enter the Plan on the first day of the following month.

Certain Plan assets are held in a voluntary employees' beneficiary association (VEBA) trust. The Plan is subject to the provisions of the Employee Retirement Security Act of 1974, as amended (ERISA).

**Benefits**

The Plan provides health benefits (medical, vision, dental, and prescription drugs), uninsured short-term disability benefits, vacation, sick, and holiday benefits to participants and covered dependents. The Plan does not provide postretirement benefits. The Plan also provides for the payment of union medical benefits.

The Plan provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA). Terminated employees that elect to receive COBRA benefits must pay the full cost of the coverage.

**Insured Benefits**

The Plan fully insures vision benefits. The Company purchases annual insurance contracts for these insured benefits. Premiums for vision insurance programs are paid to the insurance company from both the general assets of the Company as well as the assets of the VEBA trust. The Plan also makes payments for certain union medical benefits which are fully insured.

**Stop Loss Coverage**

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

**Self-Insured Benefits**

All other plan benefits are self-insured. The claims for self-insured benefits (other than vision and certain union medical plans) are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processor pays claims directly to or on behalf of participants and is then reimbursed by either the Plan's VEBA trust or the general assets of the Company. Despite the Plan's utilization of third-party claims processors, the ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan utilizes a pharmacy benefit manager (PBM); however, refunds based on the Plan's actual utilization pattern of specific drugs are retained by the PBM in accordance with the ASO agreement.

**NOTE 1 - DESCRIPTION OF PLAN**

**Contributions**

In addition to deductibles and copayments, participants contribute specified amounts based on the applicable monthly premiums for their respective benefit elections. The Company and employee contribution rates are determined annually. Employees may contribute specified amounts to extend coverage to eligible dependents. The Plan pays the full cost of stop loss insurance.

The Company makes contributions to the Plan as needed to fund claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting and Use of Estimates**

The accompanying financial statements have been prepared using the accrual basis of accounting. The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Payment of Benefits**

Premiums, paid by either the Company or the VEBA trust, are recorded as premium payments in the accompanying statement of changes in net assets available for benefits.

Vacation, sick and holiday benefits, paid by either the Company or the VEBA trust, are recorded as leave time paid in the accompanying statement of changes in net assets available for benefits.

Claim payments are recorded when paid by the third-party claim's processor. These payments are recorded as claims paid in the accompanying statement of changes in net assets available for benefits.

**Stop Loss**

Premiums for stop loss insurance are included in premium payments in the accompanying statement of changes in net assets available for benefits. Stop loss refunds of approximately \$1,629,000 have been netted with claims paid in the accompanying statement of changes in net assets.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan trustees determine the Plan's valuation policies and procedures. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

**Credit Risk**

Financial instruments which potentially subject the Plan to concentrations of credit risk consist principally of cash. The Plan places its cash with high credit quality financial institutions and, by policy, generally limits the amount of credit exposure to any one financial institution. The Plan had a credit risk concentration as a result of depositing approximately \$6,096,000 of funds in excess of insurance limits in a single bank.

**Subsequent Events**

Management has evaluated subsequent events for the Plan through October 3, 2025, the date the financial statements were available to be issued.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to the unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Observable inputs such as unadjusted quoted prices in active markets,

Level 2 - Inputs, other than quoted prices in active markets, that are observable either directly or indirectly; and,

Level 3 - Unobservable inputs where there is little or no market data, which requires the reporting entity to develop its own assumptions.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Interest-Bearing Cash:* Amounts are reported at cost, including accrued interest, which approximates fair value.

**NOTE 4 - BENEFIT OBLIGATIONS AND CLAIMS INCURRED BUT NOT REPORTED**

Plan obligations at December 31, 2024 and 2023 for claims incurred but not reported are estimated by the Plan's management based on claims data provided by the Plan's third-party claims administrators. These amounts are paid by the Plan only if claims are submitted and approved for payment.

**NOTE 5 - ADMINISTRATIVE EXPENSES**

The Plan pays the majority of the administrative expenses, which consist primarily of administrative fees paid to third-party claims administrators and stop loss premiums. The Company pays all remaining administrative expenses on behalf of the Plan, which consist primarily of professional fees.

**NOTE 6 - TAX STATUS**

The VEBA trust funding certain benefits of the Plan received an exemption letter from the IRS dated December 12, 2016, stating that the trust is tax-exempt under the provisions of Section 501(c)9 of the Internal Revenue Code (IRC). However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded for the year ended December 31, 2024 for unrelated business taxable income.

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 - PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of, participants to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

**NOTE 8 - RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS**

As described in Notes 1 and 5 the Plan has several arrangements with service providers. These transactions are party in interest transactions under ERISA.

**NOTE 9 - RISKS AND UNCERTAINTIES**

The value of benefit obligations are reported based on certain assumptions pertaining to health care rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term could be material to the financial statements.
