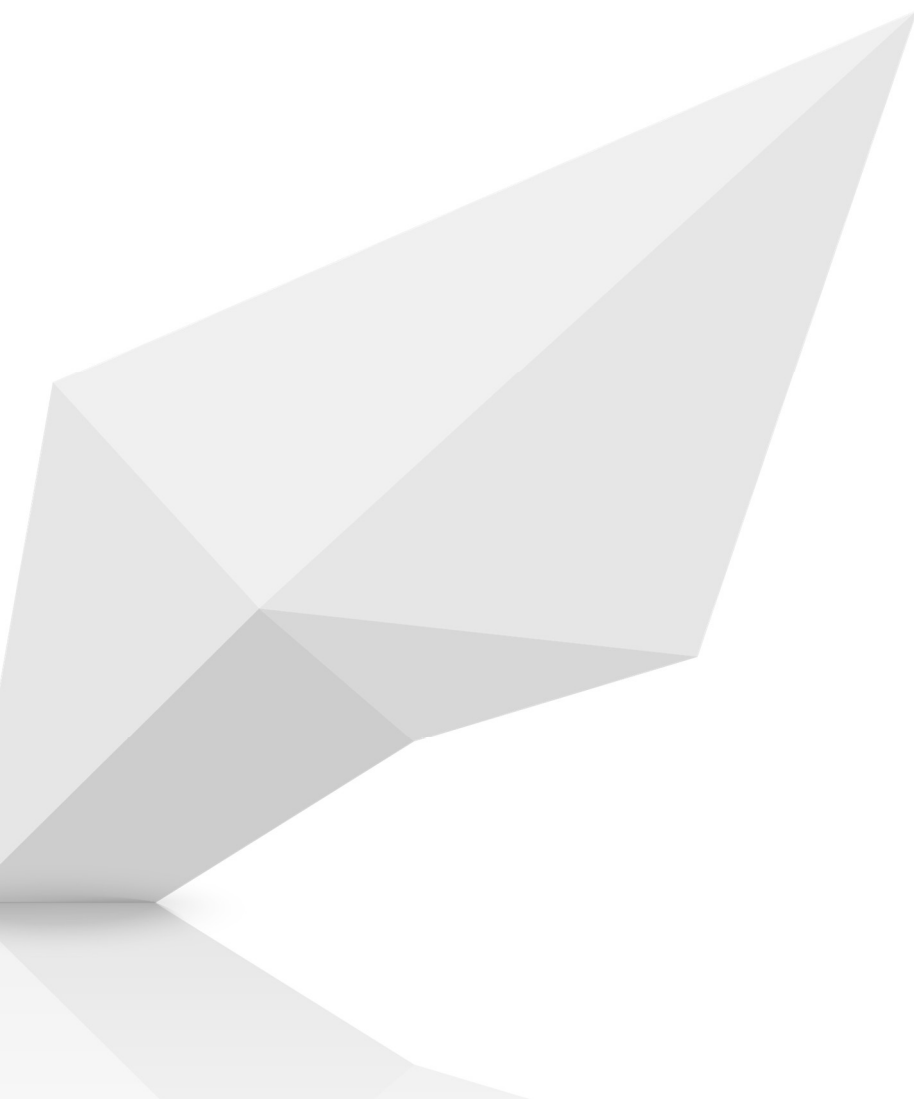

## **Independent Auditor's Report**

### ***Opinion***

We have audited the accompanying financial statements of Level 10 Employee Stock Ownership Plan (the "Plan") an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

### Note 1: Description of Plan

The following description of the Level 10 Employee Stock Ownership Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### General

The Plan, which was established on February 1, 2016, is a leveraged employee stock ownership plan which is designed to provide eligible employees the opportunity to participate in ownership of their employer. Level 10 Holdings Company ("Level 10" or "Sponsor") is the Sponsor of the Plan. The Plan is intended to satisfy the requirements of an Employee Stock Ownership Plan (ESOP), as defined under Section 4975(e)(7) of the Internal Revenue Code (IRC), and as a stock bonus plan under Section 401(a) of the IRC.

On March 31, 2016, the Plan purchased the stock of Level 10 by issuing a loan to Level 10 (the "Stock Purchase"). The Stock Purchase resulted in the Plan owning 100% of the outstanding shares of the Sponsor's common stock ("Level 10 Stock"). All shares are held in a trust (the "Trust") established under the Plan.

The Plan's note payable to Level 10 is collateralized by unallocated shares of Level 10 Stock. Level 10 has no rights against shares once they are allocated under the Plan. Accordingly, the financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to: (a) the accounts of participants with vested rights in allocated stock ("Allocated") and (b) stock not yet allocated to participants ("Unallocated").

#### Plan Administration

Level 10's Board of Directors serves as fiduciary of the Plan and has the responsibility to appoint, monitor, and oversee the Plan Trustee. An independent third party, James R. Urbach of ESOP Fiduciaries, Inc., serves as Trustee of the Plan. The Trustee oversees the valuation process and the accounting of the Plan's transactions pertaining to the accounts of participants with vested rights in Allocated and Unallocated stock. Principal Life Insurance Company is the recordkeeper and custodian of the Plan's assets.

#### Eligibility

Substantially all employees of the Sponsor are eligible to participate in the Plan upon attaining the age of 21 and completing a 12-consecutive-month period of employment during which at least 1,000 hours of service is worked. An employee who is eligible becomes a participant on the first day of the first or seventh month of the year immediately following the attainment of the above eligibility requirements.

#### Contributions

For each Plan year, the Sponsor is obligated to make contributions in cash to the Plan equal to the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its note payable. The amount contributed for the years ended December 31, 2024 and 2023, resulted in allocating approximately 5,166 and 5,258 shares at a value of \$213.12 and \$202.04, respectively. The terms of the note payable agreement between the Trust and the Sponsor require annual principal payments of \$66,700 plus interest accrued at a rate of 2.33%.

Participants eligible to receive an allocation of Level 10 Stock and, if applicable, discretionary cash or stock contributions for any Plan year, shall include only those participants who are eligible employees on the last day of the Plan year.

Employee contributions are not permitted.

#### Participant Accounts

Each participant's Employee Stock Ownership account is credited as of the last day of each Plan year with an allocation of shares of Level 10 Stock released by the Trustee from the unallocated account, forfeitures, Plan net income, and the Plan's discretionary cash contributions, if any. 40 percent of allocations are to be allocated on a pro rata basis based on eligible compensation. The remaining 60 percent is allocated equally among all eligible participants. Participants are entitled to their vested account balance.

#### Vesting

Vesting is based on the number of years of service as shown by the following:

Participants are considered to have completed one year of service for purpose of vesting upon the completion of 1,000 hours of service at any time during a calendar year.

If participants terminate due to normal retirement, death or disability, as defined by the Plan, they become 100% vested in their entire account balance as of their termination date.

#### Forfeitures

Forfeitures are portions of participant account balances that participants surrender by terminating employment prior to becoming fully vested. 40 percent of forfeitures are to be allocated on a pro rata basis based on eligible compensation. The remaining 60 percent is allocated equally among all eligible participants. There were forfeitures of \$0 and \$779 allocated during 2024 and 2023, respectively. Unallocated forfeitures were \$0 and \$80 as of December 31, 2024 and 2023, respectively.

#### Funding

The Sponsor remits contributions to the Plan annually.

#### Payment of Benefits

Upon termination of service due to death, disability, retirement, or other termination of employment, a participant or a participant's beneficiary may elect to receive an amount equal to the value of the participant's vested interest in his or her account in the form of cash. The payments may be made in either a lump-sum amount or in substantially equal annual installments generally over a period not to exceed five years plus one additional year for each \$210,000 the nonforfeitable balance exceeds \$1,070,000. Benefits paid to participants during the years ended December 31, 2024 and 2023, were \$22,915 and \$29,805, respectively.

#### Diversification

Diversification is offered to participants who are at least 55 years old and have participated in the Plan for at least 10 years (a "Qualified Participant") so they may have the opportunity to allocate part of the value of their investment in the Sponsor's stock into other investments. During each of the first five years of eligible diversification, eligible participants may elect to receive a cash distribution of up to 25% of the total number of shares in Level 10 Stock that have been allocated to the participant during the qualified election period (reduced by the number of shares of Level 10 Stock previously distributed in cash pursuant to a prior election). In the sixth year of eligible diversification, the percentage of shares that can be distributed increases to 50%.

#### Voting Rights

In general, voting rights with respect to all shares of Level 10 Stock are exercised by the Plan's Trustee.

#### Put Option

Level 10 Stock includes a put option. The put option is a right to demand that the Sponsor buy any shares of their stock distributed to participants for which there is no market. The put price is representative of the fair value of the stock. The purpose of the put option is to ensure that participants have the ability to ultimately obtain liquidity.

#### **Put Option (Continued)**

The Sponsor can pay for stock that is put to them over a period of five years. No shares of the Level 10 Stock have been distributed to any participant and accordingly, the Sponsor has no current obligation to repurchase any shares from participants.

#### **Administrative Expenses**

Administrative expenses of the Plan are generally paid by the Sponsor and excluded from these financial statements.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States (GAAP).

#### **Use of Estimates in Preparation of Financial Statements**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Management considers the fair value of the investment in Level 10 Stock to be a significant estimate. Actual results may differ from these estimates.

#### **Investment Valuation and Income Recognition**

The shares of Level 10 Stock are reported at fair value. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported on the average-cost method. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Subsequent Events**

The Plan has evaluated subsequent events through October 3, 2025, which is the date the financial statements were available to be issued.

### Note 3: Related-Party Transactions

On March 31, 2016, the Plan purchased 100% (99,999 shares) of Level 10 Holdings Company outstanding common stock and issued a note payable to Level 10 Holdings Company. Payments on the note are due in annual principal installments of \$66,700 plus interest through December 31, 2035. The note is secured by the unallocated shares of Level 10 Stock. Interest expense on the note was \$18,700 and \$20,203 in 2024 and 2023, respectively.

Effective January 1, 2025, the Plan was amended to modify the terms of the note payable to require annual principal installments of approximately \$18,343 plus interest at a rate of 2.33% through December 31, 2064.

All transactions between the Sponsor, the Trustees, Custodian, and the participants are considered party-in-interest transactions. Certain officers and employees of the Sponsor, who are also participants in the Plan, perform administrative services to the Plan at no cost. These transactions are not, however, considered prohibited transactions under Section 408(b) of the ERISA regulations.

### Note 4: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

The asset and liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Level 10 Holdings Company common stock:* Valued at fair value per share based on annual appraisals conducted by an independent valuation firm. The appraisal of Level 10 Holdings Company is determined using a combination of two valuation methods: the Selected Public Company Method and the Discounted Cash Flow Method. As of December 31, 2024 and 2023, the fair market value per share of the Sponsor's common stock was determined to be \$213.12 and \$202.04, respectively. The appraisal of the fair value per share of Level 10 Stock for 2024 was completed in May 2025.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 6: Plan Termination

The Sponsor reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon termination of the Plan, the Employee Benefits Administration Committee directs the Trustee to pay all liabilities and expenses of the ESOP and to sell shares of financed common stock held as collateral to the extent it determines such sale to be necessary in order to repay the note payable. Subsequently, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC. In the event of Plan termination, the benefits of each affected participant shall be nonforfeitable.

### Note 7: Risks and Uncertainties

The Plan investments consist primarily of the Level 10 Stock, which is exposed to various risks, such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows, and other such techniques. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the value of common stock will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

### Note 8: Income Tax Status

The IRS has determined and informed the Plan by a favorable determination letter, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.
