Opinion

We have audited the financial statements of Umpco, Inc. Employees' Pension Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 (in liquidation) and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 (in liquidation), the statement of net assets available for benefits as of December 31, 2023 (ongoing) and the related statements of changes in net assets available for benefits for the year ended December 31, 2023 (ongoing), and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of Umpco, Inc. Employees' Pension Plan as of December 31, 2024 (in liquidation) and 2023 (ongoing), and the changes in its net assets available for benefits for the years ended December 31, 2024 (in liquidation) and 2023 (ongoing), in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Emphasis of Matter – Basis of Accounting

As described in Note 2 to the financial statements, due to the termination of the Plan and its imminent liquidation, the Plan changed its basis of accounting from the accrual basis used in the 2023 financial statements to the liquidation basis of accounting for the 2024 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. NOTE 1 – DESCRIPTION OF THE PLAN

The Umpco, Inc. Employees' Pension Plan (the "Plan") is a defined benefit plan that covers substantially all employees and provides for pension and death benefits. Participants become fully vested in the Plan after six years of credited service. Umpco, Inc. (the "Plan Sponsor") has agreed to voluntarily contribute such amounts as are necessary to provide assets sufficient to meet the benefits to be paid to participants. The Plan has met the Employee Retirement Income Security Act of 1974, as amended ("ERISA") minimum funding requirements. The Plan is subject to the provisions of ERISA.

Information about the Plan, including present and future benefits, vesting and Pension Benefit Guaranty Corporation ("PBGC") benefit guarantee provisions, is contained in a summary document available from the Plan administrator. On July 2, 2024, the Plan Sponsor terminated the Plan effective August 31, 2024 (see Note 9).

Vesting

Participants vest in benefits based on years of service. Participant benefits are vested at 20% after 2 years of service, and at an additional 20% every year of service thereafter until 100% vested.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan as of and for the year ended December 31, 2024 have been prepared under the liquidation basis of accounting due to the termination of the plan (see Note 9). Financial statements are prepared using the liquidation basis of accounting to present relevant financial information about the Plan's expected resources in liquidation by measuring and presenting assets at the amount of the expected cash proceeds from liquidation. Additionally, the Plan recognizes and measures its liabilities in accordance with generally accepted accounting principles that otherwise applies to those liabilities. The Plan is also required to accrue and separately present the costs that it expects to incur and the income that it expects to earn during expected duration of the liquidation, including any costs associated with the settlement of those assets and liabilities. As of December 31, 2024, the Plan's assets had not yet been fully liquidated. The financial statements of the Plan as of and for the year ended December 31, 2023 were prepared using the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are measured at fair value based on quoted market prices. Investment income or loss and net realized and unrealized gains and losses are reflected in the Statements of Changes in Net Assets Available for Benefits. Dividend income is accrued on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported based on historical cost.

Fair Value of Financial Assets and Liabilities

Fair value estimates are made at a specific point in time based on relevant market information about the financial instrument. These estimates are subjective in nature and involve uncertainties and matters of significant judgment and, therefore, cannot be determined with precision. Changes in assumptions could significantly affect the estimates.

Actuarial Present Value of Accumulated Plan Benefits

Accumulated plan benefits are those future periodic payments and distributions that are attributable, under the Plan's provisions, to the service the employees have rendered.

The actuarial present value of accumulated plan benefits is determined by an actuarial firm, using actuarial assumptions to reflect the time value of money and probability of payment between the valuation date and the expected date of payment.

The significant actuarial assumptions used in the actuarial computations as of January 01, 2024 and 2023 are as follows:

- (a) Mortality table – Pri-2012 Employee/Retiree base table. MP-2021 generational improvement factor
- (b) Form of payment – Lump sum
- (c) Discount rate – 7.00%

As described in Note 1, the Plan Sponsor terminated the Plan effective August 31, 2024. Actuarial assumptions previously based on the presumption that the Plan will continue are no longer applicable. The actuarial present value of accumulated plan benefits has been determined in connection with the termination of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Administrative Fees

Trustee fees, consulting fees and other administrative expenses are paid from Plan assets. Total administrative fees were \$18,980 and \$9,889 for the years ended December 31, 2024 and 2023, respectively.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events through October 3, 2025, the date the financial statements were available to be issued. In August 2025, substantially all assets of the plan were liquidated through payment of benefits to participants. Excess funds totaling approximately \$1.6 million were transferred into a new qualified retirement plan established and administered by the Plan Sponsor (see Note 6).

NOTE 3 – ACCUMULATED PLAN BENEFITS

An actuary estimates the actuarial present value of accumulated plan benefits, which is the amount that results from applying actuarial assumptions to adjust the accumulated plan benefits earned by the participants to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, withdrawal, or retirement) between the valuation date and the expected payment date.

NOTE 4 – ASSETS AND LIABILITIES MEASURED AT FAIR VALUE

The Plan's investments, as directed by the Plan Sponsor, are held by the Trustee.

Fair value is a market-based measurement that is determined based on assumptions that market participants would use in pricing an asset or liability. As a basis for considering such assumptions, the Plan uses a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value as follows:

- Level 1: Observable inputs such as quoted prices in active markets;
- Level 2: Inputs, other than the quoted prices in active markets, that are observable either directly or indirectly; and
- Level 3: Unobservable inputs in which there is little or no market data, which require the reporting entity to develop its own assumptions.

The classification of fair value measurements within the hierarchy is based upon the lowest level of input that is significant to the measurement. Valuation methodologies used for assets and liabilities measured at fair value are as follows:

- Money market fund: Valued based on the underlying investments traded on the active market.
- Mutual funds: Valued based on quoted market prices in an active market.
- Real estate investment trust: Valued based on transactions in secondary markets

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in methods used to value investments.

NOTE 5 – INCOME TAX STATUS

The Internal Revenue Service (“IRS”) determined and informed the Plan by a letter dated March 30, 2018, that the Plan is qualified, under the appropriate sections of the Internal Revenue Code (“IRC”). Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require the Plan Sponsor to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan Sponsor has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023 there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 – FUNDING POLICY

The Plan Sponsor's funding policy was to contribute an amount as determined by the Plan actuary sufficient to maintain the minimum funding standard in accordance with ERISA. During 2025, remaining assets in the Plan after payment of benefits to participants totaling \$1,633,863 were transferred to a new qualified retirement plan established and administered by the Plan Sponsor. At December 31, 2024, the Plan recognized an excess funding payable liability, which is included in the statement of net assets available for benefits. These assets will be used to offset the future employer contributions and expenses of the new plan.

NOTE 7 – TRANSACTIONS WITH PARTIES IN INTEREST

Parties-in-interest transactions include the purchases and sales of investments and payments to the Plan trustee for services and expenses. There are also indirect fees deducted directly from investments earnings of the Plan.

NOTE 8 – RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such change could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

Plan contributions and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimation and assumption processes, it is at least reasonably possible that changes in these estimates and assumptions in the near term could materially affect the amounts reported and disclosed in the financial statements.

NOTE 9 – PLAN TERMINATION

On July 2, 2024, the Plan Sponsor began preparations to terminate the Plan with a plan termination amendment subject to the termination becoming effective in accordance with the applicable PBGC regulations. The Plan Sponsor froze accumulation of benefits for active participants effective August 31, 2024. All participants elected to receive their benefits in the form of lump-sum distribution, and no participants elected an annuity option. Lump-sum distributions as a result of plan termination were completed in August 2025.
