Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Carlisle Medical, Inc. 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Carlisle Medical, Inc. 401(k) Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTES TO FINANCIAL STATEMENTS

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Carlisle Medical, Inc. 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of a controlled group of employers, including Carlisle Medical, Inc. and Carlisle & Associates (the Company) who are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was created on January 1, 1993. Benefits payable by the Plan are to be funded from trust assets invested with John Hancock Life Insurance Company.

Contributions

Each year, participants may contribute up to the maximum amount allowed by law of pre-tax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. A discretionary matching and/or profit sharing contribution may be made by the Company at the option of the Company's directors. For 2024, the Company contributed 50 percent of the first 4 percent of base compensation that eligible participants contributed to the Plan. The Company made matching contributions of \$85,095 for the year ended December 31, 2024. The Company made no discretionary profit sharing contribution for the year ended December 31, 2024. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and Company matching contributions, as well as allocations of the Company's profit sharing contribution, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 1 – DESCRIPTION OF PLAN (continued)

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in employer contributions is based on years of credited service. A participant is 100 percent vested after 6 years of credited service. A participant will always be 100 percent vested if employed on or after meeting the normal retirement age of 65, becoming disabled, or upon death.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installment payments subject to period limitations. If the benefit payable does not exceed \$5,000, payment of benefits must be made in the form of a lump sum distribution. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

Forfeited Accounts

Forfeited accounts may be used to pay administrative expenses or reduce future employer contributions. At December 31, 2024 and 2023, the balance of unallocated forfeited accounts was \$9,882 and \$7,416, respectively. During the year ended December 31, 2024, forfeited non-vested balances totaling \$8,658 were used to pay Plan expenses.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and related disclosures. Accordingly, actual results may differ from those estimates.

Cash Equivalents

Investments which are readily convertible to cash and not susceptible to market fluctuation are considered to be cash equivalents.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses incurred from maintaining the Plan are paid by the Plan, unless otherwise paid directly by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments.

Subsequent Events

Management has evaluated subsequent events through October 6, 2025, the date at which the financial statements were available to be issued, and has determined that there are no events that require adjustment to, or disclosure in, these financial statements.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

NOTE 3 – FAIR VALUE MEASUREMENTS (continued)

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Valued at the value of the underlying fund based on reported net asset value, which represents the values at which each sub-account can redeem its investments. Unit values are calculated daily and are priced using values obtained from independent pricing sources.

Guaranteed interest contracts: Valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

NOTE 4 – GUARANTEED INVESTMENT CONTRACTS

The Plan offers three guaranteed investment contracts with John Hancock Life Insurance Company. The guaranteed investment contracts earn interest at specified rates for specified contract periods of three, five, or ten years. Contributions to these accounts are invested in the general assets of John Hancock Life Insurance Company and are guaranteed by John Hancock Life Insurance Company. The accounts are credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses. Interest rates are established on the first date of each calendar month and apply to any regular ongoing contributions made to the guaranteed account that month. Due to the restrictions on the guaranteed interest accounts, which only allow participants to allocate up to 20% of their beginning of the plan year balance out of these accounts on four contract-specified days within the Plan year without penalty, these investments have been determined to be not fully benefit-responsive, and are therefore reported at fair value.

NOTE 5 – CERTIFIED INVESTMENT INFORMATION

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (the trustee of the Plan). This information has not been audited by the Plan's independent auditors. The information certified by John Hancock Life Insurance Company is summarized below.

NOTE 6 – RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan is serviced by the Lomax Coale Group as its registered investment advisor and John Hancock Life Insurance Company as its trustee and record-keeper. Economic Group Pensions Services, Inc. served as its third-party administrator until January 5, 2025. Azalea Administration served as its third-party administrator beginning January 6, 2025. Certain investments of the Plan are managed by John Hancock, as noted in the supplemental schedule on pages 14 and 15. These relationships qualify as party-in-interest.

During the year ended December 31, 2024, the Plan made direct payments to these parties-in-interest totaling \$26,967, respectively. Certain fees incurred by the Plan for investment management and custodian services are paid through revenue sharing, rather than direct payment, and are included in net appreciation in fair value of investments.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

NOTE 7 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in employer contributions.

NOTE 9 – TAX STATUS

The Company has adopted a non-standardized pre-approved profit sharing plan. The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (the Code). The Plan has been amended since receiving the determination letter. However, Plan management believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

NOTE 9 – TAX STATUS (continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Company is aware of certain operational, plan document, or demographic issues that, if not properly corrected, could be treated by the IRS as qualification failures. Management is taking steps to correct these issues. If necessary, the tax qualification issues will be resolved directly with the IRS. Accordingly, management believes that the Plan will retain its tax-qualified status.

NOTE 10 – DELINQUENT CONTRIBUTIONS

During 2023, certain employee deferrals aggregating \$75 were not remitted to the Plan within the timeframe required by the Department of Labor. The Company will compute lost earnings on these deposits and make a contribution for lost earnings to the Plan. This information is shown in the supplemental schedule of delinquent participant contributions on page 16.


