Note A – Description of Plan

The following description of the University Medical Service Association, Inc. Tax Deferred Annuity Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a tax deferred annuity plan that was established effective January 1, 1987 and last amended and restated January 1, 2020. Employees of University Medical Service Association, Inc. (the “Company” or the “Employer”) are eligible to participate upon date of employment. Employees automatically become a participant and are enrolled at their hire date. Participants become eligible to receive Employer contributions upon completion of 12 months of service and 1,000 hours. To remain in a participating status, the participant is required to maintain a minimum of 1,000 hours worked each year thereafter. If an employee is not eligible on the anniversary of their employment (did not work 1,000 hours in the 12 months of service), their eligibility will be reviewed or tracked at the end of each calendar year. If the required hours were worked in the calendar year, they will be enrolled to participate going forward. If a participant has a break in service during their first 5 years of employment and resumes prior to the expiration of the 5-year period, the participant may immediately resume participation in the Plan, subject to the Plan Administrator’s approval. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Company ceased participant and Employer contributions into the Plan starting on February 11, 2022, as there were no longer any active employees. The Company’s employees moved to a new organization, USF Tampa General Physicians (USFTGP), formed in collaboration with Tampa General Hospital. The Company has not taken formal action to freeze or terminate the Plan as of the date of the audit opinion.

Effective April 1, 2024, the provision allowing participants to request a loan withdrawal from their account balance will no longer be available.

Administration of the Plan

The accounting records are maintained by the Company. The Plan’s assets are held and managed by The Variable Annuity Life Insurance Company (the “Trustee”). Contributions are held by the Trustee, who invests cash received, interest and dividend income, as directed by the participant, and makes distributions to participants.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and the Company’s matching contributions. Each participant’s account shall be allocated earnings, gains, expenses, and losses with respect to the investments of the participant’s account. Allocations of Plan earnings or losses are based on each participant’s investment fund balance in proportion to the total investment fund balance.

Vesting

Participants are vested immediately in their contributions plus actual earnings or losses thereon. A participant is 100% vested in Employer contributions after five years of credit service as follows:

A participant who becomes totally disabled or dies while under the Company’s employment, shall be 100% vested on such date.

Vesting (continued)

If the participant is terminated or departs the Company for any reason, all unvested contributions are forfeited upon a forfeiture date coinciding with the last day of five years of service. Should the participant return to work prior to the forfeiture date, no unvested contributions are forfeited, with the exception of individuals who made withdrawals during their absence from the Company. For participants that made withdrawals, the account attributable to Employer contributions must be restored to its balance on the date of the distribution prior to continuance in the Plan for Employer contributions. All forfeitures created during the Plan year will be used to offset future Employer contributions.

Notes Receivable from Participants

Prior to April 1, 2024, participants were eligible to borrow from funds accumulated through participant elective deferrals a minimum of \$1,000 and a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant notes receivable. Loan terms can be up to five years. However, for loans used to acquire principal residence, participants may extend the term of loan for up to 15 years. These loans are collateralized by the balance in the participant's account and bear interest at prevailing rates as determined by the Plan Administrator. Starting in 2022, principal and interest are paid through direct deposits by the participants in substantially equal payments over the life of the loan, with payments not less frequently than quarterly.

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Non-payment of the quarterly loan principal and interest due within 30 days after the due date will constitute default. The entire balance of the loan will be reported as a taxable distribution, subject to tax at ordinary income tax rates and possibly subject to a 10% early distribution tax. Participant account balances held as security for the loan will be foreclosed upon by the Trustee for the Plan after a distribution under the terms of the Plan and law are permitted. Repayment of the defaulted loan is permitted until the foreclosure date. Until foreclosure, the Trustee will pay an interest rate on the secured balance for the loan equal to the rate being charged. Thus, the total interest due on the defaulted loan will be paid in full at the date of foreclosure from the interest earned on the secured portion of the participant's account. Additional loans will not be granted prior to foreclosure of a defaulted loan.

Distribution of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or installments paid over various periods, as defined in the Plan agreement. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Participants may also obtain distributions from their elective deferrals balances while still employed to the extent of related earnings credited to an annuity contract; in the event of hardship; and after the participant reaches age 59 ½.

Forfeitures

Forfeited balances of terminated participants' non-vested accounts are used to reduce future Employer contributions. As of December 31, 2024 and 2023, there were approximately \$371,000 and \$223,000 of forfeitures outstanding that could be used to offset future Company contributions. No forfeitures were used during 2024.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, each participant's account will become fully vested and nonforfeitable. All appropriate accounting provisions of the Plan will continue to apply until the accounts of all participants have been distributed.

Note B – Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“US GAAP”).

Use of Estimates

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and the changes in net assets available for benefits and disclosure of contingent assets and liabilities during the reporting period. Actual results could differ from these estimates.

Valuation of Investments

The Plan's investments are stated at fair value, except for the fully benefit-responsive investment contracts, which are reported at contract value as described in Note G.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Fair Value Measurements

The Financial Accounting Standards Board has established a framework for measuring fair value in ASC 820, *Fair Value Measurements*. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:
Quoted prices for similar assets or liabilities in active markets;
Quoted prices for identical or similar assets or liabilities in inactive markets;
Inputs other than quoted prices that are observable for the asset or liability;
Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Fair Value Measurements (continued)

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note C – Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by The Variable Annuity Life Insurance Company, a qualified institution. As of December 31, 2024 and 2023, and for the year ended December 31, 2024, the Plan Administrator instructed the auditors not to perform any auditing procedures with respect to the information certified by The Variable Annuity Life Insurance Company, except for comparing such information to the related information included in the financial statements, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Note D – Income Tax Status

The Plan has received an opinion letter from the Internal Revenue Service dated April 5, 2018 for its prototype plan stating that the Plan is qualified under Section 403(b) of the IRC and, therefore, the related trust is exempt from taxation. Subsequent to the issuance of the opinion letter, the Plan was amended and the Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC.

The Plan Administrator evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the accompanying financial statements. The Plan is no longer subject to examination by taxing authorities for years prior to 2021.

Note E – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note F – Party-In-Interest Transactions

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or participants of the Plan, any person who provides services to the Plan, or an employer whose employees are covered by the Plan. Certain Plan investments are mutual funds and investment contracts managed by the Trustee. Transactions related to these investments qualify as party-in-interest transactions. Notes receivable from participants are also considered to be party-in-interest transactions because they are transacted with Plan participants. Fees paid to parties-in-interest by the Plan for services amounted to approximately \$120,000 during the year ended December 31, 2024.

The Plan invests in guaranteed interest accounts (“the Funds”) provided through group annuity contracts. Under the Funds, crediting rates are established and are credited with contributions and charged for participant withdrawals and administrative expenses charged by the Trustee of the Funds. The guaranteed interest account issuers are contractually obligated to repay the principal and a specific interest rate that is guaranteed to the Plan. The Funds require that any transfer of the investment made by the Plan are restricted to annual 20% increments. The annuity contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuers. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan,) (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures of spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transactions exempt under ERISA. The Plan Administrator does not believe that any events which would limit the Plan’s ability to transact at contract value with participants are probable of occurring.

Note H – Subsequent Events

Subsequent events have been evaluated through September 26, 2025, which is the date the financial statements were available to be issued.
