Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Murrieta Development Co., Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. DESCRIPTION OF PLAN

The following description of the Murrieta Development Co., Inc. 401(K) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan was adopted on January 1, 1997 to qualify as a defined contribution retirement plan for Murrieta Development Co., Inc.’s (the “Company”) eligible employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Employees are eligible to participate in the Plan after completion of 500 hours during the first six months of service and attained the age of twenty-one (21). To be eligible for profit sharing contributions, a participant is required to complete 1,000 service hours and be employed on the last day of the Plan year. Employees may enter the Plan on the 1st day of January and July coinciding with the satisfaction of the minimum age and service requirements.

Administration

The Plan is administered by the Company.

Contributions

The Company’s eligible employees may contribute up to the 402(g) limit which was \$23,000 for the year ended December 31, 2024. In addition, all eligible employees who have attained age 50 before the close of the Plan year shall be eligible to make catch-up contributions in accordance with, and subject to the limitations of, Code Section 414(v).

The Company may make matching contributions equal to a discretionary percentage to be determined by the Company’s Board of Directors. The Plan will also make safe harbor employer contributions equal to 3% of compensation to participants eligible to make salary deferrals. A participant’s allocation of employer contributions is reduced by contributions under the Murrieta Development Co., Inc. Prevailing Wage Plan (“Prevailing Wage”). Prevailing Wage contributions made to the Prevailing Wage Plan shall be used to offset any and all employer contributions, including qualified non-elective contributions, due to participants under this 401(k) plan. Safe harbor employer contributions amounted to \$254,849 for the year ended December 31, 2024. In addition, each year the Company may contribute to the Plan an amount subjectively determined by the Board of Directors. For the year ended December 31, 2024, the Company elected not to make employer matching or profit sharing contributions to the Plan.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and allocations of (a) the Company’s contributions and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of one-half of the participant's vested account balance, \$50,000, or the limitations set by the Tax Reform Act of 1986 and Section 408(b) of the Employee Retirement Income Security Act of 1974 ("ERISA"). The loans are to be repaid through payroll withholding over a period of five years or longer if the loan is to acquire a principal residence. Principal and interest are paid ratably through payroll deductions. Delinquent or defaulted notes receivables from participants are written off as "deemed" distributions at the end of the quarter following the quarter in which the default occurs.

The Plan classified participant loans as notes receivable from participants in the statement of net assets available for benefits and measures them at their unpaid principal balance plus any accrued interest.

Vesting

Participants are immediately vested in their voluntary contributions, safe harbor employer contributions, and actual earnings thereon. Vesting in the Company's qualified matching contributions and profit sharing contributions is based on years of service according to the following schedule:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than 2 years of service	0%
After two years of service	20%
After three years of service	40%
After four years of service	60%
After five years of service	80%
After six years of service or more	100%

Forfeitures

The unvested portion of a terminated participant's employer account will be forfeited and used to reduce future employer contributions or pay plan expenses.

Payment of Benefits

Retired or terminated participants receive the vested portion of their Company discretionary contributions and earnings on their Company matching contributions and one hundred percent (100%) of their pre-tax contribution and Company safe harbor contribution as soon as administratively possible following retirement, termination or upon becoming disabled.

Investment Options

Upon enrollment in the Plan, a participant may direct his or her respective share of contributions in any one of many investment options offered by John Hancock Life Insurance Company. (“John Hancock”).

2. SUMMARY OF ACCOUNTING POLICIES

The following are the significant accounting policies followed by the Plan:

Basis of Accounting

The accompanying financial statements have been prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Date of Management’s Review

Subsequent events were evaluated through October 6, 2025, which is the date the financial statements were available to be issued.

Investment Valuation and Income Recognition

All investments are carried at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s Investment Committee, or equivalent, determines the Plan’s investment policies utilizing information provided by the investment advisor, custodians, and investment contract issuer. See Note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a settlement date basis, which is generally the trade date plus one. Dividends are recorded on the ex-dividend date. Net realized and unrealized appreciation/depreciation in fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Non-Distributed Benefits

The Plan does not accrue non-distributed benefits related to participants who have withdrawn from the Plan before the Plan’s year end but recognizes such benefits as a deduction from net assets in the period in which such benefits are paid.

Plan Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and payments of benefits to participants are charged directly to the participant's account and included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Concentrations

One investment accounted for 33% of the Plan's net assets as of December 31, 2024 and two investments accounted for 42% of the Plan's net assets as of December 31, 2023, respectively.

Accounting Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

3. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to terminate or amend the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

4. TAX STATUS

The Plan Document is a prototype standardized defined contribution plan that received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020, which stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has since be amended and restated. The trustee, plan sponsor, and plan administrator are not aware of any course of action or series of events that have occurred that would adversely affect the qualified status of the Plan. Therefore, no provision for income taxes has been included in the Plan's financial statements.

4. TAX STATUS – (Continued)

U.S. GAAP require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

5. RELATED-PARTY TRANSACTIONS

The investments are in pooled separate accounts of which most are managed by John Hancock. John Hancock was the custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid to John Hancock for the contract administration amounted to \$26,551 for the year ended December 31, 2024.

6. INFORMATION CERTIFIED BY THE CUSTODIAN

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock the custodian of the Plan has certified to the completeness and accuracy of the pooled separate accounts and participant loan receivables on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the schedule of assets held at year end as of December 31, 2024, and all the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

7. INSURANCE CONTRACT

Pooled Separate Accounts – The Plan participated in contracts with John Hancock whereby the assets of the Plan were pooled with those of other unrelated plans. The Plan owned units of participation in the fair value of the account's underlying assets. John Hancock did not own the underlying assets, but only held them in trust for the participating plans.

8. FAIR VALUE MEASUREMENT

FASB ASC 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Fair Value Measurements

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Fair Value Measurements

Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of asset or liability.

Level 3 Fair Value Measurements

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts: The Plan participates in contracts with John Hancock (the insurance contract issuer) whereby the assets of the Plan are pooled with those of other unrelated plans. The Plan owns units of participation in the fair value of the account's underlying assets. John Hancock does not own the underlying assets, but only hold them in trust for the participating plans. These investments are public investment securities valued using the Net Asset Value ("NAV") as a practical expedient provided by the insurance institution. The NAV is quoted on a private market that is not active, however, the unit price is based on the underlying investments. A majority of the investments held by each fund are traded on an active market.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
