The following description of the AIM Transfer & Storage, Inc. Profit Sharing 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan sponsored by AIM Transfer & Storage, Inc. The Plan covers substantially all eligible employees of AIM Transfer & Storage, Inc., AIM Management LLC, AIM Expedited Services, LLC, and AIM Brokerage Services, LLC (collectively referred to as the "Company"), who have met the eligibility requirements and elect to participate in the Plan. Excluded classes of employees include leased employees and nonresident aliens. The Company serves as the plan administrator. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). All investments in the Plan are participant-directed.

On December 29, 2022, President Biden signed into law the Consolidated Appropriations Act of 2023, which includes the package of retirement provisions referred to as "SECURE 2.0". These provisions continue the themes and reforms that began with the 2019 SECURE Act, focusing on getting more participants into the retirement system, finding ways for them to accumulate more assets, and then ensuring they get connected with those assets when retirement comes.

Many of the provisions of the SECURE 2.0 are effective on January 1, 2023, and beyond and will require significant changes to plan administration and recordkeeping.

#### Eligibility

The Company's employees who have completed two months of service and are at least age 18 are eligible to participate.

#### Contributions

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a percentage, limited by Plan provisions, of their compensation contributed as pre-tax 401(k) contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. A participant may also contribute amounts representing distributions from other qualified plans (rollover contributions). The Company contributes a discretionary matching contribution that is allocated based on a participant's contributions and a minimum 3% safe harbor contribution. Additional amounts may be contributed at the discretion of the Company's Board of Directors. The Company may not make a contribution to the Plan for any Plan year to the extent the contribution would exceed the participant's maximum permissible amount. For the Plan years ended December 31, 2024 and 2023, the Company matched 50% of the first 6% of compensation contributed by the participant.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, the Employer's non-elective contribution and an allocation of plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Note 1 Description of Plan (Continued)

#### Vesting

Participants are immediately vested in their voluntary contributions, rollover contributions and Company matching contributions plus actual earnings thereon. Vesting in the Company discretionary and matching contribution portion of their accounts, plus actual earnings thereon, is based on years of credited service. A participant is 100% vested after six years of credited service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

#### Payments of Benefits

Benefit payments to participants are made payable in the event of retirement, death, disability, in-service, or termination of employment in either a lump-sum payment or installments.

#### Forfeitures

Plan forfeitures arise as a result of participants who terminate service with the Company before becoming 100% vested in the Company's contributions. These forfeitures may be reallocated to participants in the same manner as Company contributions or may be used to pay administrative expenses in accordance with the Plan document. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$3,410 and \$451, respectively. During the years ended December 31, 2024 and 2023, employer contributions were reduced by \$18,141 and \$3,325, respectively.

### Note 2 Summary of Accounting Policies

#### Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### Use of Estimates

The preparation of the accompanying financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

#### Risks and Uncertainties

The Plan holds various investments. Investment securities are exposed to various risks such as interest rates, market, and credit. Due to the level of risks associated with certain investment securities, it is at least reasonably possible that change in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Also, the Plan has a fixed annuity related to a Key Guaranteed Portfolio Fund, which is measured at contract value.

#### Notes Receivable from Participants

Participant loans are not allowed in this Plan.

#### Payments of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Administrative expenses charged by the Trustee of the Plan and investment advisory fees are paid by the Plan. All other expenses incurred in conjunction with the Plan are paid by the Company.

#### Subsequent Events

The Plan has evaluated subsequent events through October 3, 2025, which is the date the financial statements were available to be issued.

### Note 3 Fair Value Measurements

Accounting standards provide the framework for measuring fair value. That framework provides a fair value hierarchy that provides the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1                      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2                      Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs, other than quoted prices, that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3                      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Certain investments, including collective investment trusts (CITs), are measured at fair value using the net asset value (NAV) practical expedient. In accordance with ASU 2015-07, such investments are not categorized in the fair value hierarchy, but are presented separately to reconcile to total plan assets.

#### Valuation Methodologies

**Mutual Funds** – Valued at the daily closing price reported on national exchanges. Classified as Level 1.

**Collective Investment Trusts (CITs)** – Valued at NAV as provided by the trustee. NAV is based on the fair value of the underlying assets. Classified using NAV practical expedient.

**Stable Value Fund – Key Guaranteed Portfolio Fund (GIC)** – Fully benefit-responsive investment contract backed by Empower Annuity Insurance Company of America. Reported at contract value in the statement of net assets available for benefits. Fair value is determined using a discounted cash flow model with observable inputs (Level 2).

### Note 4 Information Prepared and Certified by Trustee

Certain information related to the investments in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024 was obtained and derived from the information furnished to the plan administrator and certified as complete by Empower Trust Company, LLC, the custodian of the Plan.

### Note 5 Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan document to discontinue its contributions and to terminate or partially terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

### Note 6 Tax Status

The Company adopted a nonstandard prototype document with an IRS opinion letter dated June 30, 2020, which states the prototype Plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since the date of the opinion letter; however, the Plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### Note 7 Party-in-Interest Transactions

Certain Plan investments for the years ended December 31, 2024 and 2023 were managed by Empower Trust Company LLC. Empower Trust Company LLC is the Trustee as defined by the Plan. These transactions qualify as exempt party-in-interest investments.
