- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of East House 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a 401(k) defined contribution retirement plan, sponsored by East House Corporation (the Company or Plan Sponsor). The Plan covers all eligible employees of the Company and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

The Plan is administered by the Company. VOYA Retirement Insurance and Annuity Company (Voya) is the custodian and insurance company of the Plan. Three senior management individuals of the Company serve as Plan trustees. Rimkus Marciano & Associates, Inc. is the Plan's third-party administrator.

Eligibility

Employees of the Company who are not expected to work 1,000 hours in the coming year are not eligible to participate in the Plan. Employees who are expected to work 1,000 or more are eligible to make elective deferrals into the Plan and receive Company matching contributions upon hire. The Plan has an automatic enrollment provision. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation, as defined by the Plan document. Participants are eligible to receive the Company's safe harbor nonelective and profit-sharing contributions upon completion of at least one year of service that includes at least 1,000 hours worked. The minimum age requirement to make voluntary employee deferrals and receive Company matching and discretionary profit-sharing contributions is eighteen years old. To receive Company safe harbor nonelective contributions participants must be twenty-one years old.

Contributions

Participants may make contributions up to the maximum percentage of compensation and dollar amount permissible under the Internal Revenue Code (IRC). Participants are also eligible to make Roth elective contributions to the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make additional catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company's matching contributions are equal to 25% of each participant's elective deferrals, to the extent the participant's deferrals did not exceed 4% of eligible compensation, as defined by the Plan document. The Company also makes a safe harbor nonelective contribution in the amount equal to 3% of each eligible participant's compensation, as defined by the Plan document. Profit-sharing contributions are also allowed at the discretion of the Company's Board of Directors. The Company made no profit-sharing contributions in 2024 and 2023.

Benefits

The Plan provides for benefit payments upon termination of employment, attainment of 65 years of age, death or disability. Benefit payments are made in the form of a partial payment, lump sum distribution, or a rollover to another qualified investment. Additionally, the Plan provides for in-service withdrawals once a participant reaches age 59 ½ even if still employed.

1. DESCRIPTION OF PLAN (Continued)

Hardship Withdrawals

The Plan permits distributions in the event of financial hardship as defined by the Plan document. All hardship withdrawals must comply with the rules relating to hardships, which are uniformly applicable to all participants.

Participant Accounts

Each participant's account is credited with the participant's elective deferrals, the Company's contributions, an allocation of investment earnings or losses and an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Upon enrollment in the Plan, a participant may direct employee and employer contributions in any of the investment options offered by the Plan. Participants may change their investment options electronically at any time during the year.

Vesting

Participants are immediately vested in their voluntary contributions and the safe harbor nonelective contributions, plus actual earnings and losses therein. Vesting in the Company's matching and discretionary profit-sharing contributions is based on a three-year cliff schedule, whereby participants are 0% vested until they have reached 3 years of service, at which point they become fully vested. Regardless of the Plan's vesting schedule, participants become fully vested upon death and in the event of total and permanent disability.

Forfeitures

Any forfeiture in the Plan year is used to pay plan expenses or reduce employer contributions. Forfeited nonvested accounts totaled \$14,291 and \$76,354 at December 31, 2024 and 2023, respectively. In 2024, forfeitures of \$79,025 were used to pay plan expenses or reduce employer contributions. In 2023, no forfeitures were used to pay plan expenses or reduce employer contributions.

Notes Receivable from Participants

Participants may borrow up to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate of 2% above the prime rate, as defined by the Plan document, at the time of loan origination. Loans must be repaid over a maximum term of 5 years, unless the loan is for the purchase of a participant's primary residence. Principal and interest are paid ratably through payroll deductions.

Administrative Expenses

Administrative expenses of the Plan are paid by the Plan or the Company.

Plan Termination

Although the Plan Sponsor has not expressed any intent to do so, it has the right to terminate the Plan subject to provisions set forth by ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared in accordance with accounting principles generally accepted in the United States (GAAP), using the accrual basis of accounting.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investments

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. All investments are participant directed.

Guaranteed Investment Contract

The Plan has a guaranteed investment contract (GIC) with Voya. The Plan's GIC is considered fully benefit responsive and is stated at contract value on the accompanying statements of net assets available for benefits. Contract value is equal to participant deposits minus participant withdrawals plus credit interest. Contract value may be subject to market value adjustments in connection with contract holder directed withdrawals or under limited circumstances for certain in-service withdrawals. The contract value of the GIC at December 31, 2024 and 2023 was \$89,662 and \$95,715, respectively. The guaranteed minimum crediting interest rate for the contract for the years ended December 31, 2024 and 2023 was 1.0%.

Certain events, which Plan management believes are not probable of occurring, may limit the ability of the Plan to currently transact at contract value and may result in a deferral of the payment at contract value for up to twelve months. Such events include but may not be limited to a participant termination of employment due to: (1) removal of a group of participants from Plan coverage as a result of temporary absence, change in position or other occurrence qualifying as a temporary break in service under the Plan; (2) transfer or other change of position resulting in employment by an entity controlling, controlled by, or under other common control with the employer; or (3) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the Plan sponsor's business. Such events also include: (1) removal from the Plan of one or more groups or classifications of participants; (2) partial or complete plan and contract termination of the contract (3) partial or complete Plan terminations; or (4) Plan disqualification.

Fair Value Measurements

The Plan uses various valuation techniques in determining fair value. Observable inputs are inputs that market participants would use in pricing the asset or liability developed based on market data obtained from sources independent of the Plan. Unobservable inputs are inputs that reflect the Plan's estimate about the assumptions market participants would use in pricing the asset or liability, developed based on the best information available in the circumstances.

GAAP establish a fair value hierarchy. The hierarchy is broken down into three levels based on the reliability of inputs as follows:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation does not entail a significant degree of judgment.

The Plan has no assets which are valued using Level 1 inputs.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Fair Value Measurements (Continued)

- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.

Separate accounts: Valued at their “accumulation unit value” (AUV), determined based on a combination of the fund’s net asset value (NAV) and the separate account charges. The separate account is valued daily as the number of accumulation units held multiplied by the AUV. The AUV is first established when a new fund starts (typically the beginning AUV is \$10.00) and is then determined daily based on the net asset value of shares of the underlying fund, the fund’s dividends and the contract’s separate account charges. Transactions occur daily in and out of the accounts. The fund NAV’s are available from the custodian. The Contract’s daily asset charge (separate account charge) is communicated to plan management in the contract and applicable notice of change.

- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

The Plan has no assets which are valued using Level 3 inputs.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan document.

Payment of Benefits

Benefit payments are recorded when paid.

Risks and Uncertainties

The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the accompanying financial statements.

Estimates

The preparation of financial statements in accordance with GAAP requires Plan management to make estimates and assumptions that affect the amounts reported in the financial statements. Actual results could differ from those estimates.

5. INCOME TAX STATUS

The Plan adopted a non-standardized prototype document. On June 30, 2020, the Internal Revenue Service ("IRS") stated in an opinion letter that the prototype adopted by the Plan, as then designed, was in compliance with all applicable requirements of the IRC and therefore, the related trust is exempt from taxation. The Plan has been amended since receiving the tax determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

6. PARTIES-IN-INTEREST

Voya is the custodian of the Plan and Rimkus Marciano & Associates, Inc. is the Plan's third-party administrator. Consequently, transactions between the Plan, Voya and Rimkus Marciano & Associates, Inc. qualify as party-in-interest transactions. Additionally, notes receivable from participants are party-in-interest transactions.

7. RECONCILIATION TO FORM 5500

Certain items have been classified differently between the financial statements and Form 5500. Net assets available for benefits and changes in net assets available for benefits per the financial statements agreed to Form 5500 in total as of and for the years ended December 31, 2024 and 2023.

8. SUBSEQUENT EVENTS

Subsequent events have been evaluated through September 24, 2025 which is the date the financial statements were available to be issued.
