Notes to Financial Statements

Note 1: Description of Plan

The following description of the Level 10, LLC 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established effective October 1, 2006 as defined contribution plan for eligible employees of Level 10, LLC (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility

Employees of the Company who are 21 years of age or older (other than union employees, leased employees, non-resident aliens and employees covered by a collective bargaining agreement which does not provide for their participation) are eligible to participate in the Plan immediately upon employment. The Company offers a discretionary Company match to all employees who are 21 years of age or older and have completed one hour of service during the Plan year. Also, employees who are at least 21 years old, complete 1,000 hours of service during the Plan year, and employed on the last day of the Plan year are eligible to participate in the discretionary profit sharing contribution feature of the Plan. Effective February 23, 2024, long-term part-time employees who have not previously entered the Plan, but have attained at least 500 hours of service in at least three consecutive years beginning after December 31, 2020, are eligible to participate in the Plan.

Contributions

Each year participants may contribute pretax or after tax (Roth) annual compensation up to the annual maximum allowed by the Internal Revenue Service (IRS), as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows participants to rollover distributions from other qualified retirement plans. The Plan provides for the Company to make a discretionary matching contribution. During 2024, the Company matched 10% of a participant's elective deferrals. The discretionary matching contribution totaled \$72,446 for 2024. Company profit sharing contributions to the Plan are determined each year at the discretion of the Company. No such discretionary profit sharing contributions were made during 2024.

The Plan provides automatic enrollment for all new participants upon becoming eligible to participate in the Plan at a contribution rate of 4% of their eligible compensation with an automatic increase of 1% on the first day of each Plan year up to 10%, if no election or waiver is made by the participant.

Participant and Company contributions are allocated among the available investment options as directed by each participant. By designating these investment alternatives for participants, allowing frequent fund transfers and providing the necessary fund information to participants, it is intended that the Plan be treated as an ERISA 404(c) Participant-Directed Account Arrangement.

Notes to Financial Statements

Note 1: Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contribution, Company matching contributions, and allocations of (a) the Company's profit sharing contributions, (b) Plan earnings or losses, and (c) forfeitures, and is charged with withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in a participant's allocation of Company contributions is based on years of service. Company matching and profit sharing contributions and their related earnings are fully vested after six years starting with 20% after the second year and an additional 20% each year thereafter.

Notes Receivable from Participants

A participant may borrow from his/her fund account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a range of 3.25% to 8.50%, which is commensurate with local prevailing rates. A loan is payable over a period not to exceed five years unless the loan is used by the participant to acquire a principal residence. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

A participant's vested account generally becomes distributable upon the earliest occurrence of any of the following events (an event of maturity): (a) death, (b) voluntary or involuntary separation from service, (c) retirement, (d) attainment of age 59 ½, or (e) disability (as defined by the Plan). A participant's vested account may be distributed in cash or as a rollover into an IRA or another employer-sponsored plan. In addition, hardship distributions are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2.

Forfeitures

Plan forfeitures arise as a result of participants who terminate with the Company before becoming 100% vested in Company contributions. These forfeitures may be used to reduce Company contributions or may be used to pay administrative expenses in accordance with the Plan document. At December 31, 2024 and 2023, forfeited accounts available were \$4,729 and \$14,774, respectively. For the year ended December 31, 2024, forfeitures in the amount of \$15,710 were used to reduce Company contributions or pay Plan expenses.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States (GAAP).

Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan invests in an investment contract with Voya Retirement Insurance and Annuity Company. The investment contract is comprised of several funds within a pooled separate account and a guaranteed interest rate fixed account from which participants of the Plan choose for investment of their account balance. Participants hold units of participation in the individual fund or fixed account in which their account balances are invested.

The Plan's investments in the pooled separate account funds under the investment contract with insurance company are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on pooled separate account fund investments bought and sold as well as held during the year.

The Plan's investment in the fixed account under the investment contract with insurance company is stated at contract value. Contract value is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan. Interest income on the Plan's investments in the fixed account is recorded on the accrual basis.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Expenses paid by the Plan are allocated proportionately to Plan participants based on their respective account balances. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

Subsequent Events

The Plan has evaluated subsequent events through October 3, 2025, which is the date the financial statements were available to be issued.

Note 3: Information Prepared and Certified by Custodian

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the Voya Retirement Insurance and Annuity Company (the "Custodian").

Note 4: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted market prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies as of December 31, 2024 and 2023.

The pooled separate account funds are valued at the net asset value (NAV) per unit, as provided by the custodian, as a practical expedient to estimate fair value. The NAV per unit is based on the fair value of the underlying investments adjusted by a daily asset charge as determined by the contract issuer.

Note 4: Fair Value Measurements (Continued)

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

As the investments in the Plan valued at fair value are all measured using NAV as a practical expedient as provided by ASU 2015-07, none of the investments are required to be included in the fair value tables. Therefore, these tables have been omitted.

The following table sets forth the additional required disclosures for the Plan's investments whose fair value is measured using NAV per unit as a practical expedient as of December 31, 2024 and 2023.

Note 5: Guaranteed Interest Account with Voya Retirement Insurance and Annuity Company

The guaranteed interest rate fixed account ("Fixed Account") investment option under the investment contract with Voya Retirement Insurance and Annuity Company ("Voya") qualifies as a fully-benefit responsive investment contract. Voya maintains the contributions of the Fixed Account in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract ("GIC") issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the Fixed Account is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the Fixed Account. Contract value, as reported to the Plan by Voya, represents contributions made to the Fixed Account under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment in the Fixed Account at contract value. However, transfers from the Fixed Account to a competing investment option cannot be made.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but minimum guaranteed interest rates may vary by participant based on the date that they elect to participate in the fund. The guaranteed minimum floor rate may change after the defined period, but will never be lower than the minimum guaranteed interest rate.

Certain events limit the Plan's ability to transact at contract value with Voya including Plan termination and other events as specified in the GIC. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants or the issuer are probable of occurring. The GIC does not have a scheduled maturity date.

Note 6: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 7: Plan Termination

Although it has not expressed any intent to do so, the Plan administrator has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

Note 8: Tax Status

The Company adopted a nonstandard prototype document with an IRS notification letter which states the prototype plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter; however, the Plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 9: Related Party Transactions and Party-In-Interest Transactions

Certain Plan investments are managed by Voya, as defined by the Plan and, therefore, these transactions qualify as party- in-interest transactions. Fees incurred and paid by the Plan for the investment management services are included in net appreciation in fair value of the investment, since they are paid through revenue, sharing, rather than a direct payment.

Notes receivable from the Plan's participants also qualify as party-in-interest transactions, which are exempt from the prohibited transactions rules of ERISA.
