We have performed the audits of the accompanying financial statements of Future Foam, Inc. 401(k) Profit Sharing Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

1. Description of Plan

The following description of the Future Foam, Inc. 401(k) Profit Sharing Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan provisions.

A. General

The Plan is a defined contribution plan covering all employees of the Plan Sponsor, Future Foam, Inc. (the Company), who have reached age 19 and have completed two months of service, as defined in the Plan agreement. The Plan's administrative committee is responsible for oversight of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

B. Contributions

Participants may contribute a percentage of their annual compensation, as defined by the plan, provided the contribution does not exceed limitations set by the Internal Revenue Service, through either pre-tax or after-tax Roth contributions. Participants who have attained age fifty before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute rollover distributions from other qualified benefit plans. Participants direct the investment of all contributions into investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at six percent of eligible pre-tax compensation and their contributions invested in a target retirement date fund until changed by the participant. The Company determines the amount of matching and discretionary contributions. During the years ended December 31, 2024 and 2023, the Company matched 25% of participant contributions up to a maximum of \$400 per participant. No discretionary contributions were made during each of the years ended December 31, 2024 and 2023.

C. Participants Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

D. Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in Company contributions is based on years of continuous service. A participant becomes vested in Company contributions at 25% after one year of service, and 25% each anniversary year until 100% vested after four years of service.

E. Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable are secured by the balance in the participant's account and bear interest commensurate with local prevailing rates, as determined by the custodian of the Plan. As of December 31, 2024, outstanding notes receivable carry interest rates ranging from 3.25% to 8.50%. The terms of the notes receivable require principal and interest payments to be made via payroll deduction with a maximum repayment term of five years.

F. Payment of Benefits

The payment of benefits can be made upon reaching age 59 ½, death, disability, or termination of employment. Participant vested account balances of \$5,000 or less will be paid in one lump sum. For vested account balances exceeding \$5,000, the participant or beneficiary may elect to receive either a lump sum, non-recurring partial payments, or recurring installment payments.

G. Forfeited Accounts

Forfeited balances of non-vested accounts are used to either pay Plan administrative expenses or reduce future employer matching contributions. During the years ended December 31, 2024 and 2023, forfeitures of \$24,008 and \$16,851, respectively, were used to pay for administrative expenses of the Plan and no forfeitures were used to pay employer matching contributions. There were \$2,900 and \$18,800 of unused forfeitures available as of December 31, 2024 and 2023, respectively.

2. Summary of Accounting Policies

A. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

B. Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

C. Investment Valuation and Income Recognition

Investments are reported at fair value except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements and Note 5 for discussion of the investment contract.

Purchases and sales of securities are recorded on the trade-date. Interest income is recorded on the accrual basis. Net appreciation in the fair value of investments includes the plan's gains and losses on investments bought and sold as well as held during the year.

D. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

E. Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan either distributes or allocates under the catch-up provisions of the Plan the excess contributions to the applicable participants prior to March 15 in the subsequent year.

F. Administrative Expenses

Trustee fees and administrative costs are paid by the Plan, except the Company, at its discretion, may pay for certain administrative costs. Costs directly related to notes receivable from participants are charged to the participants' account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Benefits are recorded when paid.

H. Subsequent Events

The Plan's Administrative Committee evaluated transactions and events occurring subsequent to December 31, 2024, and through October 3, 2025, the date the financial statements were available to be issued, to determine whether any events should be recognized or disclosed in these statements.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective investment funds (CIF's): Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

Pooled Separate Account (PSA): Valued at the net asset value (NAV), based upon the market value of its underlying investments, which may include equities, bonds, real estate, mutual funds, separate accounts and collective trust funds. PSA NAV is provided by the issuer, United of Omaha Life Insurance Company (United), and is not a publicly quoted price in an active market.

5. Group Annuity Contract with United of Omaha Life Insurance Company

The Plan entered into a fully benefit-responsive guaranteed investment contract with United of Omaha Life Insurance Company (United) totaling \$5,752,223 at December 31, 2023. In accordance with the contract, contributions to the Guaranteed Account (the Account) were held in United's general asset account. The Account under the contract was credited with interest and charged for participant withdrawals and administrative expenses. United was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. The crediting rate was based on a formula established by United and reviewed monthly for resetting. United was able to terminate the contract with the Plan by providing 60 days prior written notice, and United was able to delay the payment of the Account up to twelve months from the notice.

This contract met the fully benefit-responsive investment criteria and therefore was reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by United, represented contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due was dependent on United's ability to meet its financial obligations. United's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Withdrawals from the account directed by the Company, an unusual volume of participant directed transfers or withdrawals which United reasonably concludes an employer directed withdrawal has occurred, or certain Plan sponsor events (for example, sale, merger, divestitures, or spin-offs) may limit the ability of the Plan to transact at contract value with United. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with United and that also would limit the ability of the plan to transact at contract value with the participants.

During 2024, all investments in this guaranteed investment contract were sold and allocated to other investment options.

6. Party-in-interest Transactions

Plan assets were managed in investment options issued by Mutual of Omaha. Effective July 2, 2024, Ascensus assumed full responsibility for managing investment options and performing responsibilities as recordkeeper as part of an agreement between Mutual of Omaha and Ascensus to transition Mutual's 401(k) recordkeeping business to Ascensus. Therefore, transactions with Ascensus and formerly Mutual of Omaha qualify as party-in-interest transactions. The Plan made direct payments of approximately \$54,000 to Ascensus and Mutual of Omaha during 2024 and approximately \$38,000 to Mutual of Omaha during 2023. These transactions, therefore, are party-in-interest transactions.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will immediately become 100% vested in their participant account.

8. Tax Status

The Plan is a preapproved non-standardized plan created by United and adopted by the Company on November 15, 2021. On September 21, 2020, the Internal Revenue Service in an opinion letter stated the preapproved provisions adopted by the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code (IRC). Although the Plan has been amended since the opinion letter, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and therefore, believes the Plan is qualified, and the related trust is tax-exempt. The Plan has not received a determination letter specific to the Plan.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by tax authorities. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The plan is subject to audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Excess Contributions Payable

Excess contributions payable represents the refund of contributions to participants in order for the Plan to comply with ERISA nondiscrimination rules. At December 31, 2024 and 2023, liabilities of \$134,463 and \$183,048, respectively, were recorded to be refunded and paid to participants.
