## INDEPENDENT AUDITOR'S REPORT

To the Board of Directors of  
Visiting Nurse Services of Iowa DBA Everystep

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of EveryStep 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

## **Other Matters**

### *Supplemental Schedules Required by ERISA*

The supplemental schedule of assets (held at end of year) as of December 31, 2024 and schedule of delinquent participant contributions for the year ended December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplemental information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

**NOTE 1 — DESCRIPTION OF THE PLAN**

The following brief description of the EveryStep 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement (Agreement) for a more complete description of the Plan's provisions.

**General**

The Plan is a participant directed defined contribution plan established on September 1, 2008. The Plan generally covers all employees of Visiting Nurse Services of Iowa DBA EveryStep (the Company, Employer, and Plan Administrator) who have attained age 18 and have completed 90 days of employment. Plan participants may enter the Plan on the first day of the next month following the date the employee meets the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator is responsible for the oversight of the Plan. The Plan Administrator determines the appropriateness of the Plan's investment offerings and monitors investment performance.

**Contributions**

Each year, participants may contribute a percentage of their eligible compensation as defined in the Plan Agreement, subject to certain limitations established by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the Plan year, are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Eligible employees are automatically enrolled with a deferral rate of 3% with automatic annual increases of 1% to a max of 8% unless an alternate election is made.

The Employer safe harbor matching contributions are equal to 100% of the first 1% of employee contributions and then 50% of the next 5% of employee contributions for a maximum employer safe harbor matching contribution of 3.5%. Contributions are subject to certain IRS limitations. The Plan also allows for additional discretionary employer matching contributions. There were no additional discretionary Employer matching contributions during the years ended December 31, 2024 or 2023.

**Investments**

Participants direct their contributions into various investment options offered by the Plan including mutual funds and an insurance company's fixed income account. Participants may change their investment options daily.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, the Employer safe harbor matching contributions, allocations of the Employer's discretionary matching contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

**Vesting**

Participants are vested immediately in their contributions, plus actual earnings thereon. Vesting of the Employer's safe harbor matching contributions and earnings thereon is based on years of continuous service. Participants begin vesting in safe harbor matching contributions on the date of employment and are 100% vested after two or more full years of service. For discretionary Employer matching contributions, a participant vests at a rate of 25% after two years of service then 25% annually until the participant reaches five years of service.

**Notes Receivable From Participants**

Participants may borrow from their account balance a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The loans bear interest at rates which are commensurate with local prevailing rates as determined quarterly by the Plan Administrator. Loans outstanding at December 31, 2024 bear interest at rates ranging from 4.25% to 9.50% and are due through December of 2029. Principal and interest are paid ratably through payroll deductions.

**Forfeitures**

Forfeited balances of terminated participants are used to reduce Employer contributions and pay Plan expenses. At December 31, 2024 and 2023, forfeited non-vested accounts contained a balance of \$867 and \$754, respectively. Forfeited balances of \$54,583 and \$32,123 were used to reduce the Employer contributions and administrative expenses for the years ending December 31, 2024 and 2023, respectively.

**Payment of Benefits**

Under the terms of the Plan, participants are eligible for distributions upon death, permanent disability, retirement, termination of employment for other than the preceding reasons and certain financial hardships as described in the Plan document. Normal retirement is at age 65. Benefit payment options are described in the Plan document, with benefits of \$5,000 or less payable in a lump-sum.

**Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right, under the Plan, to discontinue contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their account balances.

**Basis of Accounting**

The accompanying financial statements have been prepared on an accrual basis, in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits, disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of the fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Contributions**

Contributions from the Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

**Notes Receivable From Participants**

Notes receivable from participants are measured at the unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as they are incurred. Because participant notes receivable are 100% collateralized by the participants' vested account balances, no allowance for credit losses is deemed necessary as of December 31, 2024 and 2023.

**Payment of Benefits**

Benefits are recorded when paid.

**Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Administrative Expenses**

Certain administrative expenses of maintaining the Plan and investment advisory fees for the Plan are paid by the Plan, unless otherwise paid by the Employer. Administrative expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**NOTE 3 — INFORMATION CERTIFIED BY VOYA**

The following is a summary of the investment information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and supplemental schedules that were prepared or derived from information provided by Voya Retirement Insurance and Annuity Company (Voya and the Trustee of the Plan), and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the Trustee that information provided to the Plan Administrator by the Trustee, relating to the following investments is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information that appears throughout the financial statements and supplemental schedule relating to the following investments.

**NOTE 4 — FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurements*, establishes a three-tier fair value hierarchy, which categorizes the inputs used in measuring fair value. These categories include (in descending order of priority):

Level 1, defined as unadjusted quoted prices in active markets accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2, defined as quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar instruments in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means; and

Level 3, defined as unobservable inputs in which little or no market data exists, therefore requiring an entity to develop its own assumptions.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual funds*: Valued based on quoted prices of identical assets in active markets.

**NOTE 5 — FIXED INCOME INVESTMENT CONTRACT**

The Plan has entered into Voya Fixed Income Account, a fully benefit-responsive guaranteed investment contract with Voya Financial Insurance and Annuity Company (VFIAC). VFIAC maintains the contributions in a general account. Contract value is the relevant measure for fully benefit-responsive investment contracts because it is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The contract value of the Voya Fixed Income Account fully benefit-responsive investment contract at December 31, 2024 and 2023 was \$85,933 and \$97,136, respectively.

**NOTE 5 — FIXED INCOME INVESTMENT CONTRACT (Continued)**

The contract issuer is contractually obligated to repay the principal and specified interest at a specified interest rate that is guaranteed to the Plan. The minimum interest rate is guaranteed not to be less than 1.00% through December 31, 2024 and 2023. The crediting rate is based on a formula established by the contract issuer. The crediting interest rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events, such as the Plan's failure to qualify under Section 401(a) of the Internal Revenue Code (IRC) or the failure of the trust to be tax-exempt under Section 501(a) of the IRC, premature termination of the guaranteed investment contract by the Plan or termination of the Plan, would limit the Plan's ability to transact at contract value with VFIAC. The Plan Administrator believes the occurrence of such events that would limit the Plan's ability to transact at contact value with participants is unlikely.

**NOTE 6 — INCOME TAX STATUS**

The Plan is based on a prototype plan developed by The Finway Group, LLC, which has received a letter from the IRS dated June 30, 2020 stating that the prototype plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is tax exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or asset, or disclosure in the financial statements. The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 — PARTY-IN-INTEREST TRANSACTIONS**

Plan investments include a fully benefit-responsive investment contract managed by Voya, the Trustee of the Plan. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Certain employees and officers of the Company, who are also participants in the Plan, perform administrative services for the Plan at no cost to the Plan. These investments and transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules under ERISA.

**NOTE 8 — PROHIBITED TRANSACTIONS**

During the years ended December 31, 2024 and 2023, the Company inadvertently failed to deposit participant deferrals of approximately \$86,733 and \$160,874, respectively, within the required timeframe as stated by the Department of Labor (DOL). The DOL considers late deposits to be prohibited transactions. The Company intends to make deposits into the Plan for lost earnings attributable to the delinquent contributions and loan payments to fully correct the prohibited transactions.

**NOTE 9 — SUBSEQUENT EVENTS**

The Plan's management has evaluated subsequent events through October 3, 2025, the date the financial statements were available to be issued.
