Notes to Financial Statements  
December 31, 2024

**1. Description of Plan**

The following description of the Horizon Medical Group, PC 401(k) Profit Sharing Plan and Trust (the "Plan") is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution plan covering employees of Horizon Medical Group, PC (the "Company" or "Employer") who have completed 6 months of service and are 21 years of age or older. Employees who are nonresident aliens, leased employees, or are part of a union are not eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

***Contributions***

Each year, participants may elect to have a percentage or specified dollar amount deducted from their eligible compensation as defined by the Plan document. The participant contribution to the Plan can be made on a pre-tax basis. Roth deferrals are not permitted. Participants who are age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. A participant may elect to increase, decrease or suspend deductions according to procedures established by the Company. There is an annual limit as to the amount that can be deducted from compensation that is determined by the Internal Revenue Code ("IRC").

The Employer makes a safe harbor non-elective contribution in the amount equal to 100% of each participant's elective contribution up to 6% of their eligible compensation. Employer safe harbor contributions made to the Plan amounted to \$1,623,813 for the year ended December 31, 2024.

The Employer may make discretionary profit-sharing contributions in amounts set by the Employer each year. Employees do not have to make 401(k) contributions in order to receive a discretionary profit-sharing contribution, which is based on participant compensation. Employees must reach 1,000 hours of service and be employed at the end of the Plan year in order to receive a discretionary profit-sharing contribution. There were no employer discretionary profit-sharing contributions made to the Plan for the year ended December 31, 2024.

***Participant Accounts***

Each participant's account is credited with the participant's contribution and allocations of (a) Employer's contributions and (b) Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**1. Description of Plan (continued)**

***Vesting***

Participants are immediately vested in their contributions and Employer safe harbor matching contributions and actual earnings thereon. Vesting in the Company's profit-sharing contributions is based on years of credited service. Participants vest in the Company's contributions, if any, based on the schedule below:

***Forfeiture***

At December 31, 2024 and 2023, forfeited account balances held in non-participant directed accounts were \$17,991 and \$12,504. These forfeiture amounts can be used to reduce administrative expenses and future Employer contributions. During 2024, \$2,041 of forfeitures were used to reduce Employer contributions. None were used to reduce administrative expenses.

***Payment of Benefits***

Upon termination of service due to death, disability, retirement or other reason, a participant is entitled to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Withdrawals from the Plan may also be granted based upon circumstances of financial hardship or after attaining age 59.5, in accordance with provisions specified in the Plan document.

***Expenses***

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in the net asset value ("NAV") of the respective investment vehicle and consequently, those expenses are not separately reflected but are a component of net appreciation in fair value of investments.

***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum amount of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50 % of their account balance. Participants may have up to two loans outstanding at a time. Loan terms range from 1-5 years or up to 15 years for the purchase of a primary residence. Loans are secured by the balance in the participant's account and bear interest at the prime rate plus 2%. Principal and interest are paid ratably through payroll deductions.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting and Use of Estimates***

The accompanying financial statements have been prepared in accordance accounting principles generally accepted in the United States of America (“U.S. GAAP”), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. As of December 31, 2024 and 2023, the Plan’s investments were valued using level 1 inputs.

***Investment Valuation and Income Recognition***

The Plan’s investments are stated at fair value. The mutual funds and money market funds are valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission and are deemed to be actively traded. These funds are required to publish their daily NAV and to transact at that price.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a deemed distribution is recorded when a distributable event occurs.

***Payment of Benefits***

Benefits are recorded when paid.

***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 1, 2025.

**3. Information Certified (Unaudited)**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus, LLC as an agent of Ascensus Trust Company, a qualified institution.

**4. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants will become 100% vested in their accounts.

**5. Tax Status**

The Internal Revenue Service (“IRS”) has determined and informed the prototype plan sponsor by an opinion letter dated June 30, 2020, that the prototype Plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

**6. Party-in-Interest Transactions**

Certain investments of the Plan are managed by Vanguard Group, Inc. through Ascensus Trust Company. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

**7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
