## INDEPENDENT AUDITORS' REPORT

To the Participants and Administrator of  
The Timken ARB Savings and Investment Retirement Plan  
North Canton, Ohio

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Timken ARB Savings and Investment Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal controls relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## 1. Description of the Plan

The following description of The Timken ARB Savings and Investment Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. Copies of the Plan document are available from the Plan Administrator, The Timken Company (the "Company").

### General

On January 31, 2023, the Company acquired American Roller Bearing, Inc. ("ARB"). The Plan was formed effective as of April 1, 2023. ARB assumed the role of the Plan Sponsor. The Plan is a defined contribution plan covering substantially all non-bargaining employees of ARB. The Plan Administrator is responsible for the day-to-day administration and operation of the Plan and has full discretionary authority to interpret the Plan, including its terms. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Empower Trust Company, LLC (formerly known as Great West Trust Company, LLC) is the trustee ("Trustee") for the Plan, and the Plan has adopted the Empower Trust Company Defined Contribution Prototype Plan. The Plan's adoption agreement was adopted effective April 1, 2023, and amended effective July 13, 2023.

### Eligibility

An employee becomes eligible to contribute to the Plan upon the first day of the month after reaching six months of service. Eligible employees may become participants immediately following or coincident with the date on which eligibility requirements are met.

### Contributions

Each year, participants may contribute up to 75% of pretax annual compensation, as defined in the Plan, not to exceed the limits of the Internal Revenue Code. In addition, participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions, which are also subject to the Internal Revenue Service ("IRS") limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans, referred to as rollovers.

The Plan provides for a non-elective discretionary contribution by the Company. Effective July 13, 2023, the Plan was amended for the Plan Sponsor to make a special fixed non-elective contribution in 2023, allocated in two payments. Participants who are employed on the date that the special contribution is allocated are eligible to receive the contribution.

Non-elective contributions totaled \$344,086 for the year ended December 31, 2024. The non-elective contribution amount was included in The Timken Company contributions on the Statement of Changes in Net Assets Available for Benefits. Non-elective contributions, including the special fixed non-elective contribution, totaled \$1,125,943 for the year ended December 31, 2023.

The Plan provides for a discretionary matching contribution by the Company. For the years ended December 31, 2024 and 2023, there were no discretionary matching contributions.

In 2025, the Plan sponsor identified an error in the definition of eligible compensation that resulted in certain participants not deferring the correct amounts to the Plan. Corrective contributions, including applicable lost earnings, totaling \$27,016, related to the years ending December 31, 2024 and 2023, were credited to the affected participants' accounts during the third quarter of 2025.

### Participant Accounts

Each participant's account is credited with the participant's contributions, the Plan Sponsor's contributions, and an allocation of Plan earnings. The participant's account is charged with an allocation of administrative expenses. Allocations are proportionally based on the value of account balances or as an equal dollar amount based on the number of participants in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**1. Description of the Plan (continued)**

**Vesting**

Participants are immediately vested in their contributions, employer contributions, and related earnings.

**Investment Options**

Upon enrollment in the Plan, a participant may direct all contributions to selected investments as made available and determined by the Plan Administrator. Investment options are generally intended to be long-term investments suitable for retirement savings and not designed to accommodate frequent exchanges by participants. The Plan Administrator and/or the entities that provide investments and administrative services to the Plan may adopt procedures to discourage frequent investment transactions.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less, reduced by the highest outstanding loan balance during the past 12 months or any existing loan balances on the date a new loan is made. Loan terms range up to thirty years as established by the Plan Administrator at the time of the loan. The loans initiated under the Plan bear interest at the Prime Rate at the time the loans were made plus 1%. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits**

Upon disability or termination of service with the Company, participants having a vested account balance greater than \$5,000 are given the option of (i) transferring their account balance to another plan, (ii) receiving a lump-sum amount equal to the vested balance of their account, (iii) receiving installment payments of their vested assets over a fixed year of time not to exceed their estimated life expectancy, or (iv) leaving their vested account balance in the Plan. Participants having a vested account balance less than \$5,000 receive a lump-sum amount equal to their vested account balance. Participants electing to leave their vested assets in the Plan may do so until age 73, after which time the lump-sum or installment distribution options would apply. Participants are also able to receive partial or total distributions of their vested accounts upon attainment of age 59-1/2 without regard to the source of funds in their accounts.

Hardship withdrawals are allowed for participants incurring an immediate and severe financial need, as defined by the Plan. Hardship withdrawals are strictly regulated by the IRS and a participant must exhaust all available loan options and distributions prior to requesting a hardship withdrawal.

**Plan Termination**

Although it has not expressed any interest to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the Plan's Trustee, Empower Trust Company, LLC, shall distribute to each participant the vested balance in their separate account.

## **2. Accounting Policies**

### **Basis of Accounting**

The financial statements have been prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

### **Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes and supplemental schedules. Actual results could differ from those estimates.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

### **Payment of Benefits**

Benefits are recorded when paid. No amounts were allocated to accounts of persons who have elected to withdraw from the Plan but were not yet paid as of December 31, 2024 and 2023.

### **Expenses**

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Administrative expenses include fees related to the administration of certain recordkeeping functions and are charged directly to the participant's account. Investment related expenses are included in net appreciation of fair value of investments.

### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value and are invested in the Master Trust Agreement for The Timken Company Defined Contributions Plans ("Master Trust"), which was established for the investment of assets of the Plan and the seven other defined contribution plans sponsored by the Company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**4. Investments**

The Plan's assets are held in the Master Trust and are commingled with assets of other benefits plans sponsored by the Plan Administrator.

Each participating plan's interest in the investment funds (i.e., separate accounts) of the Master Trust is based on account balances of the participants and their elected investment funds. The Master Trust assets are allocated among the participating plans by assigning to each plan those transactions (primarily contributions, benefit payments, and plan-specific expenses) that can be specifically identified and by allocating among all plans, in proportion to the fair value of those assets assigned to each plan, income and expenses resulting from the collective investment of the assets of the Master Trust. The Plan's ownership percentage in the Master Trust as of December 31, 2024 and 2023, was 1.00% and 1.06%, respectively.

**5. Fair Value**

Fair value is defined as the price that would be expected to be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Accounting Standards Codification ("ASC") 820, Fair Value Measurements and Disclosures, are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices in active markets that are accessible to the Plan at the measurement date for identical assets or liabilities.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for assets or liabilities;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable inputs for assets or liabilities. Level 3 inputs include management's own assumption about the assumptions that market participants would use in pricing the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Registered investment companies are valued based on quoted market prices reported on the active market on which the individual securities are traded.

Common collective funds are valued using the net asset value (“NAV”) based on the fair value of the underlying investments held by the fund.

The Fidelity BlueChip Growth Fund seeks long-term growth of capital by investing primarily in common stocks of well-established companies that the portfolio manager believes have above-average growth potential. The portfolio normally invests in blue chip companies whose stock is included in the S&P 500 Index or the Dow Jones Industrial Average, and companies with market capitalizations of at least \$1 billion.

The Vanguard Target Retirement Trust Funds invest in broad index funds of U.S. and international stocks and bonds. The asset allocation of each fund is managed in accordance with the designated strategy for each fund’s target retirement year. The funds are automatically rebalanced to designated glide paths.

The JPMCB Core Bond Fund invests primarily in a diversified portfolio of intermediate and long-term debt securities.

The SSgA Russell Small Cap Index Fund and the State Street Russell Small Cap Index Fund include investments seeking an investment return that approximates as closely as practicable, before expenses, the performance of the Russell 2000 Index over the long term. The fund includes exposure to stocks of small U.S. companies.

The William Blair Small Cap Growth Fund invests in small cap companies expected to have strong earnings growth. The fund's underlying investments include companies with market leadership positions, unique products or processes, strong marketing capability, and rapid industry growth expectations.

The T.Rowe Price Stable Value Funds primarily invest in security backed investment contracts.

The Western Asset Core Plus Bond strategy seeks to maximize total return through a well-diversified, long-term value based core fixed-income portfolio that includes limited opportunistic exposure to the “plus” sectors: high-yield, non-U.S. and emerging market debt. The strategy seeks to approximate the risk of the Bloomberg Barclays U.S. Aggregate Index.

The SSgA S&P 500 Index Fund and the State Street S&P 500 Index Fund include investments seeking an investment return that approximates as closely as practicable, before expenses, the performance of the S&P 500 Index over the long term. The funds includes exposure to stocks of large U.S. companies.

The SSgA Global All Cap Equity ex-U.S Index Fund includes investments seeking an investment return that approximates as closely as practicable, before fees and expenses, the total return performance of a broad-based index of world (ex-U.S.) equity markets over the long term.

**6. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**7. Income Tax Status**

The Empower Trust Company, LLC is the trustee for the Plan, and the Plan has adopted the Empower Trust Company Defined Contribution Prototype Plan. This prototype plan is used for several of the plans in the Master Trust. The prototype plan the Plan has adopted received a determination letter from the IRS dated June 30, 2020, stating that the Plan is qualified under Section 401(a) of the Internal Revenue Code (the "Code"), and therefore, the related trust is exempt from taxation. Subsequent to this determination by the Internal Revenue Service, the Plan was amended. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and therefore believes the Plan, as amended, is qualified and the related trust is tax-exempt. The Plan Administrator will take steps to ensure that the Plan's operations remain in compliance with the Code, including taking appropriate action, when necessary, to bring the Plan's operations into compliance.

Accounting principles generally accepted in the United States require plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**8. Related-Party Transactions**

Certain legal and accounting fees and certain administrative expenses relating to the maintenance of participant records are paid by the Company. Fees paid during the year for services rendered by parties in interest were based on customary and reasonable rates for such services.

**9. Subsequent Events**

Management evaluates subsequent events and transactions occurring subsequent to the date of the financial statements through October 3, 2025, the date the financial statements were available to be issued, that affect recognition or disclosure to the financial statements. In 2025, the Plan corrected an error related to an error in the definition of eligible compensation. Refer to Note 1 for further information. No other subsequent events were identified.
