### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Dynax America 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Dynax America 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Note 1 – Plan Description

---

The following description of the Dynax America 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

#### *General*

The Plan is a defined contribution plan covering substantially all employees of Dynax America Corporation (the “Plan Sponsor”) who have completed one six-month period of service in which they are credited with at least one hour of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### *Contributions*

Participants may contribute a portion of their eligible compensation on a pretax or after-tax basis as defined by the Plan, subject to certain limitations. The statutory maximum amount of contributions allowed was \$23,000 for the year ended December 31, 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to the limit imposed by law. Participants may also contribute (or rollover) amounts representing distributions from other qualified defined benefit or contribution plans. The Plan Sponsor makes discretionary matching contributions up to 3% of eligible compensation. The Plan Sponsor may also make a discretionary profit-sharing contribution; however, there was no discretionary profit-sharing contribution made during 2024.

#### *Participant Accounts*

Each participant’s account is credited with the participant’s contributions and Plan Sponsor matching contributions, as well as allocations of the Plan Sponsor’s discretionary profit-sharing contributions, if any, and Plan earnings. Participant accounts are charged with participant distributions and an allocation of administrative expenses. Earnings are allocated by fund based on the ratio of a participant’s account invested in a particular fund to all participants’ investments in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. The Plan Sponsor’s discretionary matching contributions, if any, are allocated based upon participants’ contributions to the Plan.

#### *Forfeited Accounts*

At December 31, 2024 and 2023, the Plan had no outstanding forfeited non-vested amounts. Under the Plan, these amounts are applied to reduce future Plan Sponsor contributions. During the year ended December 31, 2024, Plan Sponsor contributions were reduced by \$26,316 from forfeited non-vested amounts.

### *Vesting*

Participants are 100% vested in their own rollover, pretax, and after-tax contributions at all times. A participant also becomes 100% vested upon death, becoming permanently disabled, or reaching the normal retirement age, as defined by the Plan. Participants are vested in the Plan Sponsor's contributions to the Plan according to the following schedule:

### *Notes Receivable from Participants*

Participants may borrow from the vested portion of their accounts an amount not less than \$1,000 and not more than the lesser of 50% of the vested account balance or \$50,000. Borrowings are treated as a transfer between the investment funds and notes receivable from participants. Terms range from one to five years. A borrowing is secured by the balance in the participant's account and bears interest at the prime rate, as published in *The Wall Street Journal* on the day of the loan request, plus 2%. Principal and interest are paid ratably through payroll deductions. Interest rates on loans at December 31, 2024 ranged from 5.25% - 10.50%.

### *Investment Options*

A participant may direct the investment of their account into any one or combination of investment fund options. The Plan's current investment offerings include mutual funds, target date funds, and a guaranteed investment contract.

### *Benefit Payments*

Distributions can be made due to retirement, death, disability, or termination of employment and are subject to the applicable provisions of the Plan Agreement. The participant's vested account balance can be paid in a lump-sum, direct rollover to another qualified plan, or installments to the participant or their beneficiaries. In-service withdrawals are available for hardships or upon a participant attaining age 59 ½.

### *Administrative Expenses*

Substantially all of the Plan's administrative expenses, which include primarily custodial, investment management, and professional fees for services provided by parties in interest, are paid by the Plan Sponsor as provided in the Plan Agreement. Transactional fees for loans and distribution processing are paid by the participants from their account balances.

### Note 2 – Summary of Significant Accounting Policies

---

#### *Basis of Accounting*

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

#### *Use of Estimates*

The preparation of financial statements in conformity with GAAP requires the Plan's Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

#### *Cash*

The Plan's cash at December 31, 2023 consisted of a non-interest-bearing cash account held by the Plan's Trustee. This account was not insured by the Federal Deposit Insurance Corporation (FDIC).

#### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

#### *Valuation of Investments and Income Recognition*

The Plan's investments are stated at fair value with the exception of fully benefit-responsive investment contracts, which are presented at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### *Payment of Benefits*

Benefit payments are recorded when paid to participants.

### *Subsequent Events*

Subsequent events have been evaluated through September 17, 2025, the date the financial statements were available to be issued.

Effective January 1, 2026, the Plan document was amended to no longer allow catch-up contributions.

### **Note 4 – Fair Value Measurements**

---

The Plan's mutual funds are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

### Level 1 Fair Value Measurements

The fair values of mutual funds are based on quoted net asset values of the shares held by the Plan at year end.

## Note 5 – Guaranteed Investment Contract

The Plan has invested in the CUNA Mutual Stable Value Fund issued by the CMFG Life Insurance Company. This investment meets the fully benefit-responsive investment contract criteria and is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. This investment is a single group annuity contract with a fixed rate of interest which is reset on a quarterly basis. The average yield earned by the Plan is the yield earned on the group annuity contract. The average yield for the fund was 1.75% and 1.66% for the years ended December 31, 2024 and 2023, respectively. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

With traditional investment contracts, the Plan owns only the contract itself. Traditional investment contracts are designed to accrue interest based on crediting rates established by the contract issuers.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1 percent. The crediting rate is reviewed on a semi-annual basis for resetting. The contract cannot be terminated before the scheduled maturity date.

## Notes to Financial Statements

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

- The Plan's failure to qualify under Section 401(a) of the *Internal Revenue Code (IRC)* or the failure of the trust to be tax-exempt under Section 501(a) of the *IRC*.
- Premature termination of the contracts.
- Plan termination or merger.
- Changes to the Plan's prohibition on competing investment options.
- Other Plan Sponsor events that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

- An uncured violation of the Plan's investment guidelines.
- A breach of material obligation under the contract.
- A material misrepresentation.
- A material amendment to the agreements without the consent of the issuer.

### Note 6 – Plan Termination

---

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. The Plan Administrator will facilitate the distribution of account balances in single lump-sum payments to each participant in accordance with Plan provisions until all assets have been distributed by the Trustee.

### Note 7 – Income Tax Status

---

The Internal Revenue Service (IRS) has issued an opinion letter dated June 30, 2020, indicating that the prototype plan document adopted by the Plan, as then designated, qualifies under the applicable sections of the *IRC*. The Plan has not received a determination letter specific to the Plan itself; however, the Plan Administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the IRS. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 there were no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no tax audits in progress.

### Note 8 – Party-in-Interest Transactions

---

The Plan invests in a guaranteed investment contract with CMG, the record-keeper for the Plan, and these transactions, therefore, qualify as party-in-interest transactions. In addition, notes receivable from participants are considered to be party-in-interest transactions because they are transacted with Plan participants. Fees paid during the year for accounting and other services rendered by parties in interest were based on customary and reasonable rates for such services.

Certain administrative functions are performed by officers or employees of the Company. These employees are also Plan participants. No such officer or employee receives compensation from the Plan.
