## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Participants of the Plan  
Protective Life Corporation 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Protective Life Corporation 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

**1. DESCRIPTION OF PLAN**

The following description of the Protective Life Corporation 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan's legal document and/or Summary Plan Description (SPD) for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Protective Life Corporation (the Employer or the Company) is the sponsor of the Plan.

**Plan Administration**

Fidelity Management Trust Company (Fidelity) serves as trustee and custodian of the Plan. Fidelity Workplace Services, LLC serves as the recordkeeper of the Plan. The Retirement Committee, whose members are appointed by the President of the Company, has overall responsibility for the operation and administration of the Plan. CAPTRUST Financial Advisors serves as investment manager fiduciary as defined by ERISA 3(38) for the Plan, and therefore, determines the appropriateness of the Plan's investment options and monitors investment performance.

**Eligibility**

In general, all employees of the Company and its participating subsidiaries are eligible to participate in the Plan, except for independent contractors, leased employees, nonresident aliens with no income from a U.S. source, insurance agents who provide services pursuant to an employee/producer agreement or similar contract, union members (unless the collective bargaining agreement provides for participation in the Plan), and employees who are classified by the Employer as a liaison or a seconded worker (unless otherwise determined by the Retirement Committee or provided pursuant to a written agreement).

**Contributions**

Eligible employees may contribute up to 75% of their eligible compensation to the Plan, subject to certain limitations under the Internal Revenue Code (IRC). The Plan allows participants to contribute to the Plan through pre-tax elective deferrals or post-tax Roth elective deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Employees may roll over eligible amounts from other qualified plans.

The Company matches employees' pre-tax, Roth, and catch-up contributions dollar-for-dollar on the first 4% of eligible pay contributed to the Plan. The Employer provides cash-matching for participant contributions to the Plan. These cash matching contributions are invested according to the participants' investment elections for their pre-tax and/or Roth contributions.

**Participants' Accounts/Benefits**

An account is maintained for each participant in the Plan. The accounts are credited with the participants' pre-tax, Roth, catch-up and rollover contributions, Employer matching contributions, and investment earnings. Distributions, withdrawals, investment losses and allocated expenses are subtracted from the account balances. Participants' vested account balances represent the

benefits available to the participants upon retirement, disability, death, termination of service or upon reaching age 59½.

Subsequent to the benefit eligibility date, a participant may elect to receive a taxable distribution equal to the vested balance of his or her account or may leave it in the Plan if the vested balance is \$1,000 or more. Terminated participants can also take a partial withdrawal. However, benefit payments must commence no later than April 1 following the year the participant reaches age 73 if the participant is not actively employed.

**Investment of Assets**

Participants direct their contributions, the Company's contributions and any related earnings to one or more investment options provided by the Plan in 1% increments. Participant accounts are segregated for the purpose of determining the gains or losses on investments.

**Vesting**

Participants are immediately vested in salary deferral amounts, Company contributions and balances rolled over into the Plan from other qualified plans

**Notes Receivable from Participants**

Provisions of the Plan allow participants to obtain loans based on their vested account balance. Loans may be made only from the employee-contributed portion of a participant's individual account balance, including earnings thereon. Personal loans are made for terms of one to 60 months at a fixed rate of interest equal to the prime rate plus 1% at the time the loan is made. Loans to acquire a principal residence are made for terms up to 15 years. In addition, the Plan acquired some rollover loans as part of an acquisition that were made for terms up to 25 years.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Presentation**

The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America (GAAP).

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions which affect the reported amounts in the financial statements and the accompanying notes. Actual results could differ from those estimates.

**Risks and Uncertainties**

Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivables from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Payment of Benefits**

Benefits are recorded as paid. As of December 31, 2024 and 2023, there were no benefit payments requested and not yet disbursed.

**Administrative Expenses**

As permitted by the Plan document, fees related to the administration and maintenance of notes receivable from participants and processing distributions are charged directly to the participant's account and included in administrative expenses. Plan administrative expenses for recordkeeping, trustee and investment advisory services are paid by the Plan or offset by a revenue sharing credit.

**3. FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under this standard are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by

correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Mutual Funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Security and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Trust Funds* – The common collective trust funds are valued using the daily NAV provided by the administrator of the respective fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding. There are no significant restrictions such as redemption terms, or holding periods, which would limit the ability of the Plan or the participants to transact at the NAV. Participant transactions may occur daily.

These methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 4. INVESTMENTS AND FINANCIAL DATA CERTIFIED BY TRUSTEE

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity.

#### 5. INCOME TAX STATUS

The Plan received a favorable determination letter from the Internal Revenue Service (IRS) dated September 28, 2017, related to the Plan document. The Plan has been amended since receiving the determination letter; however, the Plan's administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore, the Plan, including amendments, continues to qualify under Section 401(a), and the related trust continues to be tax-exempt. Accordingly, the accompanying financial statements do not include a provision for income taxes.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**6. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are held in shares of mutual funds and units of a common collective trust fund managed by Fidelity. Fidelity is the Plan trustee and custodian of the Plan, and therefore, these transactions qualify as party-in-interest transactions.

Administrative fees paid by the Plan for the 2024 Plan year totaled \$574,546. These fees were paid to the investment advisor as well as the trustee and recordkeeper. As such, these expenses qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions. Administrative expenses are paid through the Plan's suspense account, and as of December 31, 2024 and 2023, the unallocated balance in the suspense account totaled \$128,112 and \$68,066, respectively. The suspense account earned \$8,169 in net investment income for the year ending December 31, 2024.

**7. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. Upon termination, all amounts credited to participant accounts remain 100% vested.

**8. SUBSEQUENT EVENTS**

Management has evaluated events through October 6, 2025, which is the date that the financial statements were available to be issued and has determined that there are no subsequent events that require disclosure under FASB ASC Topic 855, *Subsequent Events*.
