NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following brief description of the Lakeview Health 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan document for more information and a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established to provide retirement benefits to employees of Lakeview Health Services, Inc. (Lakeview) who meet certain eligibility requirements. Ascensus is the recordkeeper of the Plan and Ascensus Trust Company (Ascensus Trust) serves as the Plan's directed trustee and custodian. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

An employee must reach the minimum age of 21 to be eligible to participate in the Plan. An employee must also complete 6 consecutive months, during which they render at least 500 hours of service, before they are eligible to participate in the Plan. The initial eligibility measuring period is the employee's first 12 months of employment beginning at the hire date. If an employee does not satisfy the eligibility requirements during that initial measuring period, eligibility will be calculated based on the Plan year.

Contributions

Active participants may make voluntary pre-tax contributions in the form of salary deferrals and any applicable rollovers from other qualified plans, subject to certain limitations of the Plan and the Internal Revenue Code (IRC) under Section 401(k). Eligible participants, who attain the age of 50 before the end of the Plan year, are eligible to make catch-up contributions, subject to certain limitations of the Plan and the IRC. The Plan includes an auto enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a portfolio of investments based on the participant's normal retirement date until changed by the participant. For the Plan years ended December 31, 2024 and 2023, Lakeview made safe harbor matching contributions to the Plan equal to 100% of the first 3% of a participant's compensation deferred into the Plan, and 50% on contributions exceeding 3%, but not more than 5% of a participant's annual eligible compensation.

Lakeview may also contribute a discretionary profit-sharing contribution to the Plan as determined by the Board of Directors. No discretionary contributions were made in 2024 or 2023. Participants direct the investment of their contributions and Lakeview's contributions into various investment options offered by the Plan.

1. DESCRIPTION OF PLAN (Continued)

Participant Accounts

Each participant's account is credited with the participant's contribution, Lakeview's matching contribution, an allocation of Lakeview's discretionary contribution and account earnings (losses). The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately fully vested in their voluntary contributions, Lakeview's safe harbor matching contributions, and actual earnings or losses thereon. The Plan provides that Lakeview's discretionary contributions vest at a rate of 50% upon completion of two years of credited service, and 100% upon completion of three years of credited service. A participant is 0% vested in discretionary contributions prior to reaching two years of credited service. Alternatively, participants become 100% vested when they have attained age 55 or due to death or total and permanent disability.

Payment of Benefits

A participant may withdraw any part of the vested account upon termination of service or attainment of normal retirement age, which is 59 ½. A participant or beneficiary may receive an amount equal to the value of the participant's vested interest in the account in a lump-sum amount.

Notes Receivable from Participants

Plan participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, and have a maximum of one outstanding loan. The minimum loan is \$1,000. Notes receivable must generally be repaid over a period not longer than 5 years for general loans and 30 years for residential loans. Notes receivable from participants are secured by their account balances. All notes receivable bear interest at the prime rate.

Forfeitures

Forfeitures of non-vested account balances are used to reduce the Lakeview contributions or to pay administrative expenses of the Plan. No forfeitures were used to pay plan expense in 2024 and 2023. There were no unallocated forfeitures at either December 31, 2024 and 2023.

Administration Expenses

Substantially all administrative expenses of the Plan are paid by Lakeview.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared in conformity with accounting principles generally accepted in the United States of America (GAAP).

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Changes in the current value of investments held during the year, including realized gains and losses on assets bought and sold during the year, are reflected in the statements of changes in net assets available for benefits as net appreciation or depreciation in the fair value of investments. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest is recorded on the accrual basis.

Fair Value Measurement

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair market value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Money market funds and mutual funds are measured at fair value, based on the quoted market prices in active markets (Level 1 inputs).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no changes in the valuation methodologies used during 2024 or 2023.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Payments of Benefits

Benefits are recorded when paid.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Estimates

The preparation of financial statements in accordance with GAAP requires the Plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

5. PLAN TERMINATION

Although it has not expressed any intent to do so, the trustee of the Plan has the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event of termination, partial termination, or complete discontinuance of contributions to the Plan, participants will become fully vested in all amounts credited to their accounts. All distributions would be made in accordance with any applicable requirements of the Employee Retirement Income Security Act of 1974 and the Internal Revenue Code.

6. TAX STATUS

The Plan is based on a prototype plan document. The Plan has relied on an opinion letter from the Internal Revenue Service, dated June 30, 2020, as to the prototype plan's qualified status. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

7. PARTY-IN-INTEREST TRANSACTIONS

Ascensus is the recordkeeper of the Plan and Ascensus Trust serves as the Plan's directed trustee and custodian of Plan assets. As such, transactions between Ascensus, Ascensus Trust and the Plan qualify as party-in-interest transactions. In addition, notes receivable from participants qualify as party-in-interest transactions.

8. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

Certain items have been classified differently between the financial statements and Form 5500. Net assets available for benefits and changes in net assets available for benefits per the financial statements agree to Form 5500 in total as of and for the years ended December 31, 2024 and 2023.

9. SUBSEQUENT EVENTS

Subsequent events have been evaluated through October 1, 2025, which is the date the financial statements were available to be issued.
