Note 1 – Plan Description

The following description of the Lutech Resources, Inc. 401(k) Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan, which commenced effective March 1, 2014, is a defined contribution 401(k) plan covering certain regular full-time and regular part-time employees who are working in the United States. Certain employees who are transferred to work outside the United States must be on the Employer’s U.S.-based payroll system to be eligible to participate in the Plan. The Plan is sponsored by Lutech Resources, Inc. (the “Company,” “Plan Sponsor,” or “Employer”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and the Internal Revenue Code (“IRC”). The Plan was amended and restated effective January 1, 2022, to comply with current law.

Plan Custodian, Trustee, and Recordkeeper

Fidelity Management Trust Company (“Fidelity,” the “Custodian,” “Trustee,” or “Recordkeeper”) is the Custodian maintaining custody of all investments held by the Plan, maintaining the Plan’s participant account balances, and providing recordkeeping services to the Plan. Among other duties, the Custodian receives contributions, holds and invests the fund assets in accordance with the directions of participants, and makes distributions as directed by the Plan Administrator. Fidelity also serves as the Plan’s Trustee.

Eligibility and Plan Entrance Date

All employees, except for nonresident aliens, union employees, leased employees, residents of Puerto Rico; employees who are not paid through the Employer's U.S.-based payroll system; temporary employees; co-ops; interns; benefit ineligible employees and employees who are in the United States on an F-1 Visa; or independent contractors are permitted to participate in the Plan. In addition, highly compensated employees as defined by the Plan are not eligible to participate. Eligible employees are permitted to enter the Plan upon the first day of each payroll period after which the employee has satisfied the eligibility requirements.

The Plan also includes an automatic escalation feature where each year, participants may elect to have their pre-tax deferral rate increased by 1%, 2%, or 3% annually until a deferral rate of 20% is reached, unless they elect otherwise.

Participant Contributions

The Plan allows participants to contribute, on a pre-tax or after-tax Roth basis, up to 75% of their annual compensation as defined by the Plan, subject to the annual deferral limit established by the IRC, which was \$23,000 for 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of up to the maximum amount allowed annually by the IRC, which was \$7,500 for 2024. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (“rollovers”).

Employer Contributions

The Company may make discretionary Employer contributions as determined by the Company. The Company has not elected to make Employer contributions since the Plan’s inception. For the year ended December 31, 2024, the Company made no qualified nonelective contributions to correct missed deferral opportunities for the Plan year then ended.

Note 1 – Plan Description (continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of any Company contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions, plus actual earnings thereon. CB&I company contributions transferred into the Plan are subject to the former CB&I Savings Plan's vesting schedules. CB&I Safe Harbor company matching contributions made for the period from January 1, 2014 through February 28, 2014, are 100% vested, and CB&I company matching and annual CB&I company contributions made prior to January 1, 2014, are subject to a three-year cliff vesting schedule.

Participant-Directed Investments

All assets of the Plan are participant-directed investments. Participants have the option of directing their account balances to one or more investment options offered by the Plan. The Plan has selected various investment options, as more fully described in the Plan Document, to which participants may designate the allocation of their account balances. The options vary in types of investments, rates of return, and investment risk.

Notes Receivable from Participants

Participants may borrow from their vested account balance up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The minimum loan amount is \$1,000. Participants may only have one loan outstanding at any given time. Notes receivable from participants are secured by the balance in the participant's account and bear interest at 1% above Prime rate, as defined. Principal and interest of the loans are paid ratably through payroll deductions over a period of up to five years or up to ten years for a loan related to the purchase of a principal residence.

Payment of Benefits

Upon separation of service due to death, disability, retirement, or termination of employment, a participant may elect to receive a lump sum payment equal to the value of the participant's vested balance.

Prior to January 1, 2024, if a terminated participant's vested account balance was less than \$5,000, the Plan permitted immediate lump sum distributions. Effective January 1, 2024, the threshold for such distributions increased from \$5,000 to \$7,000. If there is no direction from the participant and the vested balance is greater than \$1,000 but less than the threshold effective on the date of the distribution, the vested balance is distributed as a direct rollover into an individual retirement account selected by the Plan Administrator. Vested balances of \$1,000 or less are distributed as a lump sum.

The Plan allows hardship withdrawals in accordance with IRC regulations. Among other things, the withdrawal must be necessary based upon an immediate and heavy financial need of the employee and is limited to certain purposes. Active participants at the age of 59½ or older may also withdraw all or any part of their vested account.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in conformity with the accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions based on the terms of the Plan agreement.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses for maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain expenses specifically incurred by, or attributable to, a participant will be paid from that participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in the fair value of investments.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1), and the lowest priority to unobservable inputs (level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 820 are as follows:

Note 3 – Fair Value Measurements (continued)

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology that are unobservable inputs for the assets or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money Market Fund – Valued at cost, which approximates fair value and is classified within level 1 of the valuation hierarchy.

Common Collective Trust Funds:

Stable Value Common Trust Fund – Primarily comprised of fully benefit responsive investment contracts that are valued at the NAV of units of the collective trust. The NAV is used as a practical expedient to estimate fair value; however, the practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily and there are no unfunded commitments. There are no significant restrictions on participant redemptions; however, if the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months’ notification in order to ensure that securities liquidations will be carried out in an orderly manner.

Other Common Collective Trust Funds – Determined by the NAV provided by the fund administrator. Although the NAV’s unit prices are quoted on a private market that is not active, the unit prices are based on underlying investments which are traded on an active market (market approach). There are also no restrictions on the NAV price or its equivalent. Participant transactions (purchases and sales) may occur daily and there are no unfunded commitments. There are no significant restrictions on participant redemptions; however, if the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require up to 60 days’ notification in order to ensure that securities liquidations will be carried out in an orderly manner.

Note 5 – Related Party and Party-in-Interest Transactions

Certain Plan investments are managed by Fidelity. Fidelity is the Trustee and recordkeeper and provides securities brokerage services for the self-directed brokerage account for the Plan. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA. All investment fund earnings or losses posted to each participant's account are net of investment management fees charged by each investment fund under the Plan.

The Plan has notes receivable from participants as of December 31, 2024 and 2023. These receivables and all related transactions qualify as party-in-interest transactions. These transactions are exempt from being prohibited transactions by ERISA.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

Note 7 – Tax Status

The Internal Revenue Service ("IRS") has determined and informed the Company by a letter dated November 8, 2017, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. The Plan has been amended since receiving the determination letter; however, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC. As such, the Plan Administrator and the Plan's tax counsel believe that the Plan is qualified, and the related trust is tax-exempt as of the financial statement date. No provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rates, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

During 2023, the Plan Sponsor failed to remit to the Plan's Custodian certain participant contributions totaling \$12,606 within the period prescribed by DOL Rules and Regulations. Delays in remitting contributions to the Custodian were due to circumstances outside of the Company's control. The Plan is in the process of correcting these contributions under the Voluntary Fiduciary Correction Program and compensating affected participants for potential lost earnings due to the delays.
